Re: Mohegan Sun Information Request

Dear Dr. Price:

I am writing in to you on behalf of the Mohegan Tribal Gaming Authority ("MTGA") in response to your request for certain documents concerning an accident that occurred March 12, 2011 on I-95 in New York City.

As you may know, the MTGA is a governmental instrumentality of The Mohegan Tribe of Indians of Connecticut, a federally-recognized sovereign Indian tribe. See 25 U.S.C. § 1775. As such, the MTGA enjoys a government-to-government relationship with the federal government and its agents. 25 U.S.C. § 3601. Acting pursuant to that government-to-government relationship, the MTGA has cooperated with law enforcement and NTSB investigators and will continue to do so.

We have reviewed a document in the form of a subpoena seeking production of certain documents from Mohegan Sun regarding World Wide Tours of Brooklyn, New York and Sunflower Express of New York, New York.

The MTGA is voluntarily providing the documents requested by your office. Please note that, in providing these documents, the MTGA and the Mohegan Tribe do not waive, and specifically affirm, their sovereign immunity from unconsented suit and from compulsory process. The information provided by the MTGA would not be publicly available, and would not be available to private litigants except through the processes established in the exercise of the sovereignty of the Mohegan Tribe and pursuant to Mohegan law. Therefore, the MTGA requests that the documents be maintained in confidence and accorded the status of "trade secrets" pursuant to 49 U.S.C. § 1114(b)(1)

or otherwise protected from disclosure pursuant to §1114(b)(3). This is consistent with the statutory obligation of the federal government pursuant to 25 U.S.C. § 3601(2) to protect the sovereignty of tribal government.

Subject to the foregoing, the MTGA provides the following information:

1. Copy of any contractual agreements between Mohegan Sun and World Wide Tours of Brooklyn New York.

The only document that I have located of a contractual nature from the Mohegan Sun staff is a "blanket purchase order" (BPO) between Mohegan Sun and World Wide Tours, together with a standard form General Purchase order for Mohegan Sun. The attached BPO is redacted to eliminate reference to the financial terms.

2. Copy of any contractual agreements between Mohegan Sun and Sunflower Express.

I understand from speaking with the Mohegan Sun staff that Sunflower Express serves as a ticket agent for Mohegan Sun selling tickets for buses operated by World Wide Tours, but that the relationship has not been memorialized in written form.

3. Documentation of arrival and departure times of World Wide Tour buses based on the list submitted to Mohegan Sun Casino staff on March 18, 2011.

The Mohegan Sun staff reviewed the list of buses and compiled the attached documents for 26 buses showing arrival and departure times. Please note that the date information on each document reflects the "gaming day" established by Mohegan Sun, which resets at 6 a.m.


