Remote Control Locomotive (RCL) operations are permitted only between CP Morena, MP 260.5 and MP 267.7 from 1100PM until 530AM.

When operating on main track:

- RCL job must have a minimum of two crew members qualified on the San Diego Subdivision.
- RCL movements must not exceed 10MPH.
- Controlling RCL operator must protect the point of movement at all times.
- RCL jobs must monitor appropriate radio channel at all times.
- RCL jobs must clear or stop all movement when instructed by the train dispatcher.
