ARTICLE OF ORGANIZATION
OF
AAAffordable Transportation LLC

The undersigned, acting at the direction of and on behalf of two or more persons desiring to be members of and having agreed to form AAAffordable Transportation LLC as a limited liability company pursuant to the Maryland Limited Liability Company Act, do hereby acknowledge and certify:

1. The name of the Limited Liability Company (the "Company") is: AAAffordable Transportation LLC.

2. The latest date upon which the Company is to dissolve is: OCTOBER 31, 2060

3. The purposes for which the Company is formed are to engage in the business of to own, operate and lease school busses and passenger transportation vehicles to the public, and for any business agreed to by the members pursuant to the Operating Agreement of the Company.
