1	P-R-O-C-E-E-D-I-N-G-S
2	DAVE: OCC. This is Dave.
3	MR. MAHANY: Hey, Dave, it's Patrick up at
4	Life Guard 2, Frisco, Colorado.
5	DAVE: What can I do for you today?
6	MR. MAHANY: I can't log-in for some reason.
7	This is my first day back and it's saying "invalid log
8	in." My password is only about 30 days old.
9	DAVE: Mr. Mahany?
10	MR. MAHANY: Mahany, yeah, RMAH.
11	DAVE: All right. No lock on your account.
12	I'm scratching my head on that part.
13	MR. MAHANY: Let me try it one more time
14	here.
15	DAVE: How many times did you try by chance?
16	MR. MAHANY: I've tried it three times now.
17	P. M-A-H-A-N-Y. That's my name. I swear that's right.
18	DAVE: Can I put you on hold one sec?
19	MR. MAHANY: Yep.
20	DAVE: OCC. This is Dave.
21	MR. ROSS: Hey, Dave, this is Wyatt Ross
22	(phonetic) in Roamingham (phonetic). I have an admin.
23	issue if you've got a second.
24	DAVE: Hey, Ross. Can I put you on hold for
25	one minute?

1	MR. ROSS: Yeah.
2	DAVE: Thanks.
3	All right. Sorry about that.
4	MR. MAHANY: Let's try it one more time. I
5	was super careful. It tries to and then says I
6	mean, it tries. The little circle of lights hits for
7	about five seconds like it's going to work and then it
8	says "invalid log-in attempt."
9	DAVE: All right. So I'll get you logged in
10	right now and we'll get you released. Then let it sit
11	for about 30, 40 minutes and then try again. Sometimes
12	if you get locked out or something like that just don't
13	sweat that part. What time are you starting duty day
14	today?
15	MR. MAHANY: 0735.
16	DAVE: 0735. Your currently MBG (phonetic)?
17	MR. MAHANY: Yep.
18	DAVE: You got a contact number for us?
19	MR. MAHANY:
20	DAVE: And what do you want to call the
21	weather for today?
22	MR. MAHANY: Green. Low risk, whatever.
23	We're blue weather because we're mountains.
24	DAVE: Yep. So VFR on the current forecast?
25	MR. MAHANY: Yep.

1	DAVE: Total fuel 390?
2	MR. MAHANY: 1+45.
3	DAVE: And any restrictions or MELs on that
4	aircraft?
5	MR. MAHANY: No. Well, I can't tell because
6	I can't get to the 411.
7	DAVE: You might have to take the logbook
8	with you. Somebody can always update it for you. MEG
9	system operational if you know?
10	MR. MAHANY: Yep.
11	DAVE: All right. So short-term we're
12	looking at three days left on flight data recording
13	equipment, 24-day card exchange. Our items 10 hours, 52
14	minutes on a 15-hour seven-day inspection. Both these
15	is minus any flight time that may not have made the
16	system but looking good for today.
17	MR. MAHANY: What is the flight release
18	number again?
19	DAVE: One second and I'll punch it up for
20	you.
21	MR. MAHANY: Okay.
22	DAVE: Let me know when you're ready.
23	MR. MAHANY: Yep.
24	DAVE: 1507419.
25	MR. MAHANY: All righty.

1	DAVE: All right, sir.
2	MR. MAHANY: All right. So I'm good to go.
3	Right?
4	DAVE: Yes, sir. Just remember give it
5	about 30, 40 minutes if you've got time. If it doesn't
6	work then, get hold of the service desk and see if they
7	can help you out because it might just be beyond either
8	of us to get it working.
9	MR. MAHANY: I hear you.
10	DAVE: All right.
11	MR. MAHANY: Thanks, man.
12	DAVE: All right. Take care.
13	MR. MAHANY: Bye.
14	DAVE: Bye.
15	(Whereupon, the above-entitled matter went
16	off the record and resumed.)_
17	DAVE: OCC. This is Dave.
18	MAJ. MARTINEZ: Hi, David. This is Major
19	Martinez calling from the Air Force Rescue Coordination
20	Center.
21	DAVE: What can I do for you today?
22	MAJ. MARTINEZ: We've got an ELT going off
23	on the aircraft T-ALL (phonetic). Tail number is
24	N390LG. I wonder if you can help us with getting that
25	located.

1	DAVE: Absolutely. Let me reach out to
2	it looks like they are
3	MAJ. MARTINEZ: It's plotting right to a
4	hospital.
5	DAVE: In Frisco, Colorado?
6	MAJ. MARTINEZ: Yeah.
7	DAVE: Yep. They are sitting on a pad. It
8	looks like they are motoring it right now. Let me
9	reach out to them and see if I can get that for you.
10	MAJ. MARTINEZ: Okay.
11	DAVE: You said you're Major Martinez?
12	MAJ. MARTINEZ: Yep. The number here is
13	
14	DAVE: Okay. All right. Let me get on that
15	real quick and I'll get back to you here shortly.
16	MAJ. MARTINEZ: Thanks so much.
17	DAVE: No problem. Bye.
18	MAJ. MARTINEZ: Bye.
19	(Whereupon, the above-entitled matter went
20	off the record and resumed.)
21	KATIE: Flight for life. This is Katie
22	(phonetic).
23	DAVE: Katie, it's Dave with Air Methods,
24	occ.
25	KATIE: Hi.

1	DAVE: Can you do we a favor?
2	KATIE: Yeah.
3	DAVE: Can you get me in touch with the
4	Frisco pilot real quick?
5	KATIE: Actually, the Frisco pilot just took
6	off from the helipad. Apparently there's a situation
7	behind the helipad. In the camera it looks like a fire
8	but I can't tell for sure and he is airborne and I'll
9	try to connect with him and see where he's headed. Is
10	that what you were calling about?
11	DAVE: No. I got a call from Air Force
12	Search and Rescue that their ELT is activated.
13	KATIE: Oh.
14	DAVE: If you have them on air to ground can
15	you just get hold of them real quick and just have them
16	confirm that their ELT is silenced?
17	KATIE: You bet. Hold on one second.
18	DAVE: Absolutely. Thanks.
19	KATIE: Dave?
20	DAVE: Yes.
21	KATIE: I believe the helicopter has
22	crashed. I just got a call from someone at dispatch.
23	We're going to activate the PAIP. I did not know they
24	were listing.
25	DAVE: Okay. What's going on now?

1	KATIE: I got the call from Summit Con
2	Center. They said the helicopter is down behind the
3	helipad. There are injuries. They are sending EMS.
4	DAVE: Okay.
5	KATIE: We're going to activate the PAIP.
6	DAVE: All right. Just keep me appraised.
7	KATIE: I will. Thank you.
8	DAVE: Thank you. Bye.
9	(Whereupon, the above-entitled matter went
10	off the record and resumed.)
11	KATIE: Flight for Life. This is Katie.
12	DAVE: Katie, it's Dave from OCC.
13	KATIE: Yep.
14	DAVE: All right. Just following up with
15	you. Where do we stand right now?
16	KATIE: What we know so far is that Life
17	Guard 2 per Summit EMS has crashed behind the hangar.
18	They have found the pilot. He has burns. The medic is
19	out and they are looking for the nurse. I don't know
20	where they were going or why they were lifting. I've
21	paged we've contacted the Com Center manager. He's
22	on his way in.
23	We've paged Kathy Mayer (phonetic). We've
24	paged Teresa Elder (phonetic). We have also paged or
25	tried to contact by cell Rod Ballock (phonetic). We've

1	got a helicopter in-bound to that location. Medevac
2	has been dispatched to that location for any
3	transports. That's where we are so far. I'm going to
4	contact Ed Stemby (phonetic) next. He's our safety
5	officer.
6	DAVE: Sure.
7	KATIE: The mechanic is also aware.
8	DAVE: Okay. And, real quick, we don't have
9	a soul-on-board count, do we?
10	KATIE: We do not because they did not
11	advise that they were getting ready to lift. I just
12	looked up and saw fire behind the helipad and then you
13	called.
14	DAVE: Okay. So what we're looking for
15	right now is did they have a flight that they were
16	going out on that you know of?
17	KATIE: No. I'm the one on this side of
18	I'm dispatching or working with North State and there
19	was no request for a helicopter.
20	DAVE: So there is no request for service so
21	we had them going out on an unknown issue doing
22	something. We don't know the count. The pilot has
23	burns. Can you specify that for me? I know it might
24	be stupid.
25	KATIE: That's okay. He called into Com

1	Center to say he was out, that the pilot was out with
2	burns and they were looking for the nurse.
3	DAVE: Okay. The medic for right now is in
4	okay shape and no serious
5	KATIE: From what we know, yeah. Can you
6	hold on one sec?
7	DAVE: Absolutely. Whatever you need to do.
8	KATIE: Thanks.
9	Okay. That's all I have so far, Dave.
10	DAVE: That's all you have so far? Okay.
11	Whenever you get any more details about anything.
12	Specifically on location, it's just behind the hangar?
13	KATIE: Just behind the hangar, yes. We can
14	see it on the camera on the helipad picture.
15	DAVE: Just the unimproved area that's just
16	behind there like the gravel pit?
17	KATIE: Yes.
18	DAVE: Okay.
19	KATIE: Can we go ahead and silence that
20	alarm?
21	DAVE: Are you getting an alarm for them?
22	KATIE: Yeah, I do have an alarm going off.
23	DAVE: Is it Flight Vector (phonetic)?
24	KATIE: Yep. It's actually the DMS tracker
25	that I have.

1	DAVE: Really? You're getting an alarm for
2	them?
3	KATIE: I am, yep.
4	DAVE: Why am I not getting an alarm?
5	That's not good. I am not getting an alarm on that
6	aircraft. Sorry.
7	KATIE: I'm going to go ahead and confirm
8	it.
9	DAVE: Sure. Absolutely. Whatever you need
10	to do to get rid of it. Go ahead and get rid of it,
11	whatever you need to do.
12	KATIE: Okay.
13	DAVE: Like I said, Kate, whenever you get
14	any more information, just let me know. Okay?
15	KATIE: Okay. Will do.
16	DAVE: Thank you. Appreciate it.
17	KATIE: Thanks. Bye.
18	DAVE: Bye.
19	(Whereupon, the above-entitled matter went
20	off the record and resumed.)
21	FEMALE: Air Force Rescue. You're being
22	recorded live. How can I help you?
23	DAVE: Hi, this is Dave with Air Methods,
24	OCC. Can I talk to Major Martinez, please?
25	FEMALE: Yes, one moment.

1	DAVE: Thank you.
2	MAJ. MARTINEZ: This is Major Martinez.
3	DAVE: Hi, Major Martinez. This Dave with
4	Air Methods, OCC. Real quick, I did check on the
5	status of that aircraft. I contacted one of our
6	communication centers that's responsible for doing the
7	flight following on that aircraft to have them verify
8	the ELT was found. They did inform me after that that
9	the aircraft did, in fact, crash. We are working with
10	them right now in coordinating a response for that but
11	we do have an accident in the vicinity of Summit.
12	Stand by and I'll give you the name of the hospital.
13	MAJ. MARTINEZ: St. Anthony's Summit Medical
14	Center?
15	DAVE: That is the one.
16	MAJ. MARTINEZ: Okay. Do you need anything
17	from us? Do you need assistance or is it under
18	control?
19	DAVE: They should have local response
20	coming out. It's in the vicinity of the hospital. If
21	I do find that we need something, I will definitely get
22	in touch with you as soon as possible.
23	MAJ. MARTINEZ: Okay. All right. Thanks so
24	much. Appreciate it.
25	DAVE: Thank you for the call. Appreciate
