2	00:10	7/26/2010	11:55 AM	The Enbridge Regional Manager initiates a call to the Enbridge Vice President of Operations. An Enbridge Incident Command Structure is put into motion.
3	00:15	7/26/2010	12:00 PM	The Enbridge Regional Manager initiates the Emergency Response Protocol.
4	00:45 to 01:15	7/26/2010	12:30 PM to 1:00 PM	First deployment of booms into the water by the Enbridge Personnel.
5	01:44	7/26/2010	1:29 PM	Enbridge contacts The National Response Center (1:08 PM) and generates NRC # 948903. Enbridge caller is placed on hold for approx. 20 minutes. Reports a release of 19,500 bbs of Oil. This initial estimate is based on volume stored in 34" dia pipe (@ ~3 miles) and est. 1,800 bbl mass balance difference. The actual pipe diameter is 30".

7	02:05	7/26/2010	1:50 PM	Enbridge receives a call from The Pipeline Hazardous Materials Safety Administration.

9	02:34	7/26/2010	2:19 PM	Internal Enbridge notification sent out via the leak reporting system.
