Narrative:

Stephanie Lattion is a Helicopter Instructor Pilot. Christopher Perkins is Lattion's student pilot. On 01/11/2002 at about 1133 hrs, the two were in the helicopter practicing hovering over the Seattle Times Helicopter practice property in the 700 block of So 34th St. According to Lattion and Perkins, Perkins was in primary control of the aircraft. As they were hovering an estimated 3 or 4 feet off the ground, the front of the aircraft pitched up slightly, and the rear portion of the landing skids touched down onto the ground. The aircraft began to spin and then tipped over onto its left side on the ground. Lattion and Perkins were able to exit the aircraft without further incident. Lattion complained of soreness to her left arm, Perkins of soreness to his back. Both were treated by Renton Fire Department members at the scene then transported to Valley Medical Center for further observation. The aircraft involved was identified as a Beta II, tail number N7185A.
