ON MONDAY APRIL 7, 2014 AT APPROXIMATELY 1352 HOURS, WRITER MADE CONTACT WITH LIEUTENANT DIXON, ID IN REFERENCE TO A POSSIBLE MISSING PERSON AND AIRCRAFT. LIEUTENANT DIXON WAS ADVISED BY THE DUNNELLON AIRPORT THAT AN AIRCRAFT HAD LEFT ON SATURDAY. APRIL 5. AND HAD NOT ARRIVED AT ITS DESTINATION OF ZEPHYRHILLS.

UPON ARRIVAL, WRITER MET WITH REPORTEE JOHN HELMS, WHO IS THE MANAGER OF THE AIRPORT. THE REPORTEE STATED THAT ON SATURDAY, APRIL 5, 2014 AT APPROXIMATELY 1400 HOURS, THE PILOT, THEODORE WEISS, HAD DEPARTED THE AIRPORT EN ROUTE TO ZEPHYRHILLS, FLORIDA. THE REPORTEE WAS ADVISED THAT ON THE REPORTED DATE. THE PILOT AND AIRCRAFT HAD STILL NOT ARRIVED AT ITS SCHEDULED DESTINATION. THE REPORTEE ADVISED THAT HE WAS ADVISED BY THE ZEPHYRHILLS AIRPORT THAT THE SUBJECT'S VEHICLE WAS AT THE HANGER, HOWEVER, THE AIRCRAFT WAS NOT AT THE LOCATION. THE REPORTEE ADVISED THAT THE AIRCRAFT WAS A WHITE EXPERIMENTAL 2 SEAT LOW WING. THE REPORTEE ADVISED THAT THE AIRCRAFT HAD A GREEN STRIPE AND "N229P" ON THE TAIL. THE REPORTEE ADVISED THAT AIRCRAFT WAS LAST SEEN HEADED SOUTHBOUND FROM THE LOCATION. THE REPORTEE HAD NO FURTHER INFORMATION.

WRITER MET WITH MICHAEL JANUARY, WHO IS A FRIEND OF THE SUBJECT. JANUARY ADVISED THAT HE ALSO WITNESSED THE SUBJECT DEPART AT THE STATED TIME AND DATE. HE ADVISED THAT HE HAS NOT HEARD FROM THE SUBJECT SINCE THE INCIDENT. HE ADVISED THAT THE AIRCRAFT POSSIBLY HAD MALFUNCTIONS WITH THE CANOPY PRIOR TO DEPARTURE. HE HAD NO FURTHER INFORMATION.

WRITER CANVASSED THE HANGER THAT THE PILOT WAS UTILIZING WITH NO FURTHER INFORMATION. WRITER WAS ADVISED THAT THE F.A.A. AND THE U.S. AIR FORCE HAD ACTIVE SEARCH AND RESCUE TEAMS DEPLOYED. LIEUTENANT DIXON WAS ATTEMPTING TO HAVE THE SUBJECT'S PHONE PINGED. THE REPORTEE ADVISED THAT LIEUTENANT COLONEL EUBANKS OF THE U.S. AIR FORCE HAD PINGED THE SUBJECT'S PHONE. THE PING WAS SHOWN ON APRIL 7, 2014 AT APPROXIMATELY 1030 HOURS IN THE AREA OF THE DUNNELLON AIRPORT. THIS INFORMATION WAS UNABLE TO BE VERIFIED AT THIS TIME.

WRITER MADE CONTACT WITH JOAN BACKER, WHO IS A CLOSE FRIEND TO THE SUBJECT. SHE ADVISED THAT SHE HAS NOT HEARD FROM THE SUBJECT. SHE ADVISED THAT SHE WOULD ATTEMPT TO NOTIFY THE SUBJECT'S SON, BRIAN WEISS, WRITER WILL ALSO ATTEMPT TO SEND A NOTIFICATION TO BRIAN VIA TELETYPE TO THE NEW YORK LAW ENFORCEMENT JURISDICTION. CONTACT WAS ALSO MADE WITH THE PASCO COUNTY SHERIFF'S OFFICE, WHO WOULD RESPONDED TO THE SUBJECT'S RESIDENCE.

**FOLLOW UP** 

ON 040714 AT APPROXIMATELY 1200 HOURS, WRITER WAS CONTACTED BY THE MARION COUNTY PUBLIC SAFETY DISPATCH THAT THE DUNNELLON AIRPORT MANAGER, JOHN HELMS, WAS REQUESTING AIR ASSISTANCE. WRITER CONTACTED MR HELMS WHO GAVE A BRIEF DESCRIPTION OF A POSSIBLE MISSING AIRCRAFT. FURTHER CHECKS REVEALED THAT THIS AIRCRAFT DID DEPART THE DUNNELLON AIRPORT ON SATURDAY, 040514 AT APPROXIMATELY 1400 HOURS. MR HELMS ADVISED HE PERSONALLY WITNESSED THE PLANE DEPART AND TURN IN A SOUTHERLY DIRECTION SHORTLY AFTER CLEARING THE AIRPORT PROPERTY. WRITER ALSO LEARNED THAT THE MISSING AIRCRAFT AND PILOT, MR TED WEISS, HAD NOT MADE IT TO ZEPHYRHILLS AT THE TIME OF THE CONTACT WITH MR HELMS.

WRITER ALSO LEARNED THAT THE U.S. AIR FORCE SEARCH AND RESCUE SQUAD FROM PANAMA CITY, HAD BEEN ACTIVATED ON THIS CASE.

WRITER MADE CONTACT WITH LIEUTENANT COLONEL JULIE EUBANKS OF THE U.S. AIR FORCE WHO ADVISED THE FOLLOWING.

THEY CONDUCTED A "PING" OF MR WEISS' CELL PHONE AND IT APPEARED TO BE OFF AT THE TIME AND THE LAST SUCCESSFUL CONTACT WITH THAT PHONE WAS ON 040514 AT 1030 HOURS. WRITER ALSO RECEIVED PERMISSION FROM ASSISTANT STATE ATTORNEY AMY BERNDT WHO GAVE PERMISSION FOR US TO ATTEMPT A PHONE "PING" AS WELL. THAT "PING" WAS UNSUCCESSFUL. THE CIVIL AIR PATROL HAD BEEN ACTIVATED BY COLONEL EUBANKS AND A SEARCH BETWEEN THE DUNNELLON AIRPORT AND THE ZEPHYRHILLS AIRPORT WAS IN PROGRESS. WRITER ALSO DISPATCHED SERGEANT STANDRIDGE IN THE MARION COUNTY SHERIFF'S OFFICE HELICOPTER TO SEARCH THE SURROUNDING AREA OF THE DUNNELLON AIRPORT.

THE PASCO COUNTY SHERIFF'S OFFICE WAS CONTACTED BY THE COMMUNICATIONS CENTER VIA TELETYPE TO RESPOND TO THE MISSING SUBJECT'S RESIDENCE. WRITER SPOKE WITH CORPORAL COMIS OF THE PASCO COUNTY SHERIFF'S OFFICE. HE ADVISED THEY CHECKED THE SUBJECT'S RESIDENCE AND THERE WAS NO CONTACT MADE. THEY ALSO LEARNED THAT THE SUBJECT HAD A SECOND RESIDENCE IN THE CITY OF ZEPHYRHILLS IN WHICH THEY RESPONDED TO AS WELL. THE MISSING SUBJECT'S PERSONAL PICKUP TRUCK WAS LOCATED AT THE SECOND RESIDENCE, HOWEVER THERE WAS NOBODY AT THE PROPERTY. IT SHOULD BE NOTED THAT THE SUBJECT'S TRUCK STAYS AT THAT PROPERTY FULL TIME AND THAT WHILE HE IS IN THE ZEPHYRHILLS AREA, HE DRIVES A RENTAL CAR. This report is in reference to crime scene processing located around the Dunnellon, which was performed by Rachel Peavy # on Monday, October 20, 2014 from 1027 hours to 1415 hours.

At 0930 hours I was contacted by Lieutenant D. Winston # and requested to respond to the above listed address in reference to an aircraft crash resulting in one fatality.

Crime scene processing was requested by Lieutenant D. Winston #

### SCENE:

Upon arriving on scene, contact was made with Lieutenant D. Winston who briefed me on the case details. Lieutenant Winston advised that two individuals located a wrecked aircraft in a heavily wooded area. Lieutenant Winston stated that the aircraft was supposed to arrive in Zephyrhills, Florida on April 5, 2014 but had not arrived. The aircraft was located in a remote part of the Halpata Tastanaki Trailhead, which is a part of the Florida Greenway. Lieutenant Winston further advised that the Federal Aviation Administration would be responding to the incident location and would assume the investigation.

I observed a large debris field in the areas surrounding the aircraft. I observed the aircraft to be white with green stripes with identification on the tail that read N229P, in an area partially surrounded by thick brush. The extensive damage of the aircraft made it difficult to determine the directionality of the aircraft, but it appeared to be upside down and facing west. I observed the decedent beneath the aircraft and several suspected bones to the south of the aircraft.

### SCENE PROCESSING AND RESULTS:

Overall color digital images were captured of the decedents and the scene.

At 1224 hours I contacted the MCPS Communications Center to obtain GPS coordinates of the aircraft crash site and they are as follows: 29.03098522 - 82.38782529.

Upon removal of the decedent from the wreckage, I collected a wallet which contained several credit cards, Florida ID card, Pilot's license, \$27.00 in cash and other miscellaneous items.

AFTER SPEAKING WITH COREY, I MADE CONTACT WITH MEDICAL EXAMINER INVESTIGATOR TODD BRANSON AND GAVE HIM DIRECTIONS TO OUR LOCATION.
