THE MALE'S BODY WAS ON THE MARINA'S DECK WALK AND HAD BEEN COVERED WITH A YELLOW BLANKET TO CONCEAL HIM FROM ONLOOKERS. INFORMATION HAD BEEN PROVIDED THAT AN EMERGENCY CONTACT AND PHONE NUMBER WERE FOUND IN HIS WALLET AND DEPUTIES WERE ABLE TO CONTACT THE DECEDENT'S SISTER, EDITH STONE BINDER

BINDER TOLD DEPUTIES THAT SHE HAD LAST SPOKEN WITH HER BROTHER THE PREVIOUS DAY AROUND NOON. LOWERRE HAD LEFT HIS HOME IN MARGATE FLORIDA, AND DRIVEN TO THE BOCA RATON EXECUTIVE AIRPORT WHERE HE KEPT HIS SMALL PLANE. HAD NOT HEARD FROM HIM SINCE THAT TIME.

CRIME SCENE INVESTIGATOR PATRICK AND I WERE TAKEN TO THE PLANE'S LOCATION BY PALM BEACH SHERIFF'S OFFICE MARINE UNITS. CRIME SCENE INVESTIGATOR PATRICK DOCUMENTED THE SCENE BY PHOTOGRAPH AND THE PLANE APPEARED TO BE RESTING IN FAIRLY SHALLOW WATER AND NOT DRIFTING. WE THEN WENT BACK TO THE MARINA WHERE I CALLED THE MEDICAL EXAMINER'S OFFICE TO NOTIFY THEM OF THE CRASH. I SPOKE WITH FORENSIC INVESTIGATOR LITTLEFIELD AND PROVIDED HER WITH THE PERTINENT INFORMATION. SHE ADVISED THAT SHE WOULD HAVE ELITE REMOVAL RESPOND TO OUR LOCATION. SHORTLY AFTERWARDS, A REPRESENTATIVE FROM AIR & SEA RECOVERY, STEVE SMALLY, AND TIMOTHY MONVILLE WITH NTSB ARRIVED AT THE MARINA. AT 1330 ELITE REMOVAL ARRIVED AND WE DID AN INSPECTION OF THE BODY. LOWERRE HAD ON A PLAID BUTTON UP SHIRT, BLACK SLACKS, BLACK SOCKS AND BLACK SHOES. THERE WAS AN ABRASION/INJURY ON THE BACK OF HIS HEAD, AND A SMALL LACERATION WAS SEEN ON THE RIGHT SIDE OF HIS HEAD AND WAS APPROXIMATELY 3 INCHES LONG. LIVIDITY WAS VIEWED IN HIS FACIAL AREA. NO OTHER TRAUMA WAS NOTED ON THE BODY AT THAT TIME. AT APPROXIMATELY 1400 HOURS, JAUNITA CORBIN AND JEANNIE COOK, WITH THE FAA ARRIVED. I CALLED AND SPOKE WITH BINDER AND SHE INFORMED ME THAT HER BROTHER HAD A SECOND, LARGER CESSNA AIRPLANE WHICH HE KEPT IN POMPANO BEACH AND SHE WAS CERTAIN HE HAD INSURANCE POLICIES ON BOTH AIRCRAFT. SHE TOLD ME THAT SHE WOULD SEARCH HIS HOME FOR THAT INFORMATION. SHE FURTHER TOLD ME THAT HER BROTHER WAS SUPPOSED TO MEET HER THE PREVIOUS AFTERNOON AT 1700 HOURS FOR DINNER AT DENNY'S IN EAST BOCA RATON. WHEN LOWERRE DID NOT ARRIVE, BINDER CALLED HIS CELL PHONE, WHICH SHE TOLD ME WENT RIGHT TO HIS VOICE MAIL. AS SHE WAS CONCERNED, BINDER DROVE TO THE BOCA RATON AIRPORT TO CHECK IF HIS VEHICLE/OR THE PLANE WAS THERE. ONCE SHE GAINED ACCESS, SHE WAS UNABLE TO ENTER THE HANGER, AND LOWERRE'S 2007 BLUE CHEVROLET "HHR" WAS NOT PARKED IN THE PARKING AREA. AS SHE HAD NOT BEEN CONTACTED BY LOWERRE, SHE STARTED TO GET CONCERNED AS SHE DID NOT KNOW OF HIS LOCATION. ACCORDING TO BINDER, LOWERRE HAD BEEN BUILDING THE AIRPLANE FOR 33 YEARS, AND WAS STILL WORKING ON HIS FORTY HOURS OF TRAINING HE NEEDED PRIOR TO BEING ABLE TO TAKE A PASSENGER UP IN THE PLANE. BINDER VERIFIED THAT HE ALWAYS FLEW THE SMALL PLANE ALONE AND
