On this date at approximately 3:30 p.m., airport operations was advised by the FAA tower that a Plaggio tall number 590JL landed on its belly on runaway 35 right just south of taxiway lime. Deputy Barbetto, Airport Operations, Airport Fire Rescue and I responded to the aircraft.

Upon arriving at the aircraft, the pilot, Jaffrey Ballay, and his co-pilot, were out of the plane. Jeffrey and John Tucker the co-pilot stated they were not injured. The plane appeared to have minor damage, but it skidded approximately 300 feet on the runway. interviewing pilot Bailey, he stated as he was taking off he heard a pop sound which he thought was a flat tire. He then put the plane back on the ground, and he thought the gear collapsed leaving the plane on its belly.
