

Where's the fire?" - answered that he passed him so fast "he created turbulence." I can't say for sure how far over he was but there was a lot of room between his bus and my truck when he passed. I then started to approach the scene and I switched lanes into the middle lane. As I came to scene the I noticed the brake lights looked weird because they were straight up in the air. I was able to read "World Wide" on the back of the bus though and believe it was the bus that had passed me earlier. It was laying on its side and I saw a person with short hair standing in the grass. As we proceeded by the scene I called 911. I told 911 that a full size tour bus was laying on its side by exit 14. I told them to bring more than one ambulance. By the time I got off the phone I saw other emergency vehicles heading Northbound towards the scene.
