3	MR. MULARCHYK: Good afternoon.
4	MR. EMEABA: My name is Kalu Kelly Emeaba,
5	spelled out K-A-L-U, K-E-L-L-Y, E-M-E-A-B-A. I am an
6	NTSB investigator. And the reason we are here in this
7	interview today is with respect to the accident that
8	occurred on July 6, at a crossing at 25th Street in
9	Palm Beach, Florida at the roadway crossing.
10	And with me here is Mr. Josh. Mr. Josh, can
11	you please give me your full name with
12	MR. MULARCHYK: Joshua Michael Mularchyk.
13	MR. EMEABA: the spelling and also your
14	employer name and the title of, your job title.
15	MR. MULARCHYK: Say that one more time.
16	MR. EMEABA: Please can you give me, spell
17	your full name. Tell me your employer name, and your
18	job title.
19	MR. MULARCHYK: My name's Joshua Michael
20	Mularchyk, J-O-S-H-U-A, M-I-C-H-A-E-L, M-U-L-A-R-C-H-Y-

23	please tell me a little bit about your work. How long
24	have you been on the job and your years of experience
25	and the education you have.

4	your experience on the job.
5	MR. MULARCHYK: What my trailer experience
6	or with this job?

9	experience. As well education, 14 years education, two
10	years college.
11	MR. EMEABA: Okay, and on your current
12	position, what is your current job title, please?
13	MR. MULARCHYK: Right now I'm a signal
14	maintainer on South Florida rail corridor.
15	MR. EMEABA: Okay. As a signal maintainer,
16	what do you do?
17	MR. MULARCHYK: With all the testing, well I
18	just, I worked signal for them, the job, signal
19	maintainer, test and maintain the signal systems for
20	the South Regional Transportation Authority.
21	MR. EMEABA: Okay. How long have you been
22	doing that?
23	MR. MULARCHYK: Signal man? I just went on
24	the signal maintainers job the day before the accident.
25	I worked signal foreman at, I did that through signal

3	year, or it's one month, two weeks, what?
4	MR. MULARCHYK: Oh that part signal now, one
5	day before the accident.
6	MR. EMEABA: No, no, no. I said, how long
7	have you been on the job? Is it for this one as a
8	signal maintainers, is it one year, or one month, or
9	one week. What
10	MR. MULARCHYK: The one what, the four of
11	us, as of right now, or before the accident?
12	MR. EMEABA: No just, before the accident.
13	I'm sorry.
14	MR. MULARCHYK: One day.
15	MR. EMEABA: One day?
16	MR. MULARCHYK: Yes.
17	MR. EMEABA: Okay, so that was your first
18	day before the accident?
19	MR. MULARCHYK: Yes, actually it was my
20	second day on that position.
21	MR. EMEABA: Okay, in that area. Okay,
22	thank you so much. And leading to what happened on the
23	railroad crossing, can you please accident on the 25th
24	Street, can you tell me is your work, how you started
25	on the serving on the 6th of July, leading to your

2	MR. MULARCHYK: I just heard there was a
3	vehicle accident on 25th Street, when a train struck
4	the vehicle and I was instructed by my supervisor, just
5	go up there and see if they need any assistance. When
6	I got there, I was just sitting at, I was just sitting
7	at the cross. I was there for two or three hours
8	before, and they blamed this mayhem was
9	(unintelligible).
10	MR. EMEABA: Okay, which supervisor, please?
11	MR. MULARCHYK: (unintelligible) Khan.
12	MR. EMEABA: Can you spell his name, any
13	way?
14	MR. MULARCHYK: No, I can spell his last
15	name. It's K-H-A-N. But I can't spell the first name.
16	MR. EMEABA: Okay. Okay. So, can you
17	please, sir, just lead me through when you got the call
18	from your supervisor and you were told a train hit a
19	vehicle and
20	MR. MULARCHYK: All right. It was, on
21	approximately 10, approximately 10:15, 10:30 maybe.
22	MR. EMEABA: Okay. About 10:30. Okay, from
23	there what happened. Just lead me through what you did
24	from there.
25	MR. MULARCHYK: I actually, well, drove up

6 1 to 26th Street and when I got there, I just sit there 2 and my (unintelligible) calls some until Mr. Marquette, Tom Marquette, signal, senior signal supervisor, job 3 brings with me what was happening. And they was, and 4 5 told me that there was, we were going to have to do 6 additional testing on the crossing eventually. That 7 was pretty much it. 8 MR. EMEABA: Can you repeat that? Now you have to do what? 9 10 MR. MULARCHYK: Mr. Marguette was at the 11 scene prior to me getting there. And once I was there, 12 I was there probably some over an hour. I was there 13 before Mr. Marquette. He had just told me what was 14 going on this accident. And that we were going, there 15 was an accident and we're going to have to probably do 16 some testing on the call signal eventually. That was 17 it. So to perform testing? 18 MR. EMEABA: 19 MR. MULARCHYK: Yes, that was it. 20 MR. EMEABA: What kind of testing did you, 21 have to perform, please? 22 MR. MULARCHYK: Well, we didn't perform any 23 testing that afternoon. But we were there assisting with FRA, waiting for the FRA to show up, but I didn't 24 25 do anything except we sealed the house up.

8	MR. EMEABA: Okay. Do you of a technical
9	that was already working at the signal house before the
10	accident?
11	MR. MULARCHYK: Yes, I had no idea.
12	MR. EMEABA: Okay.
13	MR. MULARCHYK: I had no idea what was going
14	on. All I knew was that a vehicle got struck by an
15	Amtrak. That was it.
16	MR. EMEABA: Okay, so from what you just
17	said to me, you were called by a supervisor to go and
18	give an assistance
19	MR. MULARCHYK: Yes.
20	MR. EMEABA: at this railway crossing.
21	MR. MULARCHYK: Yes.
22	MR. EMEABA: Because an Amtrak struck a
23	vehicle.
24	MR. MULARCHYK: Yes.
25	MR. EMEABA: Is that correct?

3	kind of assistance were you instructed to go and give?
4	MR. MULARCHYK: Well, since we didn't know
5	if there was damage to the call signal equipment or
6	not. So they did had a dispatch, or (unintelligible)
7	labor or anything. You know, we really didn't think
8	there was knocked down or tore up. So I was just there
9	to go up there and assist, to see what was, what was
10	wrong. And you know, to figure out what we needed to
11	do if something was, something tore up.
12	MR. EMEABA: Okay.
13	MR. MULARCHYK: That was it.
14	MR. EMEABA: So what
15	MR. MULARCHYK: You know, that was, that was
16	all and then I went back to work.
17	MR. EMEABA: Okay. If you can lead me
18	through, so when you got there, what did you see and
19	what did you do in terms of communicating back to your
20	supervisor or to somebody. What else do you have to
21	do?
22	MR. MULARCHYK: Yes, I didn't do anything.
23	When I got there, Amtrak was still sitting at the
24	crossing. All the, all the gates were down. The
25	lights were flashing. And I didn't do anything until

1	Mr. Marquette came up and told me that, you know, FRA
2	was on the way and we were going to have to do some
3	testing on the crossing later that afternoon. And we
4	were going to have to seal the house up. And that was
5	it.
6	MR. EMEABA: Okay. So, when was the house
7	actually closed, or sealed up?
8	MR. MULARCHYK: Yes, around, around 3:00,
9	3:30 maybe.
10	MR. EMEABA: Okay. And by the time, were
11	you involved in the closing or sealing of the house?
12	MR. MULARCHYK: Yes, I sealed up the, part
13	going in the backdoor.
14	MR. EMEABA: Okay, and you never, did you
15	enter the house at all, the signal house?
16	MR. MULARCHYK: No, I didn't.
17	MR. EMEABA: Okay, so you didn't observe
18	anything inside the signal house?
19	MR. MULARCHYK: No, sir.
20	MR. EMEABA: Okay. Did you, what about Mr.
21	Bickford? Did he enter the signal house for any
22	activity?
23	MR. MULARCHYK: Well he, not to my
24	knowledge. Not while I was there he didn't.
25	MR. EMEABA: Okay. All right.

2	house when I was there.
3	MR. EMEABA: Okay. Did you, can you tell me
4	any conversation you had with the technician working on
5	
6	MR. MULARCHYK: I didn't have, I didn't have
7	any. Jim, I didn't have, only, I didn't have any
8	communication with him. At one point, I asked him, you
9	know, if he was thirsty. And he, I guess was sitting
10	in a vehicle talking to a manager. And when he got in
11	the vehicle, you know, I had some cold water. I asked
12	him if he wanted a couple bottles of water. That was
13	it.
14	MR. EMEABA: Who did you ask that, please?
15	MR. MULARCHYK: The technician.
16	MR. EMEABA: Okay, the technician that was
17	there when the accident happened?
18	MR. MULARCHYK: Yes, I just asked him if he
19	wanted a bottle of water.
20	MR. EMEABA: Okay.
21	MR. MULARCHYK: When he was standing outside
22	the truck with Mr. Marquette. That was it.
23	MR. EMEABA: Okay, and what did he say?
24	MR. MULARCHYK: Yes, please.
25	MR. EMEABA: No, I mean. When you offered

1	him a bottle of water, what did he say? What did he
2	do?
3	MR. MULARCHYK: Nothing. He just said, yes.
4	I went and got him a couple bottles of water. That was
5	it.
6	MR. EMEABA: So at least he, so he accepted
7	the water from you? That addressed my question.
8	MR. MULARCHYK: That was, that was all that
9	was said.
10	MR. EMEABA: Okay.
11	MR. MULARCHYK: I didn't say anything else
12	to him. I haven't talked to him since.
13	MR. EMEABA: Okay. All right, I really
14	thank you for the time I've taken from you on your
15	travel and being interviewed at the same time.
16	MR. MULARCHYK: Okay but
17	MR. EMEABA: And as I said, the number to
18	this accident is DCA16FR009. And
19	MR. MULARCHYK: Okay.
20	MR. EMEABA: if you have any other thing
21	you remember beside this, I would appreciate if you can
22	give me a call and then, and we can still communicate,
23	and as I said, none of this information is used for
24	legal purpose or finding, or penalty. It's just to
25	fact, facts finding to help us in this investigation.
