The National Transportation Safety Board (NTSB) is an independent federal agency charged by Congress with investigating every civil aviation accident in the United States and significant accidents in other modes of transportation—railroad, highway, marine, and pipeline. The NTSB determines the probable cause of the accidents and issues safety recommendations aimed at preventing future accidents. In addition, the NTSB carries out special studies concerning transportation safety and coordinates the resources of the federal government and other organizations to provide assistance to victims and their family members affected by major transportation disasters. We are providing the following information to urge Rand McNally to take action on the safety recommendation being issued in this letter.

On July 15, 2014, the NTSB adopted its report concerning the May 23, 2013, accident in which a span of the Interstate 5 bridge over the Skagit River near Mount Vernon in Washington State collapsed after being struck by an oversize combination vehicle.¹ Additional information about this accident and the resulting recommendations may be found in the report of the investigation, which can be accessed at our website, <u>http://www.ntsb.gov.</u> under report number HAR-14/01.
