3 MR. KAMINSKI: -- date's November 4th. My name is Ronald

4 Kaminski with the National Transportation Safety Board. I'm here

- 5 | with Sergeant Colanto (ph.). And we're going to be talking to
- 6 Elsie Lewis, L-e-w-i-s, who was a passenger on the MTA bus, and
- 7 | she's going to give us a description of what she recalls regarding
- 8 the crash.

- 9 INTERVIEW OF ELSIE LEWIS
- 10 BY MR. COLANTO:
- 11 Q. If you don't mind, start, can you tell us what your injuries
- 12 were, or are?
- 13 A. I have a, I have a fractured, fractured spine. I have
- 14 bruises on both of my legs, upper part of my legs. I had glass, I
- 15 | had glass in my, in my right ear, they had to take the glass out.
- 16 And I got a couple little scrapes. I got a little sore right
- 17 here. And I had a couple in my face.
- 18 Q. Glass cuts? Glass cuts, you think?
- 19 A. Yes. And I had glass bledded all in my coat. I had blood
- 20 all in my clothes.
- 21 Q. Do you remember where you were sitting on the bus?
- 22 A. Yes. I was sitting on right, right side.
- 23 Q. The passenger's side, away from the driver?
- MR. KAMINSKI: Or behind the driver?
- MS. LEWIS: I was on the other side of the driver. I

- 2 MR. KAMINSKI: Okay. Passenger side.
- 3 MS. LEWIS: I usually sits on the passenger side, but I sat
- 4 on the other side this time. And I was talking to the lady,
- 5 Michelle (ph.) that was on the bus. Me and her was talking. The
- 6 | lady that's (indiscernible) Michelle --
- 7 BY MR. COLANTO:
- 8 Q. Okay. So --
- 9 A. -- Michelle Kennedy.
- 10 Q. -- were you --
- 11 A. Me and her was sitting right across from each other. Right
- 12 next --
- 13 Q. In the, towards the back, the front?
- 14 A. No, the front. You know how, you go on the bus, and then the
- 15 | elderly people sit right here, and the first two seats right in
- 16 | the back of the elderly.
- 17 Q. Right behind where the elderly sit?
- 18 A. Yes.
- MR. KAMINSKI: Or where the -- they had the, the wheelchair
- 20 | tie downs and seatbelts underneath, and all that?
- MS. LEWIS: Well not right -- not them three seats there,
- 22 | right here, right in the first two, where the, usually if somebody
- 23 on, with a wheelchair come on, they'll sit right there.
- MR. KAMINSKI: Okay.
- MS. LEWIS: Yeah.

- 1 MR. KAMINSKI: So in that first, that, in that first row
- 2 | right there.
- 3 MS. LEWIS: Uh-huh.
- 4 MR. KAMINSKI: On the right side?
- 5 MS. LEWIS: Uh-huh. Right side. Yes.
- 6 BY MR. COLANTO:
- 7 Q. Where's the -- is that next to the --
- 8 MR. KAMINSKI: There's a, there's a, there's a row of seats
- 9 that are facing the windows.
- 10 MS. LEWIS: Um-hum.
- 11 MR. KAMINSKI: And then the first seat --
- 12 MS. LEWIS: First two --
- 13 MR. KAMINSKI: -- the first two on each side there --
- 14 MS. LEWIS: Um-hum.
- 15 MR. KAMINSKI: -- have the, a wheelchair tie down.
- 16 MR. COLANTO: Okay.
- 17 BY MR. COLANTO:
- 18 Q. And were you on -- towards the window or the aisle? Do you
- 19 remember?
- 20 A. Next to the window.
- 21 Q. You were right next to the window?
- 22 A. Um-hum.
- MR. KAMINSKI: And Michelle, you said, that's Michelle
- 24 Kennedy was across from you, on the other side?
- MS. LEWIS: No, Michelle was sitting -- I was sitting right

- 1 here by the window. Michelle was like right here. She was
- 2 sitting right there where the, the handicapped people set.
- 3 MR. KAMINSKI: Oh, in the, on the, in the other --
- 4 MS. LEWIS: On the same side.
- 5 MR. KAMINSKI: -- side-facing seats.
- 6 MS. LEWIS: The same side.
- 7 MR. KAMINSKI: Right, but in the side-facing seats?
- 8 MS. LEWIS: Yes. Yes.
- 9 MR. KAMINSKI: Okay. Okay.
- 10 BY MR. COLANTO:
- 11 Q. And then if you can just kind of walk us through where you
- 12 got on, and if there was anything leading up to that, what you
- 13 recall, just whatever you --
- 14 A. I got on right there on Pulaski and -- Frederick and Pulaski.
- 15 | That's where I always get on the bus at.
- 16 Q. Okay.
- 17 A. And I just know I was talking to her, and I don't remember
- 18 | nothing else after that. When I did remember, because I believe I
- 19 had, I fainted, I blacked out.
- 20 Q. Um-hum.
- 21 A. But I did blacked out. I was laying, I was facing this way,
- 22 on my left side. And I was laying on top of Michelle. And the
- 23 bus driver was laying on my shoulder.
- 24 Q. Okay.
- MR. KAMINSKI: So you were on, this is -- you were on the

- 1 floor?
- MS. LEWIS: Yes, on the floor. And my coat was ruined, blood
- 3 | everywhere, all in my coat, all in my pocketbook, all in my book
- 4 | bag that I carry, glass, all, glass was all in my hair. My hair
- 5 was in another way. I had to take my hair out and wash my hair.
- 6 Because glass was, pieces of glass was, was everywhere.
- 7 MR. KAMINSKI: Right. So you --
- 8 MS. LEWIS: All in my coat.
- 9 MR. KAMINSKI: So when you came to, you said you were on the
- 10 floor?
- 11 MS. LEWIS: Yes, I was on the floor. I was on top of
- 12 Michelle. This is the coat I had on.
- 13 BY MR. COLANTO:
- 14 Q. You said you were on top of Michelle?
- 15 A. I was on top -- I was laying on top of Michelle. Michelle
- 16 was laying -- I could -- I don't know how to describe the bus,
- 17 because if was (indiscernible).
- 18 Q. Sure, sure, sure.
- 19 A. And, and, and I was still out of it. I was -- but I was
- 20 | laying on Michelle, and the bus driver was laying on my shoulder.
- 21 And this is the things to my coat. Because the debris and stuff
- 22 was over top of us.
- MR. KAMINSKI: Hum. Yeah.
- 24 MS. LEWIS: They had to get the debris off. And because
- 25 neither one of us -- none of us could stand. They had to life us

- 1 up off the bus, to get us on the grass.
- 2 MR. KAMINSKI: Because of all the debris that was --
- MS. LEWIS: Yeah, they had to lift that stuff off of us
- 4 first.
- 5 MR. KAMINSKI: Okay. Wow.
- 6 MS. LEWIS: In order for them to get us off. Um-hum. This
- 7 is the damage to my coat that I had on. This is my coat.
- 8 MR. KAMINSKI: Oh, yeah. And it's destroyed?
- 9 MS. LEWIS: Um-hum.
- 10 BY MR. COLANTO:
- 11 Q. And you take the -- is that the normal bus you take?
- 12 A. Yeah, but it just so happened the bus was late that morning.
- 13 Q. But was late.
- 14 A. But she wasn't driving -- she was driving the normal speed,
- 15 | but --
- 16 Q. Right.
- 17 A. -- she was kind of late, a little late. The bus was kind of
- 18 | a little late getting to us. And I'm usually, we'll usually be on
- 19 the earlier bus, like the bus come like 6:10, usually, but it was
- 20 a little late, the, that morning.

- MS. LEWIS: They took me to Shock Trauma.
- MR. KAMINSKI: Shock Trauma?
- MS. LEWIS: Um-hum.

- 17 | nothing. I'm just, the questions that already asked.
- 18 MR. KAMINSKI: Like the driver said oh, no, or, or --
- 19 BY MR. COLANTO:
- 20 Q. Or a horn, or --
- 21 A. No, because I -- I don't know. I don't think -- I'm, I'm
- 22 glad that I didn't, didn't see anything, because I
- 23 probably would have got up, and it probably would have been worse
- 24 | if I would have try to get up and move.
