I went to King Salmon from Soldotna via Anchorage (to pick up the helo) on Monday to do some work with ADF&G in the King Salmon area and ended up staying the night.

On Tuesday at 0710 I received a call from Captain Mlynarik who asked if I heard of the aircraft accident in Dillingham, I had not so he advised that I call Trooper Minnick in Iliamna as he was the on call trooper. I called Trooper Minnick right after I hung up with Cpt. Mlynarik, Trooper Minnick gave me a brief synopsis and advised that I call Lt. MacDonald. I called Lt. MacDonald and was advised to stand by in case they needed me.

At about 0850 I was contacted by Trooper Fieser in Dillingham who requested that I fly to Dillingham for possible support.

At 0930 I was en-route to Dillingham.

At 1025 I arrived in Dillingham and was met by Trooper Henry and Trooper Sadloske and was told to stand by.

At 1510 hours I flew Trooper Henry to the area of the crash site for aerial photos and to try and locate Trooper Fieser and his party who had hiked in from the Muklung River. Poor weather hindered aerial work but we were able to get some photos before returning to Dillingham. Contact was made with Trooper Fieser thru Dillingham post with plans to pick him and his crew up at a landing zone below the crash site.

At 1650 hours I dropped Trooper Henry at Dillingham and fueled the helo.

At 1720 I was headed back to the LZ.

At 1730 hours I landed at the agreed upon LZ and waited.

At 1800 hours when I had not heard from Trooper Fieser I fired up the helo to look for them and found them in another clearing a short distance from the LZ. I landed and shuttled two sport fish guides, Guy Fullhart and Ryan Thede to their boats back at the Muklung River. Fullhart and Thede had taken Trooper Fieser and VPSO Creasey from Dillingham up river and then hiked in to the crash site.

By 1830 hours I had shuttled all four men to the boats on the Muklung River.

At 1840 I was back in Dillingham and fueled the helo then remained over night for stand by.
