- 6 LIFENET 22: (indiscernible), roughly?
- 7 DISPATCHER KOREY: Yeah. I'm showing 34 and 3 seconds.
- 8 LIFENET 22: That's going to be cutting it pretty close.
- 9 I'm probably going to need to get fuel before that.
- 10 DISPATCHER KOREY: Okay. Hey, can I put you on hold for
- 11 one second?
- 12 LIFENET 22: Okay.
- 13 DISPATCHER KOREY: LifeNet 1-3 Medical. AirCom.
- 14 13 MEDICAL: 1-3 Medical standing by for patient report
- 15 if you have it?
- 16 DISPATCHER KOREY: LifeNet 1-3 Medical, you're going
- 17 after a 63-year-old male, abdominal pain, patient weight 1-9-6
- 18 pounds. Picking up the patient at the Clarinda ER. Return the
- 19 patient to the Creighton ER. Acceptance has been verified.
- 20 That's all the information I have unless you require further.
- 21 13 MEDICAL: 1-3 Medical. Does Clarinda rendezvous at
- 22 the airport? We can't remember.
- DISPATCHER KOREY: LifeNet, 1-3 Medical. Negative.
- 24 You're going to -- yes. Sorry, that is affirmative. You're going
- 25 to meet the ambulance at the airport, pick the patient up at the

- 2 13 MEDICAL: 1-3 clear. Thanks.
- 3 DISPATCHER KOREY: 180- --
- 4 Hi. Sorry about that. Everybody and their brother
- 5 wants to talk to me at the moment.
- 6 LIFENET 22: I think I'm going to go to Excelsion
- 7 Springs. It's airport identifier of 3-X-ray -- or, excuse me, 3-
- 8 Echo-X-ray.
- 9 DISPATCHER KOREY: Okay.
- 10 LIFENET 22: Either that or Midwest National
- 11 (indiscernible) would be better. Let me look them up. I'll see
- 12 if it's going to be Midwest National or Excelsior Springs, see
- 13 which one has -- I think it's going to be Midwest National, which
- 14 is --
- DISPATCHER KOREY: I'm showing that there's, I'm showing
- 16 that there's an airport there in Bethany, Bethany Memorial.
- 17 LIFENET 22: Yeah. They don't have Jet-A.
- DISPATCHER KOREY: Okay.
- 19 LIFENET 22: I mean, I don't think they do. I can look
- 20 again, but --
- 21 DISPATCHER KOREY: Well, let me, let me look here real
- 22 quick.
- 23 LIFENET 22: Otherwise, I'll go to Gulf-Papa-Hotel is
- 24 where I'll be going.
- DISPATCHER KOREY: I'm pulling it up on the Internet

- 1 right now. Give me just a second.
- 2 LIFENET 22: Okay.
- 3 DISPATCHER KOREY: Yeah, there's -- they're not showing
- 4 a FBO there at all.
- 5 LIFENET 22: Yeah. So, Midwest --
- 6 DISPATCHER KOREY: I'm sorry. What was the identifier
- 7 that you gave?
- 8 LIFENET 22: Gulf-Papa-Hotel.
- 9 DISPATCHER KOREY: Okay.
- 10 LIFENET 22: Is that Mosby or whatever it is? Excelsion
- 11 Springs in (indiscernible), which is down -- Midwest National,
- 12 Mosby.
- DISPATCHER KOREY: Okay. Yeah, there's a FBO there.
- 14 LIFENET 22: Yeah. They have Jet-A.
- 15 DISPATCHER KOREY: Yeah.
- 16 LIFENET 22: Can you see how far that is for me?
- 17 DISPATCHER KOREY: Give me just a second.
- 18 LIFENET 12: AirCom, LifeNet 1-2. This is
- 19 (indiscernible) 21.
- DISPATCHER KOREY: LifeNet 1-2, AirCom. Standby.
- 21 Hey, I'm sorry about that.
- 22 LIFENET 22: Yeah, no problem. It looks like it's going
- 23 to be about 27 minutes to me, I think.
- 24 DISPATCHER KOREY: Sorry, I spelled the name wrong.
- 25 LIFENET 22: The identifier is Gulf-Papa-Hotel.

- 1 DISPATCHER KOREY: Yeah. I'm putting it in my map so I
- 2 can calculate in distance here. Sorry, sir.
- 3 LIFENET 22: No worries. Yeah, I got about halfway here
- 4 and looked at it and went, "Aw, crap."

- 6 miles.

- 8 save me, save me 4 nautical miles and 2 minutes. I think that's
- 9 probably where I'm going to end up going.
- 10 DISPATCHER KOREY: Okay. Do you want to -- are you
- 11 going to do that now or are you going to do it with the patient on
- 12 board?
- 13 LIFENET 22: I'm going to have to do it with the patient
- 14 on board. We're sitting here now. There's no place close to get
- 15 gas that I can just go now.
- 16 DISPATCHER KOREY: Okay.
- 17 LIFENET 22: I mean, from where I'm sitting right now,
- 18 I'd have to -- Albany doesn't have Jet-A. Cameron doesn't have
- 19 Jet-A. I mean, I could go back to St. Joe and then down. I'd
- 20 have to go out of my way.
- DISPATCHER KOREY: Okay. If you change your mind, just
- 22 let us know, okay?
- 23 LIFENET 22: Yeah. We'll figure it out. Do you want me
- 24 (indiscernible) --
- DISPATCHER KOREY: All right.

- 1 LIFENET 22: I don't want to run short and I don't want
- 2 to run into that 20-minute reserve if I don't have to, but
- 3 (indiscernible).
- 4 DISPATCHER KOREY: Yep. I understand, sir.
- 5 LIFENET 22: We'll take off. I'll see how much gas I
- 6 have when I got and I'll call you when we're in the air.

- 15 aspirin. They gave her 5 metatropal (ph.), also 2 nitro.
- 16 FlightNet 1-2. That's all the information I have unless you
- 17 require further. 1806.

- 20 DISPATCHER KOREY: Korey. I'm going to pass along
- 21 Justine at 1806. LifeNet 1-2 has landed. They switched into 352-
- 22 Lima-November. That was the pilot on the phone. Apparently, he
- 23 didn't have as much fuel. The fuel he was reading was from 101
- 24 and not 352. So, he's going to have to stop in possibly Mosby
- 25 with patient on board to get more fuel. They're just going down

- 1 to Liberty, which is right below Mosby there.
- 2 LifeNet 1-2 is on the way to Albion, possibly to bring
- 3 the patient back to Creighton. Acceptance has not been verified,
- 4 but that's where they sent the labs.
- 5 LifeNet 1-3 is going to Clarinda to the airport.
- 6 They're going to ground over, get the patient, come back.
- 7 Bringing that patient back to Creighton.
- No flights for MedFlight today. 1-1's yellow at base.
- 9 1-4's yellow at base. I'm sure that this medi-flight two flights
- 10 over -- otherwise all Oklahoma is green and back at base. Tulsa
- 11 LifeFlight green on base. They're in 324-Alpha-Mike and that
- 12 pilot's already there. They were at Eppley headed back to Rapid
- 13 City. Air Carrier 1 is yellow base. Ground's doing Great River
- 14 back to University, and Aircraft 2 is yellow at base. Iowa Life
- 15 Flight is out of service for maintenance.
- Any questions?

- 18 DISPATCHER KOREY: 1808.

- 21 DISPATCHER KOREY: LifeNet 2-2, AirCom. Traffic's

- 23 LIFENET 22: (Indiscernible) is airborne, four on board.
- 24 Risk (indiscernible) Bravo. En route Midwest National to get
- 25 fuel. Fuel status currently is 4-5 minutes.

- 1 DISPATCHER KOREY: LifeNet 2-2, lifting four on board,
- 2 4-5 minutes fuel. Bravo for Midwest. 1813.
- 3 LIFENET 22: AirCom, LifeNet 2-2.
- 4 DISPATCHER KOREY: LifeNet 2-2, AirCom.
- 5 LIFENET 22: Roger. Can you call Midwest National, let
- 6 them know we're coming in, we'll need fuel and we have a patient
- 7 on board?
- 8 DISPATCHER KOREY: LifeNet 2-2, understood. 1813.

- 10 (Start time: 1815:43)
- 11 LOWELL: Air Methods Communications. Lowell speaking.
- DISPATCHER KOREY: Hey, this is Korey.
- 13 LOWELL: Yeah.
- 14 DISPATCHER KOREY: Obviously, I haven't left yet.
- 15 LifeNet 2-2 switched into their normal aircraft, 352-Lima-
- 16 November. When the pilot took off, he told me the fuel that was
- in 101-Lima-November that he had been flying earlier.
- 18 LOWELL: Okay.
- 19 DISPATCHER KOREY: Yeah. It's bad because now he's
- 20 going to have to stop for fuel with the patient on board. And
- 21 there's no airport close.
- 22 LOWELL: Do we have -- oh, my gosh. Do we have an AOC
- 23 for that program?
- 24 DISPATCHER KOREY: No, not like Arizona does.
- 25 LOWELL: Oh, god. Do we -- call --
