Used NYPD tow to lift back of bus to affect inspection. SMCI Paraskevas: At co hq obtaining records prior to inspection-record current possession, J. Nicastro.

Log Books: In possession of NYPD-August and Sept.-obtained in bus. No pages turned into to carrier. Photos in my possession.

Driver deceased at hospital. 3 fatal total: Dahila driver, 2 pedestrians. 16 inj. Dahilia e/b 25a, went through red at main st. on Svce Road. Hit right turning MTA bus in rear and then went into bldg.

Brakes: Chambers have no exposed pushrod. Disc lining: Unremarkable wear. Unable to power vehicle. Foot controls destroyed.

Tire Tread Depth: 14/32 l/s 16/32 r/s. Axle 2: 9/32, l/s outer 11/32 inner Axle 3: 12/32, l/s, r/s

Tire Pressure: Axle 1, both sides-flat. Axle 2: I/s inner 102 psi, outer 110 psi. r/s: 105 psi, outer and inner.
