I, am not under arrest for, nor am I being detained for, any criminal offenses concerning the events I am about to make known to the ERIE POLICE DEPARTMENT. I volunteer the following information of my own free will, for whatever purpose it may serve.

Was in my office, north side of FBO Hangar, heard what sounded like someone buzzing airport, looked out office window (facing north) saw A/c Flyover Building Northwest bound - left wing low, approx 50 FT AGL, A/c sounded under full power, was banking left & looked to be purpasing elevator up & down. A/c seemed to be sinking fast. Then impacted west bank of Coel creek & looked to kind of pancake into bank of River then cart wheel over. I ran to front office to have Receptionist call 911. Went to crash site found Flight Nurse looking inside A/c window, when she saw me, she said no one was alive, she said all other necks were broken. I then backed away from airplane and started asking bystanders to stay out of the way. When fire arrived I went back to airport.

Note: Nurse was from Med-TRANS.

I read, speak and understand the English language. I am not under the influence of any intoxicant. No threats, promises, favors, or promises of leniency have been made to me by any person. My voluntary statement follows:

Sitting on deck of [redacted] was able to have full view of the entire crash sequence from the beginning of the go around just above the approach end of the runway, normal landing height, gear was down. Was not a normal go around. Climbed only slightly at first. Did not hear full power come in. Turn left approx 30° then settle into the ground in wings level state. Impacted the bank of ravine in a moderately nose high attitude. Pitch and roll attitude seemed to remain constant all the way in, after the turn. Power seemed to remain from the beginning of go around. Speed during ~~the~~ go around seemed like normal landing speed. Hard to judge if it was near stall speed. Oh gosh, I forgot to mention, gear was coming up after the turn and probably fully retracted at impact. No fire thank goodness

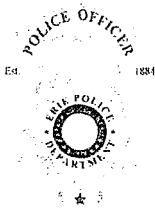

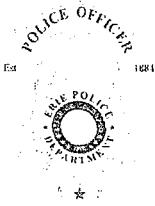
