I was working at Rose, TTC, in the middle area of the express side, around 2:00 am, still in the same position, when I looked towards Concourse where Eprot line is I saw monorail pink reversing to the station. I saw that pink passed the station and when I looked further, about 25-30 feet away from Concourse monorail purple was stopped. Pink reversed into purple and crashed with both front cabs. As I saw this I went running to the monorail entrance to keep the guests away from the area and from the debris. About a couple of minutes I saw pink pulling forward with purple still attached. Another couple of minutes later I dialed 911 and gave my phone to another Cast Member, Eddie Ramos, who was also at the time of the accident
