I noticed the small aircraft low to the ground - too low for how far it was from the airport. It initially seemed to be headed north, then took a turn to west with nose down. I initially thought it would land in the field, but then took a sharp turn north & down. It hit a power line & crashed ~~into~~ <sup>near</sup> structure at Dairy farm & burst into flames. The power line sparked & came down.

I called 911. Reported accident & fire, although I could not recall name of country Rd.

I ran over to crash site & other bystanders helping crash victims out of plane. Front of plane came apart from tail, which was a few yards away on fire.
