 SPARK PLUGS. THE WAY HE CAME IN
 IT LOOKS AS THOUGH HE TRIED TO SET IT
 DOWN ON THE ROAD IN FRONT OF OUR
 HOUSE, BUT WITH IT GETTING DARK THE
 ELECTRICAL LINES WERE PROBABLY NOT VISIBLE.
 THE FACT THAT THERE WAS NO FIRE AT ALL
 IMMEDIATELY AFTER THE CRASH ALSO IS A
 QUESTION. ZERO FIRE AT ALL.

WHEN I FIRST SAW THE AIRCRAFT IT APPEARED TO BE COMING STRAIGHT DOWN, TRYING TO RECOVER FROM A SPIN. THEN HE ROLLED VERTICALLY RECOVERED UPRIGHT, AT THAT POINT I THOUGHT HE WAS OK, THEN I SAW THE LEFT WING GO ABOUT 80° UP. AT THAT POINT HE WENT BELOW THE TREE TOPS IN A RIGHT TURN - I THOUGHT IT WAS JUST A GUY DRIVING ACRO. - THE AIR PLANE WAS NOT AT FULL THROTTLE AT THE TIME I LOST HIM BELOW THE TREE TOPS IT DID SOUND LIKE THE ENG. WAS SPUTTERING AND I HEARD A LOUD POP - LIKE A BACK FIRE AS HE WENT BELOW THE TREES.
