side of the airport, he saw white reflective wings on the S.W. end of the runway where VI was last seen. When RP looked back to the area a 2nd time he noticed VI swerve right then left again and crash off the end of the runway. RP stated he believed he(VI) was swerving out of the way of another plane that RP saw as he circled. 1WI (RP's wife) stated that she too saw another plane she believed was a Cessna in the same proximity of VI when he swerved and crashed. I also spoke w/2WI who works for the FAA, 2WI advised that he was in his hanger at C.E. Page when he was contacted by a friend Gary Lake who told him there was a crash at the South end of the runway. 2WI then drove his vehicle to the scene and contacted the FAA.
