

Supporting Deposition

On the 20th day of September, 2015, I Deputy Shannon Augustine, working in and for the Madison County Sheriff Department, do state the following:

On September 20, 2015, at about 1254 hours, I RICHARD W GORTON, DOB chief in and for the Morrisville Fire District, received a call about a plane crash in the area of Old County Road and Stone Bridge Road in the Town of Eaton.

Upon arrival, I located LYNN ROHER and he asked me if I wanted him to help and he could take me up in the hills, while driving on Old County Road, I saw a man on a four wheeler who was waving his arms, so I decided to follow him down a farm trail.

I called on the radio and stated to 911 that I was on the trail and that someone would be marking the road to show responding units where to go. I followed the four wheeler to the location of the plane crash, and ROHER and WITTWER ran to the plane, while I was getting my gear on. Both ROHER and WITTWER came back to my ocation and stated that it was obvious death. I called the 911 center again on my radio and told them to advised powers to be that it was a signal 45 times two for the Sheriff's and file 3 for the State Police.

I waited for law enforcement to arrive and turned the scene over to Deputy Augustine, from the Madison County Sheriff's Office.

#### State The Following:

My name is George Eiholzer and I am a volunteer Medic for the Smithfield Eaton Volunteer Ambulance (SEVAC) Ambulance Service in Morrisville NY. I am the Chief of Operations for SEVAC. I am a state certified critical care technician.

On September 20, 2015 at about 1:00 Pm, SEVAC was dispatched to a reported plane crash. The dispatch advised the crash was either on or near Old County Road in the Town of Eaton. I arrived in the area with my personal vehicle, which contains all my medical gear. I began to drive the area attempting to locate the plane crash site. The Morrisvile Fire Department arrived as well and began to look for the crash site. Fire Chief Rick Gorton advised over the fire radio that he had located the crash site, as he was in a farm field off of Old County Road. I drove down the farm field access road and located the plane. I observed a plane on the ground, with the nose down into the dirt. I could see both victims hanging out of one side of the plane. I could see that the victim on the left side of the cockpit was a female. I could see the passenger was a male. I could tell that both victims were both young.

I approached the plane and checked both victims for a pulse by touching their necks. I determined that neither victim had a pulse. From the position of the plane and the wreckage, both victims had obvious signs of death, with massive head trauma, and chest trauma. Madison County Deputy Sheriff Shannon Augustine had arrived and was with me. We determined by our watches that the time of death was 1318 hours. I took no further action, as I turned the scene over to Deputy Augustine.


I make the following statement to Deputy Gabriel of the Madison County Sheriff's Office. I would like to say I met CATHRYN DEPUY on the or about the 29th of August 2015 when she came in to the Hamilton Airport to discuss renting and airplane. I had spoken with her father about a week prior and he also had made inquiries about his daughter flying out of the airport. CATHRYN came in on the 29th with all the required documentation to fly. She had her FAA medical certificate, FAA private pilot certification, I flew with CATHRYN on that day for about .4hrs and we performed one landing. CATHRYN returned on the next day, the 30th of August and we flew 1.4hrs together and reviewed all private pilot maneuvers and emergency procedures. during the flight we did 4 landings together. I left the aircraft and CATHRYN continued on solo for a period of time after. I have checked my paperwork and found CATHRYN flew this aircraft one other time on September 2, 2015 at 3:00pm and had the aircraft booked for 1.5hrs. Today CATHRYN came in to take the aircraft at about 11:30am, she had a young man with her who had expressed an interest in flying and made inquiries about flight lessons here. I noticed CATHRYNdid a very thorough per-flight inspection as she explained what she was doing and telling the male why she was doing it. CATHRYN was done with her pre-flight about 12:15pm and took off at about 12:25pm. as I was working around the facility I remember hearing CATHRYN making her required calls over the radio. The last call I recall hearing was that she was going over the collage and that she would be flying in the area of the airfield. About 20 minutes after her last call a Officer from the Hamilton Police Department stopped by and told me there was a report of an airplane that had crashed in the area of Morrisville. He asked me if I could fly up to the area and locate anything. I flew to the area where the reported accident occurred and I was able to pick up the emergency locator tone. I contacted Syracuse to find out if they had received any information and they told they did not. I was able to locate the crash and flew and orbit above the incident. I noticed there were emergency responders on the ground in the area. I returned to Hamilton Airport, and spoke with the Officer from Hamilton Police.

As the plane flew over head of us the engine stalled again and the plane did the same downward swoop as before but the engine didn't start again. I could see the plane level off a little then it suddenly pitched to one side then spiraled downward. Right before it went below the tree line the top of the plane was facing me. I was west of where the plane went down.

It looked like it went down on my grandfathers property so I checked the area but when I came out of the woods I could see the emergency vehicles at the downed plane. I went back to my grandfathers after the plane went down to wait until everything calmed down so that I could tell the police what the plane was doing before it had crashed.
