I Jamie VanHorn was in bed we were getting a heavy down pour at the time. The rain had just let up My wife Teia VanHorn was in the living room. We could here a constant low rumbling all at once you knew it was a plane it got extremely loud and fast. In my opinion just by sound the plane was traveling due east, at a very fast rate of speed. We knew it was way to low by the sound. you could almost feel it in your chest. It was gone as fast as it appeared. We thought nothing of it until I saw it on Solomons words around 11:30 pm. When I showed the news post to my wife she turned pale white, gasped and said "oh my god Jamie them people". In talking with neighbors afterwards I assumed the plane was across the road and field possibly over the ridge.
