
## SUPPORTING DEPOSITION GENERAL



## SUPPORTING DEPOSITION GENERAL

I, H. Kenneth Murdock, residing at the following allegation of Dix, Schyler County, State of New York, by this Supporting Deposition make the following allegation of fact in connection with an accusatory instrument filed, or to be filed:

On November 15, 2012, I was working for the Corning School District and was doing a job at Corning East High School. I am a consultant and the architect for a project. At about 12:15pm-12:30pm, I was on the gym auxiliary roof of the school. I could hear a helicopter flying. I looked up and saw it coming down the hill, east of the school and east of the highway. The helicopter was flying down, over the top of the power lines. It was actually below the highest tower from my advantage point. I took my eyes away for a minute. I looked back up and I saw a flash the right side of the power poles, which would be south side of the power poles. I knew the helicopter had hit electric wires. I saw the helicopter fall and it then disappeared from my point of view. I then saw flames and lots of black smoke. I immediately called 911. During the duration of the incident, I did not ever hear a change in the rhythm of the blades prior to the crash. I could not tell from where I was as to how many passengers were in the helicopter.
