My name is Karlie Darmochwal and I am currently employed at Million Air White Plains. I am a customer service representative who works at the front desk in the lobby who greets customers, answers phones, processes invoices etc. On this date, June 13th 2014, I was working my regular scheduled shift of 0600-1400. N5335R was on our schedule to depart @ 0900. In our notes we were to bring the aircraft online for departure. Mr. Richard Rockefeller arrived in our lobby at approximately 0745. Upon first seeing him, I realized he was early and that his aircraft had not been pulled online yet. Mr. Rockefeller walked in and said "Good Morning" just like how he always greets us. The line supervisor also happened to be at the desk so I asked him verbally, in front of Mr. Rockefeller to bring the A/C online. At which point, Mr. Rockefeller said, "I'd like to have the plane facing the wind since it is strong this morning" At which point Jonathan nodded and proceeded to get the plane. After that Mr. Rockefeller stepped into the bathroom and came out a few minutes later. He grabbed his bag off the couch and started heading to the door leading to the hangar. He said "Thank You, Goodbye, See you next time." And I said "goodbye and to get rid of this terrible weather for us" He laughed and proceeded out the door. He seemed like his usual self, He walked in alone, was very friendly and somewhat in a rush like he always looks. He had said he wanted to get out before the storms so I understood his rush.

He asked for his plane to be put online and facing the wind. I then proceeded to do as requested. When the aircraft was put online I asked Mr Rockefeller if he wanted his plane to be checked. He replied no thank you, I will be leaving as soon as you disconnect the tug. I disconnected and went on to complete another task. I had left the building for a pickup at the train station and upon my return I was given the tragic news.
