I had just stepped out of the east overhead of the main bldg at Riley & Son's when I heard a plane. I looked up and it was over that main bld going down. It did not sound like the eng was having trouble. After he cleared Riley's and 4005 he went down several hundred yards in the field nose first at about a 45° angle. I then looked back to the north and saw what looked like a wing, but for sure part of the plane floating down towards the woods on N/E section of the Riley property. I then walked out to 400 ~~to~~ but the police were coming so I did not go to the site

My husband and I were coming E. on 400th, right before we got to 200th, I saw a shiny bright shape of an airplane it looked to be not too big, I realized it was diving straight down towards the ground, and I screamed at my husband, look at that, the airplane is crashing. I was so scared and just then it hit the ground. We turned on 200th going South, we looked on both sides of the road, and could not see any fire or dust at all, although the plane ~~crashed~~ hit the ground pointed nose first and made a puff of dust as it hit. We could not even see any airplane parts laying around. My husband said he believed that it was a model airplane and I thought he might be right, because we could not see a crashed airplane. We came on home and my son informed me he was the first one at the scene, as he was driving by, he is an E.M.T. and he called me and I came right back over. This was a very frightening thing to me.
