1	PROCEEDINGS
2	MR. WIEMEYER: Okay. We're back on the
3	record. And at the present time we're interviewing
4	Dave Ruvola. And, Mr. Rolava (sic) would please state
5	your full name and spell your last name.
6	MAJ. RUVOLA: Okay. My name is actually it's
7	C. David Ruvola, R-U-V-O-L-A C is for Christopher.
8	MR. WIEMEYER: Okay. And you are attached to
9	the New York Air National Guard.
10	MAJ. RUVOLA: I am.
11	MR. WIEMEYER: At the Westhampton Beach
12	MAJ. RUVOLA: Yes.
13	MR. WIEMEYER: Facility?
14	What was your role with regards to the events
15	surrounding the TWA accident?
16	MAJ. RUVOLA: My role initially was to be
17	called in to fly the SAR search and rescue of the
18	victims of TWA Flight 800. And I was to come in at
19	3:00 o'clock in the morning after the accident took
20	place.
21	However, when I got here we were stood down
22	and we were basically been regulated to fly the FD
23	FBI and the NTSB to and from the meetings and the
24	press conferences, and the like, for the duration of
25	the investigation; approximately about a month or so.

1	My closest contact with anyone who was an
2	eyewitness came with Chris Baur Capt. Baur, who knew
3	of my interest in the area of side business at home in
4	hypnosis. And he was having problems with a dream, and
5	he approached me. And I was offered my services to
6	help him out if I can help him in any way, shape or
7	form.
8	He did come to my house one evening. And I
9	used a a regression technique to bring him back to
10	the scene in his mind's eye of what took place on that
11	evening. And we spent approximately an hour together.
12	MR. WIEMEYER: Okay. For the purposes of
13	clarification, you're a helicopter pilot with the
14	Guard?
15	MAJ. RUVOLA: Yes.
16	MR. WIEMEYER: Okay. And would you give us
17	your training and background qualifications as a
18	hypnotist, please?
19	MAJ. RUVOLA: Yes. I began it I had an
20	interest in hypnosis always since I was in high school
21	and I took a few courses. I guess beginning in 1992,
22	through the National Guild of Hypnotists, a basic
23	hypno-therapy certification program, along with later
24	on what they called an advanced clinical hypno-therapy
25	certification.

1	I then began a a very, very small part-
2	time business in it. And I didn't continue beyond a
3	month when I realized that I needed to expand my
4	education and knowledge in this area, because I had
5	people clients coming to me for items that were
6	it seemed very superficial: smoking, stress, weight
7	loss; things of that sort and they began to express
8	and divulge quite a bit more than I had anticipated.
9	I felt myself not qualified to hear these
10	things when I was my background was very minimal, as
11	far as official training or in formal training for
12	this.
13	So, I then enrolled in a 14-month long
14	correspondence course that I completed and received a
15	Master's Degree in. It's a college in Louisiana called
16	St. John's University. It is not a regionally
17	accredited university. But it did give me much more
18	background and and confidence in myself as far as
19	performing hypnosis.
20	MR. WIEMEYER: To act as a hypnosis in the
21	State of New York are you required to have any kind of
22	a license or
23	MAJ. RUVOLA: No, you're not.
24	MR. WIEMEYER: Okay. And then, you do run
25	this business well, still on a part-time basis?

1	MAJ. RUVOLA: Yes, I do, but on a very
2	minimal basis. My most of my clients now are really
3	on a volunteer-type basis, and I'm not even charging
4	anyone. But I in the future I hope that when I have
5	more time I'll pursue it more readily.
6	MR. WIEMEYER: During the interview with
7	Chris Baur we discussed his being hypnotized by you,
8	and that's one of the reasons that we wanted to talk to
9	you.
10	Would you expand on what took place during
11	the the session with Chris Baur, please?
12	MAJ. RUVOLA: Yes. He came in and I used a
13	what's called a progressive relaxation type thing to
14	relax him. I then took him on a guided visualization
15	to relax him mentally. And I then used a technique to
16	help him recall in his mind's eye what he saw that
17	evening.
18	The technique that I used that particular
19	evening I believe I used a the analogy of an old-
20	time movie theater an old-time movie show; whereby
21	the picture frames would click, or stop like a
22	Charlie Chaplin-type of thing. And I asked him, if he
23	could, to go and stop at each frame from what he saw
24	and continue on until impact.

The exact words and details I don't have.

1	But the general overview would be that he saw
2	something. He described it. And there was some kind
3	of an impact and an explosion. And a secondary
4	explosion. And he became extremely emotional when we
5	got back to that point of the actual impact, and what
6	he had seen prior to it.
7	He described a sparkler type of thing. A
8	high white-pitch glow impacting, and then an explosion
9	and then a secondary explosion. And, of course,
10	falling debris and and a very large flame falling
11	towards the ocean.
12	MR. WIEMEYER: Chris Baur's shared with us
13	that he that you made a tape of that session or
14	he did. Or there was
15	MAJ. RUVOLA: No, I
16	MR. WIEMEYER: a tape made of the
17	MAJ. RUVOLA: I always make a tape of
18	the
19	MR. WIEMEYER: Okay.
20	MAJ. RUVOLA: of the sessions.
21	MR. WIEMEYER: And he has offered to share
22	that tape with us this afternoon, so I won't go into
23	any more details with regards
24	MAJ. RUVOLA: Okay.
25	MR. WIEMEYER: to that since it's all

1	MAJ. RUVOLA: Fine.
2	MR. WIEMEYER: on the tape.
3	MAJ. RUVOLA: You bet.
4	MR. WIEMEYER: Just some general questions to
5	help me understand hypnotism, which I know absolutely
6	nothing about.
7	MAJ. RUVOLA: Uh-huh.
8	MR. WIEMEYER: Can a hypnotist induce
9	information into a client?
10	MAJ. RUVOLA: They can. And you have to be
11	very careful with that, not to provide any suggestions
12	that would lead a client to say something that maybe he
13	didn't actually recall. And there have been cases
14	regarding false memories things of that sort
15	where people would regress back. And the possibility
16	arose that the hypnotist actually said some things that
17	may have brought on these these memories regarding
18	past past childhood trauma; traumatic type things of
19	things of this sort. So, you have to be very
20	careful.
21	And I was very careful not to do that. And I
22	believe that when you listen to the tape you'll be able
23	to judge for yourself that, hopefully, I did not do
24	that in any way, shape or form.
25	MR. WIEMEYER: Okay.

1	MAJ. RUVOLA: But it is a in answer to
2	your question, sir, it is a possibility.
3	MR. WIEMEYER: Okay. That's what I want to
4	find out. Because can you give us an example of the
5	type of questions that you ask in a general sense when
6	you do have someone under your hypnosis to avoid this
7	type of activity?
8	MAJ. RUVOLA: To avoid it? For example, with
9	regards to the specifics involved with the TWA Flight
10	800, obviously there was speculation that something
11	beyond an aircraft mechanical failure took place.
12	I was very careful not to suggest in any way,
13	shape or form what actually took or happened on the
14	flight. I was very careful just to ask Capt. Baur
15	exactly what he was seeing; how he was feeling; his
16	position in the helicopter. Things of this sort.
17	And not to imply or suggest anything to add
18	to his surmise of what happened.
19	MR. WIEMEYER: Do you feel that Capt. Baur
20	gained some insight through the hypnosis that helped
21	him deal with this you know, better way?
22	MAJ. RUVOLA: Apparently it did. He would
23	he told me thereafter that he recalled a few things
24	that he didn't on a conscious level. And apparently, I
25	believe he began to sleep a little bit better. I'm not

1	100 percent sure on that. But I believe he did.
2	MR. WIEMEYER: When people are under
3	hypnosis, do they recall the details of what takes
4	place under hypnosis when they are brought back to
5	the
6	MAJ. RUVOLA: Conscience
7	MR. WIEMEYER: conscience
8	MAJ. RUVOLA: and a whole state of mind?
9	MR. WIEMEYER: Yeah.
10	MAJ. RUVOLA: Yes and no. It it all
11	depends. In in Baur's case, yes, he did. He did
12	recall everything.
13	MR. WIEMEYER: Okay. I have no further
14	questions.
15	We'd like to go around the room and each one
16	of the people who have questions will identify
17	themselves so that we know who they are for the tape.
18	MR. BURNS: Dave, I'm Lou Burns. I'm a TWA
19	747 captain, and I'm representing the Air Line Pilots
20	Association in this
21	MAJ. RUVOLA: Right.
22	MR. BURNS: In addition to your training and
23	your degree from St. John's did in your
24	undergraduate work did you study psychology? Or do you
25	have any psych? You know, background in psychology?

1	MAJ. RUVOLA: Just a few basic courses for
2	the requirements, that I had for my Bachelor of Science
3	degree.
4	MR. BURNS: Okay.
5	MAJ. RUVOLA: But I I did not minor, nor
6	did I major in psychology.
7	MR. BURNS: Okay. That's all. That's all I
8	have. Thank you.
9	MR. CLEMENS: My name is Al Clemens, with the
10	FAA. And I have no questions.
11	MAJ. RUVOLA: Yes, sir.
12	MR. METCALF: And I am Scott Metcalf, with
13	the FBI. I'm a special agent with the Bureau.
14	What city is St. John's located in?
15	MAJ. RUVOLA: Springfield, Louisiana.
16	MR. METCALF: Is in the Masters you
17	received in this correspondence course like what is
18	it? What's the name of the like the designation?
19	MAJ. RUVOLA: It's called the
20	MR. METCALF: Master's of what?
21	MAJ. RUVOLA: Master Degree it's Master of
22	Science in Hypno-therapy. And they also gave me a
23	certified clinical hypno-therapist certification.
24	MR. METCALF: Okay. And a number to reach
25	you? Do you have, like, a office number or home

1	MAJ. RUVOLA:	The office
2	MR. METCALF:	number?
3	MAJ. RUVOLA:	number here is 288-7606.
4	MR. METCALF:	Okay.
5	MAJ. RUVOLA:	And home phone number is
6	874-2381.	
7	MR. METCALF:	Okay. What's the area? (516)?
8	MAJ. RUVOLA:	Yes.
9	MR. METCALF:	Okay. And you're rank in the
10	Coast Guard?	
11	MAJ. RUVOLA:	In the Air Guard
12	MR. METCALF:	I mean, oh
13	MAJ. RUVOLA:	you mean?
14	MR. METCALF:	Yeah.
15	MAJ. RUVOLA:	That's okay.
16	MR. METCALF:	What's the rank?
17	MAJ. RUVOLA:	Major.
18	MR. METCALF:	Nothing else. Thank you.
19	MAJ. RUVOLA:	Yes, sir.
20	MR. STACEY:	Dave, Terry Stacey, with TWA;
21	747 captain. I'm tryin	g to assist the NTSB in the
22	investigation.	
23	When I am in	a normal situation or state, and
24	look at something, see	something and then I go under
25	hypnosis, is the wel	.l, let me say this first. Is

1	the eyesight better? Or, describe how that works, as
2	to whether you might see something, or recall something
3	that you saw that you did not consciously record?
4	MAJ. RUVOLA: Okay. I think what you're
5	looking for is can you recall things more acutely or
6	better while under hypnosis, than on on a conscious
7	level? Is that
8	MR. STACEY: Yes. Uh-huh.
9	MAJ. RUVOLA: what I'm getting from you?
10	MR. STACEY: Yes, basically.
11	MAJ. RUVOLA: Obviously, that's very
12	subjective. Okay.
13	I would say, yes. And through my training
14	the answer is yes. However, that is something that
15	would be subject to criticism. I don't believe you
16	could prove whether or not somebody had actually seen a
17	thing, or recall something clearer in hypnosis. And
18	that's why I don't believe it will stand up in court.
19	I know that forensic hypnosis, from my
20	understanding of it, is used primarily in the FBI could
21	maybe it's enlightened us just for looking for
22	leads, and things of this sort, that may help them in
23	an avenue. However, I don't believe it is an an
24	acceptable means of evidence in in a court of law.
25	MR. STACEY: Okay. For example, I'm in a

1	room here now and there are lots of objects around me
2	that I'm not focussing on. This Coast Guard blue thing
3	in the behind you there, is an example. Under
4	hypnosis would I be able to if I looked at that
5	would I be able to read that?
6	It assuming I could read it?
7	MAJ. RUVOLA: Okay. Another example may be
8	could I bring you back to where you had lunch yesterday
9	in the cafeteria and ask you the question of what color
10	or what type of painting was on the wall, when you
11	consciously were not on the level? The answer is
12	possibly yes.
13	MR. STACEY: How long have you known
14	MAJ. RUVOLA: Baur?
15	MR. STACEY: Baur? his rank?
16	MAJ. RUVOLA: I've known him since he joined
17	the unit in approximately 1992, I believe. I believe
18	it was '92 when he joined the unit.
19	MR. STACEY: And your area of hypnosis is
20	well known to the Guard unit? Is that true?
21	MAJ. RUVOLA: I work with people here in the
22	Guard, yes. I don't readily advertise it in in
23	attempting to drum up business, or anything along those
24	lines, no. I I deal with people on a very personal
25	level and if somebody approaches me on it, yes, I'll

1	help them. And I'm not trying to pay my rent with this
2	by any means or
3	MR. STACEY: No, I
4	MAJ. RUVOLA:way, shape or form.
5	MR. STACEY: understand. I'm trying to
6	get the relationship between you and Chris as to his
7	approaching you for the hypnosis.
8	MAJ. RUVOLA: Okay. Chris a approached me
9	a while back before the incident 'cause he wanted to
10	stop smoking. And at that point he he was aware
11	that I did hypnosis. And, unfortunately, I couldn't
12	provide him the time to do it because I was involved
13	with a very expensive correspondence program here with
14	the Guard in order to make the next rank and I spent
15	it I finished it up about three months ago.
16	And as such, I wasn't seeing anybody. And I
17	didn't want to take one and not anyone else; so
18	basically across the board I basically put hypnosis on
19	the back burner. So, he was aware of that.
20	But then, after the the incident with TWA
21	he then re-approached me and said that he would like to
22	attempt to recall the incident because he can't sleep
23	at night, and there's something that was bothering him
24	about it. And he asked if I could help him. And I
25	said, I I if I can help, I'd love to.

1	MR. STACEY: Okay. Were you surprised at
2	anything that came out in the had you talked to
3	Chris about any of this previously? The incident
4	and
5	MAJ. RUVOLA: The incident itself?
6	MR. STACEY: specifics?
7	MAJ. RUVOLA: Well, I I knew basically
8	what he had seen. You know, and what he he was
9	reporting, you know. On the television and all the
10	media events I was part of that; not on stage, but I
11	was here as a member and working the command post
12	during that the entire aftermath, as everyone else
13	was.
14	MR. STACEY: The this is something that
15	just came to mind. Do people normally tell the truth
16	under hypnosis? I'm not saying
17	MAJ. RUVOLA: He could
18	MR. STACEY: they to lie.
19	MAJ. RUVOLA: certainly lie, absolutely.
20	That's right.
21	MR. STACEY: I'm sorry?
22	MAJ. RUVOLA: He can certainly lie.
23	MR. STACEY: He can?
24	MAJ. RUVOLA: I mean, there's just no doubt
25	he can. In his particular case I don't believe he was

1	But, you know, again, that's subject. I I feel that
2	he was interested in coming to me I know him to be a
3	very honest guy and a very straightforward person, as
4	I'm sure he came across to you folks in here in his
5	interview.
6	And I've been on trips with him and we've
7	talked on a on a deep level about issues concerning
8	personnel and incidents sort. And I know him to be a
9	a man of integrity. And when he did approach me he
10	was sincere of it. And I'll if there was anything I
11	could do to help him, I was going to.
12	And I can tell you this, when he did recall
13	the incident he did become extremely emotional. And I
14	think it was something that he was allowing to get out
15	of of his system during that time.
16	MR. STACEY: That must've been a terrible
17	experience. Okay. Thanks, Dave.
18	MAJ. RUVOLA: Sure.
19	MR. STACEY: I have no further questions.
20	MR. WIEMEYER: Dave, I have no further
21	questions. Does anybody else in the group have any
22	other follow-ups?
23	(No response.)
24	MR. WIEMEYER: I want to thank you for taking
25	the

1	MAJ. RUVOLA: Okay.
2	MR. WIEMEYER: time. I was
3	MAJ. RUVOLA: My pleasure. Thank you very
4	much, sir.
5	MR. WIEMEYER: You're welcome.
