### (4) STATUS OF CASUALTY

- Lying on port side in approximately 25 feet of water approximately 1NM NNE of Clark's Point.
- 23Aug18; when the RMG300 was on-site and in position, it was noticed the vessel is now sitting more upright and only listing to port rather than fully resting on her port side.
- 24Aug18; reported that the casualty is resting in a hole, created by the changing currents, and the keel is approximately 12' below the mud line, listing 15° to Port.

#### (5) STATUS OF WRECK SITE

- Vessel sank in approximately 25 feet of water at 58° 51.5′ N, 158° 32.1′ W on 25 July 2018.

## (6) SERVICES

#### **Performed In Last 24 Hours**

- Completed setting barge up for lifting operations. Tested all pumps and winches.
- Repositioned RMG300 over wreck site. Anchors out and spuds down.
- Divers completed rigging/connecting the bow port and starboard lifting chain.
- Started working on connecting aft chains. Current too strong for diver so have to wait until next slack tide tomorrow morning.

#### **Planned For Next 24 Hours**

- Complete connecting the aft/stern chains to the A-Frame.
- Perform final inspection and safety check on all chains and rigging.
- Commence lifting operations.

#### Planned For Next 48 - 72 Hours

- Continue lifting operations.
- Begin pumping operations and perform necessary steps to prepare for safe towage.
