Met with vessel master to discuss the scope of the inspection. Inspected master's MMC and vessel log. Discussed the onboard procedures for the storage and usage of Li-ion batteries if onboard the vessel. Discussed the prohibited use of extension cords or overloading of the outlets. Witnessed general alarm. Inspected installed fire detection panel (backup battery and servicing which occurred on 28JUN22).

Conducted walk through of passenger accommodation areas and machinery space. Ensured emergency exits were accessible. Witnessed safety orientation.
