

Also, he would tell the driver the name of other places they would be going. I gave him a quote and he said he would check with his party and get back to me. A short time later he called back and agreed to the price. I called one of my drivers, Scott Lisinicchia, asked him if he was available for the job and he said yes. I then texted him all the info for the service, where to pick them up, customer name and where they were going. He responded that he would go get the car. I did not have any other communication with Scott. It is common not to hear from a driver until the trip is completed. At about 3:55PM today I received a phone call from Investigator Erica Hock telling me that my vehicle was in a serious accident out in Schoharie somewhere near 30 and 30A maybe. I had to ask her a couple times because



missing my vehicle and striking the blue car that was traveling north on SR-30A. It was awful. The blue car went flying. I didn't even see where it landed. I then saw the limo flew right into trees and the ditch, the back end came up about 45 degrees, and then slammed down. The limo ended up laying on the bank of the ditch, sort of on its left side, facing northwest. I pulled over, put my flashers on and ran over. My daughter was on the phone with 911. I walked over towards the Apple Barrel and saw two deceased men, one was between two vehicles in the lot and the other was entangled in trees and bushes. I then took the phone from my daughter and told the 911 operator what I had seen. Shortly after that police arrived. This statement is true and accurate to the best of my knowledge.
