

vehicles, involving units 4, 8, 9 and 10 before ultimately coming to final rest in the grass median just north of the bridge. Units 5 and 10 came to rest in the grass median. Unit 9 was caught in the front of unit 1 which resulted in Unit 9 being pushed into the grass median where it came to a final rest on its driver side in front of unit 1. Unit 6 driver was attempting to pull as far left as possible to avoid collisions.

Prior to this crash, a single-vehicle crash occurred at approximately 2:17 p.m. on the bridge at the same location on Interstate 65 at the 138.3-mile marker, which involved a 2019 Hyundai Santa Fe, with a vehicle identification number (VIN) of 5NMS33AD4KH085821. This single-vehicle collision forced the driver, Mark A. Willis, to pull over onto the grass median just beyond the bridge near the inside northbound lane. As a result of this one vehicle crash, multiple vehicles south of that crash began to slow and collect in both northbound lanes near the end of the bridge.

Subsequent crashes that followed, involving another tractor trailer, resulted in units 1, 5, 6, 9 and 10 to burn.

The driver and passenger of unit 10 were released from the hospital prior to making contact with any Trooper.


