Please find attached NTSB's party representative form to participate in the investigation of Contact of Towing vessel Ovide J with Chalmette Oil Refinery Crude Oil Dock.

On April 25, 2023, about 0004 central daylight time, the 76-foot-long towing vessel Ovide J was attempting to maneuver two 297-foot-long loaded crude oil barges to Chalmette Oil Refinery's crude dock near mile 89 on the Lower Mississippi River when the starboard barge's (EMS 348) starboard

quarter struck the dock, causing 150 feet of the dock to collapse. There were no injuries or pollution reported. The berth suffered extensive damage to the pipelines, bridges, and pilings.

Thank you for taking my call this afternoon. As discussed, please find attached NTSB's draft Marine Investigation Report for the investigation into Contact of Ovide J Tow with PBF Chalmette Refinery Dock on April 25, 2023, about 0004 local time. The towing vessel Ovide J was maneuvering two loaded crude oil barges to the PBF Chalmette Refinery crude oil dock near mile 89 on the Lower Mississippi River in Chalmette, Louisiana, when the starboard barge's starboard quarter struck the dock, causing 150 feet of the dock to collapse.

Kindly review the attached draft report (word document or pdf) for accuracy and provide technical review and comment. The deadline for submitting comments is **January 17th, 2025**. If I do not have a reply by that date, I will consider the report to be technically correct.
