Narrative:

RFD was dispatched for the report of a bus vs child. Squad 3, Engine 7 and Squad 20 responded. Squad 3 arrived on scene and reported that a truck had hit the school bus then a child waiting for the bus. Crew members from Squad 3 assisted with the patient, Engine 7 crew set up the Med Flight landing zone and squad 20 redirected traffic at 136 and 33. A crew member from Squad 3 redirected traffic at Northwoods and 33 to close the road down to traffic. Med Flight landed and assisted EMS on scene with the patient. The child passed away at the scene. Med Flight returned to Madison. The road way was shut down for approximately 5 hours for the crash scene reconstruction. Fire crews returned to the station.


