Navigable Waters (Section 10) of the United State (Traditional)

These waters are administratively defined to mean waters that have been used in the past, are now used, or are susceptible to use as a means to transport interstate or foreign commerce up to the head of navigation.

A determination of the navigability, once made, applies laterally over the entire surface of the water body to the ordinary high water mark (OHW). The OHW mark for inland fresh waters is the line on the shores established by physical characteristics such as a clear, natural line impressed on the bank; shelving, changes in the character of soil; destruction of terrestrial vegetation; the presence of litter and debris; or other appropriate means that consider characteristics of the surrounding areas. Section 10 or Section 404 permits are required for construction activities in these waters.

Regulates all structures and/or work in or affecting navigable waters of the U.S.

Section 404

Clean Water Act:

Regulates discharges of dredged or fill material into all waters of the U.S.
