Good morning David,

As Ingram Barge considers the NTSB's party invitation, I would also like to request additional information from the company related to the accident. Through the US Coast Guard, we have gathered a majority of the evidence necessary to complete the investigation, but there are a few items we need:

- An overall side-view photo of the *Carol McManus*. This photo will appear at the beginning of the NTSB's report, along with a photo of the *Big D*. The image does not need to be a photo taken at the time of the accident we'd rather have a photo that presents an overall view of the vessel.
- Audio from Carol McManus "Blue Box" files @20230109010000_20230109020000_1578.avi,
 @20230109010000_20230109020000_2203.avi, @20230109010000_20230109020000_8656.avi. What I am really looking for here is the audio files for the VHF transmissions between the Carol McManus and Big D around 01:33AM (passing arrangements) and around 01:51AM (emergency). The files listed here should include audio from the Carol McManus's three VHF radios, but the files I received from the Coast Guard contained no audio, only video.
- Confirm or update cost of damages. The CG Form 2692 submitted for the accident estimated \$478K in damages to the barges in the *Carol McManus* tow. Request confirm that this estimate is still valid, or, provide an updated estimate of damages.
