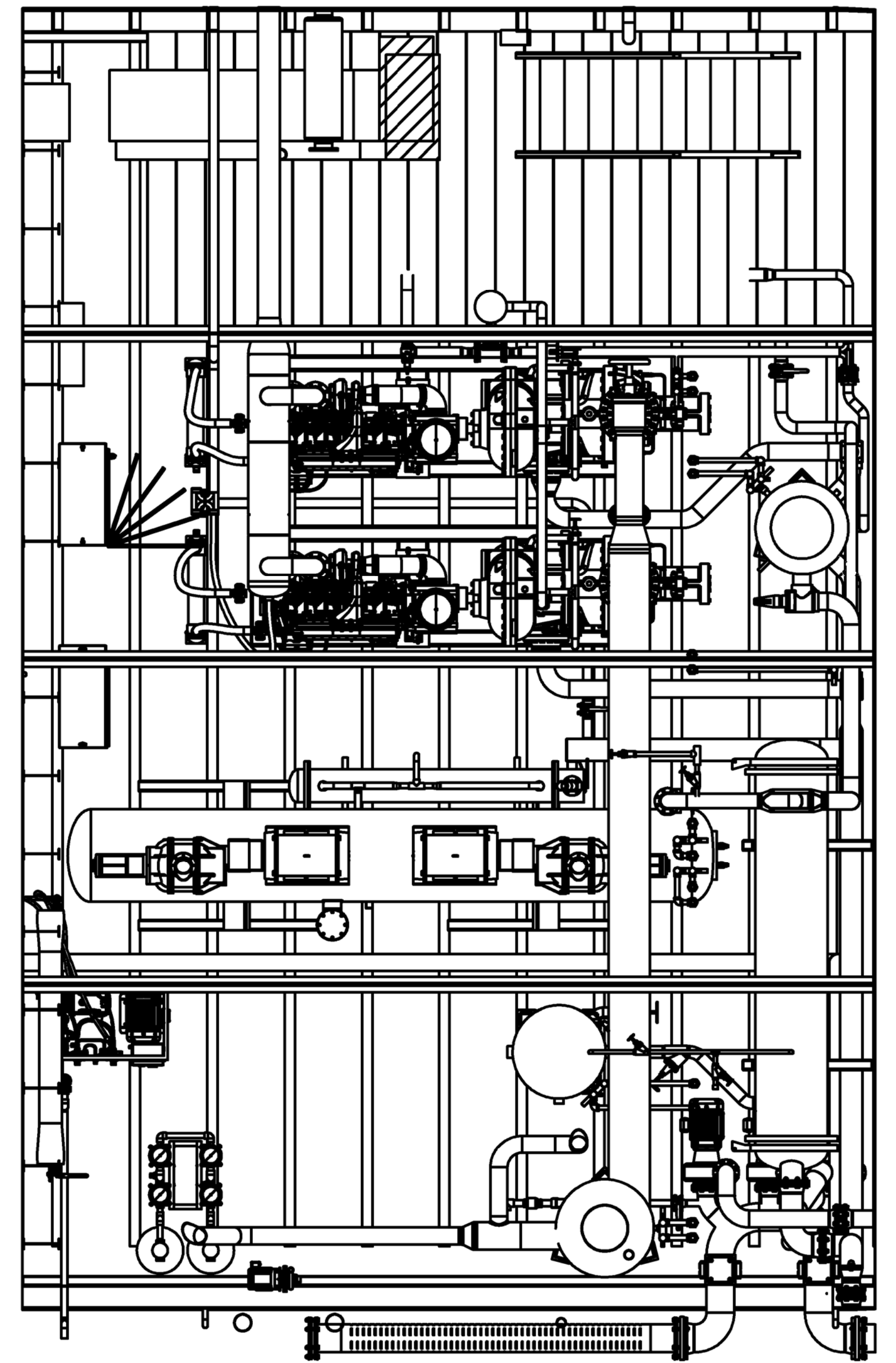
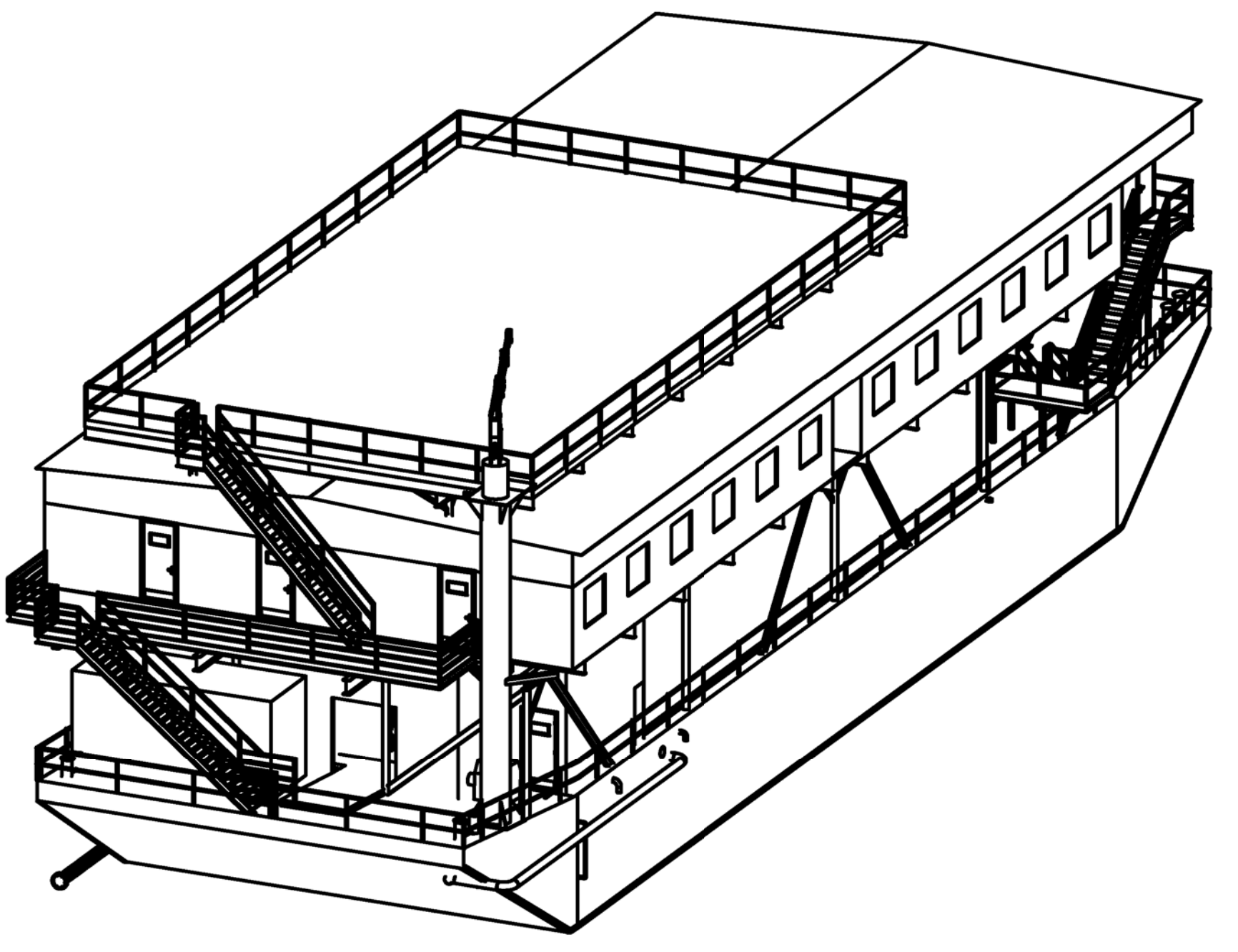
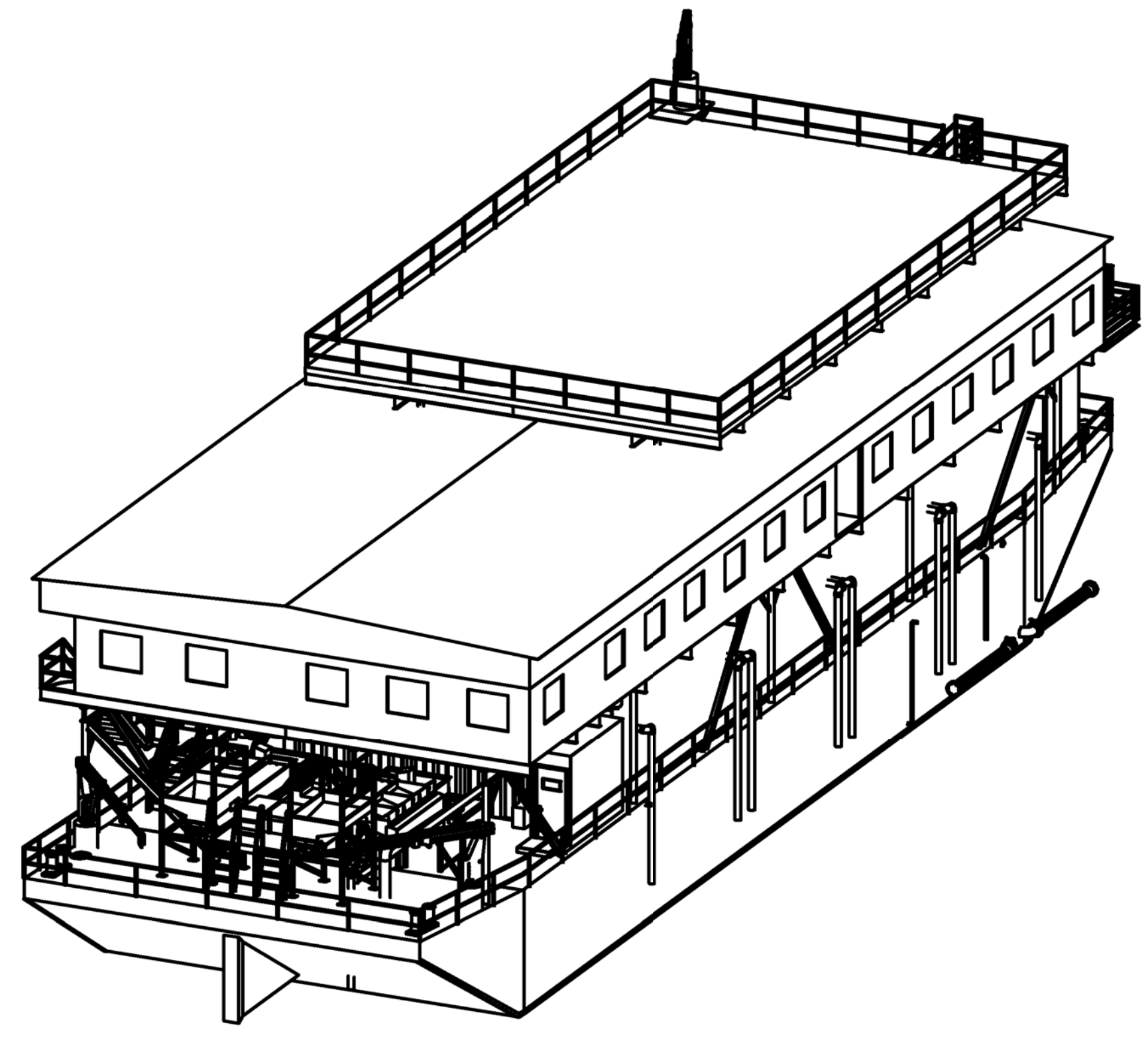
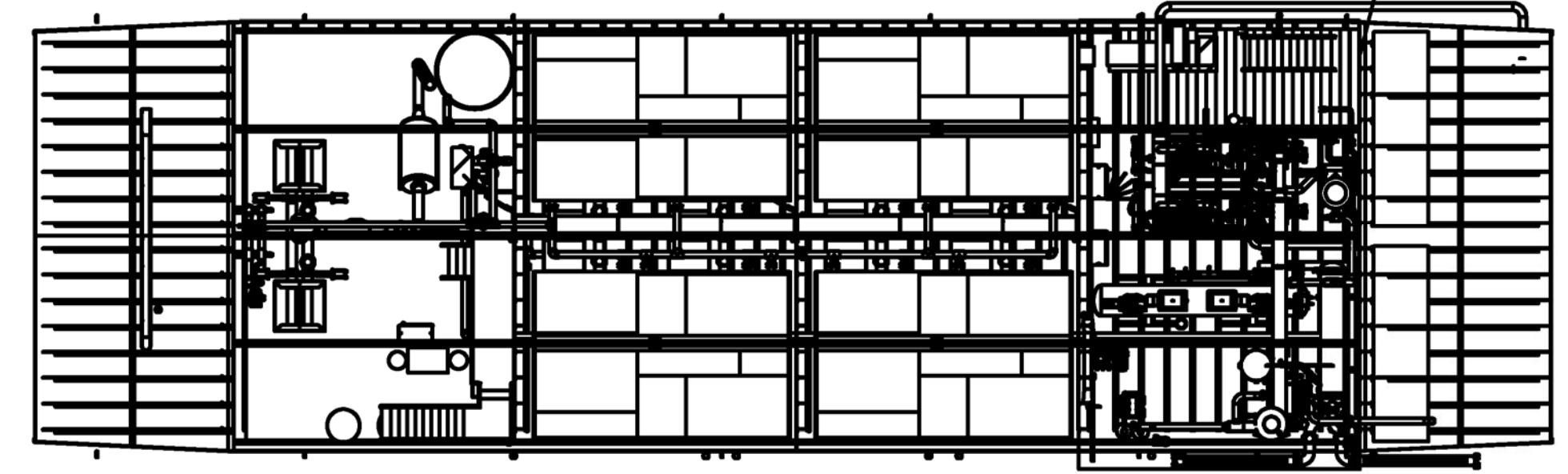
BERTHING DECK (APPROXIMATION ONLY)
