I want to thank Mr. Wayne for taking my call this afternoon regarding work performed onboard the ITV Desperado during the fall timeframe (Oct-Nov) of 2022.

The Coast Guard and I are requesting electronic copies of work order # M2215 reports and invoice no. 110580 for ITV Desperado owned by Mr. Warren Solleau. Please find attached a copy of your estimate from Sept 30th, 2022.

We are interested in determining if one of your employees installed a 1/2" Gates 8G1 wire braid hose on ITV Desperado's steering pump system. I have attached two photographs for Monday's follow-up discussion along with hose spec below.
