04:18 FWE, ALL FAST, 5+3 mooring lines FWD, 5+3 mooring lines AFT, starboard side alongside.

~~X~~14:00 Storm force wind with heavy rain in formation of tornado suddenly hit the vessel . Cargo operations are in progress with 2 cranes.

Vessel start moving away from the berth.

14:02 7-mooring lines broken FWD, 3-mooring lines parted AFT, St-by all crew nobody injured, Master on bridge

14:10 SBE, Drop both anchors, ME and bow thruster in use. Observed that spreader from crane number 5 fallen into the water with 1 container. Crane was working on bay 10.

Another spreader of crane number 6 stacks on bay 38

14:18 Report to All Stations on VHF 16, 67 to Keep clear of the vessel

Contacted with traffic control via VHF ch 67,

Coast Guard replied on the same ch67, received info that tug boats underway to the vessel.

14:24 Fwd tug boat made fast "Mardi Gras"

14:28 Aft tug boat made fast "Shiney V Moran"

14:50 1st POB on Board,

15:40 Tug boat "Lizzy B Moran" came to assist with mooring ropes

15:42 Sent two headlines Fwd

17:44 Vsl at present psn, awaiting shore team

18:34 Boat with shore team approaching, 5 persons came on board
19:00 Master and Pilot exchange information, intention to move the vsl ahead for 10 mtrs to release spreader
19:10 Tug boat "Lizzy B Moran" approach stern to Assist
19:13 Command: Slack all stern lines Aft, Slack springs Fwd
19:15 Vessel start moving ahead, Spreader fall on hatch cover, bay 38, Vsl stopped, all lines tight
