17	some time with you in the weekend, I just wanted to make sure that
18	we had an idea of when her wake times and her sleep times were in
19	the few days prior to the crash.
20	A. Sure.
21	Q. Okay. So did was it Friday night that she spent with you?
22	A. Yes, yes. Most of the weekend, yes.
23	Q. Okay. We got from her daughter what time she usually wakes
24	up is 5:30 for Friday. Can you give me an idea around what time
25	she went to be on Friday night?

2	worked with some of the colts. We just kind of hung around home
3	basically that morning, and first part of the afternoon. Later in
4	the day the saddle club that we belong to, a horse club, they had
5	a one of our get-togethers that they have every year. We went
6	to that, and just kind of group gathering, and went out to eat. I
7	don't know, we probably got home, I don't even remember what time
8	it would have been Saturday evening; probably, again, probably
9	10:30 or 11, maybe would have been a little later than that.
10	Q. All right.
11	A. Sunday morning we didn't really get up very early again, you
12	know, about 7 or 7:30. I can't remember for sure. It might have
13	been a little earlier. Just kind of done the same thing, you
14	know, fed horses, and kind of worked with some horses. Late
15	Friday or late Sunday afternoon, we went to some friends of
16	mine. They had a fish fry or fried some fish. Again, we were
17	probably home by 8 o'clock.
18	Q. Okay. Did she spend the night with you Sunday night?
19	A. Yes, she did.
20	Q. And then what time did you guys sleep in?
21	A. She usually gets up on the days that she works she usually
22	gets up around 4:30. That's her usual work time. I think she
23	left my house around quarter 'til five which was, you know, she
24	has to be at work there at the bus barn fairly early. She always
25	allows herself plenty of time. Usually 4:30 was her wake up time

2 Q. How about like Sunday night then, what time did she go to 3 bed?

4 A. We went to bed, you know, come to think about it we were both5 tired. 9:30 maybe.

6 Q. 9:30.

7 A. I don't -- I'm pretty sure it wasn't even 10 o'clock. It was 8 we did go to bed early because I was exhausted too and she was. 9 And so it's not like we were -- yeah, I know, I remember we to bed 10 (indiscernible) just because we were tired, and she had to, you 11 know, had to work the next day, and I had things to do too. 12 So --

Q. One of the things that Michelle had mentioned to us is that she had been, I guess, diagnosed with lupus somewhat recently.

15 A. Yeah. I did know about that.

16 Q. Did you -- I forgot, was it like a week only since she was 17 diagnosed?

18 A. No. It would have been longer than that.

19 Q. Longer?

20 A. It was before I got to know her that she was diagnosed as I21 remember.

- 22 Q. Okay. How long have you known her?
- 23 A. I've known her since last summer.
- 24 Q. Okay.

25 A. I started knowing her a lot better last fall, late fall.

Q. Had she been experiencing -- because Michelle had mentioned
 that she's experiencing migraines.

3 A. Yes, she was.

4 So since you've known her she's been experiencing migraines? Q. 5 Α. Yes. And, actually, it was from a -- she had a previous 6 accident, and it wasn't a vehicle accident or anything. I think 7 it was a work-related or something. But she, she had to have some 8 neck surgery and stuff, and she had been having some issues with 9 the neck pain, and she actually had a doctor's appointment that 10 afternoon because she had taken the afternoon off, and was going 11 to the doctor here in Rushville, and he was -- had some kind of 12 treatment thing he was going to give her. I don't remember 13 exactly what it was for sure, but she had been going to a doctor 14 about her neck pain. So do you think the, the neck pain and -- well, I guess the 15 Q. 16 lupus and the neck pain are, are sort of totally different but --17 Yes. Α.

18 Q. Do you know what -- which doctor she was going to in 19 Rushville?

20 A. You know, she told me, but I don't -- I had never heard of21 the guy.

A. I remember her saying it was right there by the hospital across the road. I think it would be to the, the east there's a clinic right across the road from the hospital in Rushville, and

8	migraine. Do you know if she was experiencing that prior to a
9	migraine?
10	A. No, not that I know of. I mean, she would tell me sometimes
11	that she had a headache, but I couldn't really tell any
12	difference. She just, you know, she wasn't acting any different.
13	Her activities wasn't any different. I've had friends that have
14	had migraines before. They get where they, you know, couldn't
15	even really do anything.
16	A. Yeah.
17	Q. And I'd never seen her, I'd never seen her have a migraine
18	like that when she was with me. She'd mention, you know,
19	headaches but once in a while. And but as far as a migraine that,
20	you know, she was really so bad she had to go lay down or
21	anything, she never had anything like that around me.
22	Q. Was she experiencing other symptoms? Or was she like having
23	like some sort of life events or stressors at the time of or
24	around the time of the crash?
25	A. None that I know of at all. She just was always in a very

8	morning. Just the same as usual. She was going to work, and she
9	was supposed to come back up to my house around noon when she got
10	off and, you know, never showed up.
11	Q. Yeah. So with her, her neck fusion you said that she was
12	feeling, she was feeling a lot of pain, and she was going to be
13	seeing a doctor. Did you notice any limitations in her movement
14	because of the because of that?
15	A. No, I really didn't. Because she would help me feed horses
16	and carry buckets of feed, and throw hay over to them, carry hay.
17	I never, never ever noticed her having any issues that way.
18	Q. Okay. I know this lupus it's very, you know, like it's
19	very individualistic what sort of symptoms people experience. I
20	guess she never complained about visual, vision problems.
21	A. No.
22	Q. Okay.
23	A. No, never has. I know she wore glasses. She wore contacts
24	most of the time, and glasses when she took her contacts out at
25	night and stuff, you know, but never noticed any she never

9 A. No. I don't think so. I mean, she love her job. She always 10 loved kids, and, and I do remember her saying something about 11 there was one parent that was kind of inappropriate or whatever, 12 but that had, that had been some time ago, I think.

A. And sent her different texts or something that were kind of,
I don't know, suggestive or something like that she was upset
about.

17 When she, I quess, when she woke up was she usually just --Q. 18 did she ever like feel like or did she seem like she was drowsy 19 or, or anything like that after waking up? Or do you think that 20 she had a, you know, she had pretty good sleep after waking up? 21 Yeah. She always seemed to. She would wake up, and pop Α. 22 right up, and be in a happy mood. I always kind of envied her for 23 that because I was always kind of grouchy when I first got up. 24 But she would just, yeah, she'd wake right up, and be in a good 25 mood, and full of energy it just seemed like.

21	Michelle had mentioned that she took vitamins, and also was
22	getting injections for the migraine. Do you know if she was
23	taking any other medications besides that?
24	A. Not that I know of. I never did see her take anything. I
25	mean, I seen her take I don't know whether it was for the
