SUBJ VSL RPTS THEIR POSN TO BE IN PLATTS HARBOR, NORTH SIDE OF SANTA CRUZ ISLAND. THE FIVE POB THAT ABANDONED SHIP ARE NO ON BOARD THE M/V GREAT ESCAPE THAT IS ALSO ANCHORED INSIDE PLATTS HARBOR APPROX 500 FEET AWAY FROM THE BURNING BOAT. ISSUED UMIB. INITIATED CIC.
