If your accident/incident occurred in Ohio, Michigan, Indiana, Wisconsin, Illinois, Minnesota, Iowa, Missouri, Arkansas, Louisiana, North Dakota, South Dakota, Nebraska, Kansas, Oklahoma, Texas, Colorado, or New Mexico, send the form to: NTSB, CEN, 4760 Oakland Street, Suite 500, Denver, CO 80239.

If your accident/incident occurred in Montana, Wyoming, Idaho, Utah, Arizona, Nevada, Washington, Oregon, California, Hawaii, or the territories of Guam or American Samoa, send the form to: NTSB, WPR, 505 South 336th Street, Suite 540, Federal Way, WA 98003.

If your accident/incident occurred in Alaska, send the form to: NTSB, ANC, 222 West 7th Avenue, Room 216, Box 11, Anchorage, AK 99513.

Rules pertaining to notification of aircraft accidents and incidents, as well as overdue aircraft are found in 49 Code of Federal Regulations (CFR) Part 830 http://www.ecfr.gov/cgi-bin/text-idx?c=ecfr&tpl=/ecfrbrowse/Title49/49cfr830_main_02.tpl. These rules state the authority of the NTSB, define accidents, incidents, injuries, and other terms, and provide procedures for initial and immediate notification of accidents and incidents by aircraft pilots/operators.

A. APPLICABILITY

The pilot/operator of an aircraft shall send a report to the office listed above, based on accident/incident location; immediate notification is required by 49 CFR 830.5(a). **The report shall be filed within 10 days after an accident for which notification is required by Section 830.5, or after 7 days if an overdue aircraft is still missing.**

An aircraft accident, as defined in 49 CFR 830.2, is determined as an occurrence that involves a fatality or serious injury, or substantial damage to the aircraft. For occurrences that do not involve a fatality, the determination that the occurrence is an accident can be appealed by writing to the Director, Office of Aviation Safety, NTSB, 490 L'Enfant Plaza, S.W., Washington, D.C. 20594.

INSTRUCTIONS TO PILOTS/OPERATORS FOR COMPLETING THIS FORM

It is necessary that ALL questions on this report be answered completely and accurately.

If more space is needed, continue on a blank sheet of paper.

Nearest City/Place: Use the name of the nearest community in the state where the accident/incident occurred.

Date/Time: Indicate the date and local time of the event. Be sure to indicate the time zone.

Phase of Operation: Indicate the phase of operation during which the accident/incident occurred.

Aircraft Information: Enter aircraft make and model information as indicated on the aircraft registration certificate, including series. If the involved aircraft is certified as "amateur-built," include the name of the producer of the kit or plans, unless an NTSB employee instructs otherwise.

Maximum Gross Weight: Enter the certificated maximum gross weight for the aircraft involved in the occurrence. This should be the same as the maximum gross weight indicated on the aircraft weight and balance documents.

Engine: Enter engine make and model information as indicated on the engine data plate.

The NTSB uses this form for aircraft accident prevention activities and for statistical purposes. NTSB regulations (49 CFR Part 830) require that **ALL** questions be answered **completely** and **accurately**. Completion of this form will take approximately 60 minutes. The NTSB does not guarantee the privacy of any information provided in this form. You need not complete this form unless it displays a valid OMB control number, in accordance with 5 C.F.R. § 1320.5(b), which applies to this collection of information.

B. DEFINITIONS

1. "Aircraft Accident" means an occurrence associated with the operation of an aircraft that takes place between the time any person boards the aircraft with the intention of flight and all such persons have disembarked, and in which any person suffers death, or serious injury, or in which the aircraft receives substantial damage. For purposes of this form, the definition of "aircraft accident" includes "unmanned aircraft accident," as defined at 49 CFR 830.2.

2. "Substantial Damage" means damage or failure that adversely affects the structural strength, performance or flight characteristics of the aircraft, and that would normally require major repair or replacement of the affected component. NOTE: Engine failure or damage limited to an engine if only one engine fails or is damaged, bent fairing or cowling, dented skin, small puncture holes in the skin or fabric, ground damage to rotor or propeller blades, and damage to landing gear, wheels, tires, flaps, engine accessories, brakes, or wing tips are not considered "substantial damage" for purposes of this report.

3. "Operator" means any person who causes or authorizes the operation of an aircraft, such as the owner, lessee, or bailee of an aircraft.

4. "Fatal Injury" means any injury that results in death within thirty (30) days of the accident.

5. "Serious Injury" means any injury that (1) requires hospitalization for more than 48 hours, commencing within 7 days from the date the injury was received; (2) results in a fracture of any bone (except simple fracture of fingers, toes, or nose); (3) causes severe hemorrhages, nerve, muscle, or tendon damage; (4) involves injury to any internal organ; or (5) involves second- or third-degree burns, or any burns affecting more than 5 percent of the body surface.

Type of Fire Extinguishing System: If a fire extinguishing system was used to fight an aircraft fire, specify the type(s) of extinguishing system(s) used. Examples include handheld extinguisher, engine fire bottle, cargo/baggage compartment fire suppression system, or airport emergency ground equipment.

Owner/Operator Information: Enter the owner information as shown on the registration certificate. Commercial operators, enter the operator information, including "doing business as" when applicable, as shown on the operator certificate.

Revenue Sightseeing Flight: Indicate whether the accident aircraft was conducting revenue sightseeing operations under 14 CFR Part 91 at the time of the accident.

Air Medical Flight: Indicate whether the accident flight was being conducted for the purpose of carrying medical personnel, patient(s), or organs.

Public Aircraft: Federal, state or local government flight operations such as official travel, law-enforcement, low-level observation, aerial application, firefighting, search and rescue, biological or geological resource management, or aeronautical research. Indicate whether the flight was conducted by the armed forces, federal, state, or local government.

Purpose of Flight: 14 CFR Parts 91, 103, 133, 136, and 137: Indicate the type of operation that was being conducted at the time of the occurrence using the following definitions:

AERIAL APPLICATION--Operations using an aircraft to perform aerial application or dispersion of any substance. Examples include agricultural, health, forestry, cloud seeding, firefighting, insect control, etc.

AERIAL OBSERVATION--These flights include aerial mapping/photography, patrol, search and rescue, hunting, highway traffic advisory, ranching, surveillance, oil and mineral exploration, criminal pursuit, fish spotting, etc.

AIR DROP--Aerial operations, other than aerial application, that are intended to release items in flight.

AIR RACE/SHOW--Includes any flight operations conducted as part of an organized air race or public demonstration.

BUSINESS--includes all personal flying without a paid professional crew for reasons associated with furthering a business, including transportation to and from business meetings or work. This does not include corporate/executive operations, air taxi, or commuter operations.

EXECUTIVE/CORPORATE--Company flying with a paid, professional crew.

FERRY--Non-revenue flight under a special flight or "ferry" permit. Refer to 14 CFR 21.197 for details of special flight permit issuance.

FLIGHT TEST--Flight for the purpose of investigating the flight characteristics of an aircraft/aircraft component or evaluating an applicant for a pilot certificate or rating.

INSTRUCTIONAL--Flying while under the supervision of a flight instructor or receiving air carrier training. Personal proficiency flight operations and personal flight reviews, as required by federal air regulations, are excluded.

OTHER WORK USE--Miscellaneous flight operations conducted for compensation or hire such as construction work (not 14 CFR Part 135 operation), parachuting, aerial advertising, towing gliders, etc.

PERSONAL--Flying for personal reasons (excludes business transportation) including pleasure or personal transportation. This also includes practice or proficiency flights performed under flight instructor supervision and not part of an approved flight training program.

POSITIONING--Non-revenue flight conducted for the primary purpose of relocating the aircraft. Examples include moving the aircraft to a maintenance facility or to load passengers or cargo etc.

UNKNOWN--Use only if the primary purpose of flight is not known.

Other Aircraft--Collision: For all accidents involving a collision with another aircraft, including parked aircraft, check "Collision with other aircraft" under Basic Information and complete this section indicating details about the OTHER aircraft involved in the collision.

Airport Information: Complete this section if the accident/incident occurred on approach, landing, takeoff, departure, or within 3 statute miles of an airport. Please refer to the FAA Airport/Facility Directory or other official source for airport information.

Airport Identifier: Provide the official 3 or 4 character airport identifier number.

Runway: Indicate the number of the runway used, including L, R, or C if applicable.

Runway/Landing Surface: Indicate the type of intended runway/landing surface (do not indicate surface conditions). If the surface type was mixed, check all that apply.

Condition of Runway/Landing Surface: Indicate the condition of the intended runway/landing surface. If multiple conditions existed at the time of the accident, check all that apply.

Weather Information at the Accident/Incident Site: Indicate the weather conditions reported at the accident/incident site at the time of occurrence. If no weather reporting was available for the accident/incident site, indicate the reported conditions at the nearest reporting site. Specify the weather reporting site identifier, the observation time, and distance from the accident/incident.

Sky/Lowest Cloud Condition: Indicate the height above ground level of the lowest cloud condition present at the time of the accident/incident and whether coverage was reported as few, scattered, broken or overcast. Also indicate the height above ground level and coverage of the lowest cloud ceiling present at the time of the accident/incident (reported as broken or overcast).

NOTAMs (D and FDC), AIRMETs, SIGMETs, PIREPs: Describe all NOTAMs (distant (D) or Flight Data Center (FDC), if known), AIRMETs, SIGMETs, and PIREPs in effect near the accident/incident.

Flight Crewmember Information: Indicate the category that best describes the capacity served by this flight crewmember at the time of the accident. The designators "Flight Crewmember 1" and "Flight Crewmember 2" do not refer to a specific pilot position or responsibility. If more than one pilot is aboard, they may be entered in any order and their capacity entered as appropriate.

Degree of Injury: See Definitions on the top half of Page 1 of the instructions. Minor injury is not defined. If an injury does not meet the criteria for another injury category, select Minor.

Date of Last Flight Review or Equivalent: Enter the date of the most recent flight review, or equivalent, completed by this pilot. Refer to 14 CFR 61.56 for accepted equivalents.

Type Ratings: List all type ratings on the pilot certificate. If the pilot holds no type ratings indicate "none." If the pilot holds a pilot certificate other than student and was flying an aircraft requiring an endorsement, enter the type and date of any logbook endorsement(s) for that aircraft. See 14 CFR 61 for examples of required endorsements.

Student Endorsements: If the pilot holds a student pilot certificate, enter all solo endorsements and dates on the student pilot certificate.

Flight Time: Complete the flight time matrix. Solo flight time should be included as "Pilot-in-Command (PIC)" and all dual flight instruction given should be included as "Time as Instructor."

Additional Flight Crewmembers: Complete this section if there were more than two required flight crewmembers on the aircraft. This also includes a check airman performing official duties but does not include cabin crew. State the capacity served by each included crewmember at the time of the accident.

Passenger(s)/Other Personnel: Enter identification and injury severity information for all passengers, cabin crew, and other personnel involved in the accident. See Page 1 of the instructions for the official definition of injury levels.

Several questions throughout the form allow for multiple responses; when appropriate, choose all responses that apply.

These instructions only pertain to major issue areas covered by NTSB Form 6120.1 Pilot/Operator Aircraft Accident/Incident Report. For additional definitions of questions and responses, please refer to www.nts.gov.

NARRATIVE REPORT FOR ACCIDENT INVOLVING AIRPLANE N9721Q

ON JUNE 24TH 2023, I ARRIVED AT SCOTT CITY MUNICIPAL AIRPORT (KTQK). I NOTICED ACTIVITY OF A HELICOPTER, AG SPRAY AIRPLANE AND ANOTHER PRIVATE AIRPLANE ABOUT THE AIRPORT. I WENT INSIDE MY ENCLOSED HANGER. I PERFORMED A FUEL TEST. NO WATER WAS FOUND. A WEEK BEFORE I HAD DONE A PREFLIGHT INSPECTION AND FULL RUN-UP AS PART OF KEEPING THE AIRPLANE OPERATIONAL. I USUALLY LET THE ENGINE IDLE 10 MINUTES. I ALSO VARY THE RPMs DURING THESE TIMES. I AM THE ONLY ONE WHO HAS A KEY TO THE DOOR LOCK. I ALSO NOTICED MY HIDDEN DOOR OPENED INDICATOR WAS NOT DISTURBED SO I KNOW NO ONE HAD BEEN IN THE HANGER. I TOWED MY AIRPLANE TO THE FUEL ISLAND. I MADE CONTACT WITH THE FBO LINE OPERATOR NAMED, WARREN. HE TURNED ON THE PUMP AND I PUMPED THE FUEL. I PUMPED 17.16 GALLONS OF 100LL AVIATION FUEL. I RECEIVED A RECEIPT WHICH INDICATES THIS AND THE TIME OF 8:52AM. THIS PUT THE FUEL QUANTITY AT 30 GALLONS AT 15 GALLONS PER WING. I PLANNED ON A FUEL STOP AT HAYS REGIONAL AIRPORT (KHYS). FROM THERE I PLANNED ON GOING TO CLAY CENTER KS (KCYW). I ESTIMATED THE AIRPLANE TO WEIGH APPROXIMATELY 1925 POUNDS. THE MAXIMUM TAKEOFF WEIGHT FOR MY AIRPLANE IS 2000 POUNDS. I REVIEWED THE CHECKLIST AND STARTED THE AIRPLANE. IT STARTED RIGHT UP AFTER IT WAS PRIMED TWICE. I LET IT IDLE AT APPROXIMATELY 600 RPM. A FEW MINUTES LATER AFTER THE AIRPLANE WAS CONFIGURED TO FLY AND I WAS SETTLED, I STARTED TO TAXI. I NOTICED AN AG SPRAY AIRPLANE APPROACHING THE TAXI WAY HEADED TO THE RUNWAY ENTRANCE. I STOPPED AND LET HIM TAKE LEAD AS HE WAS WORKING AND I WAS ON A PLEASURE FLIGHT. I WAITED WHILE HE BACK TAXIED TO RUNWAY 35. I WAITED TIL HE WAS AIRBORN AND CLEAR OF THE RUNWAY. I THEN RADIOED MY INTENTION TO BACK TAXI FOR RUNWAY 35. I TAXIED TO THE BEGINNING OF RUNWAY 35 AND RUN-UP AREA. I PERFORMED AN ENGINE RUN-UP, MAG CHECK, VACUUM CHECK, AND CARB HEAT CHECK. MY THOUGHT WAS THAT EVERYTHING CHECKED OUT. I REVIEWED MY CHECKLIST WITH THE INTENTION OF TAKING OFF. I THEN HAD A THOUGHT THAT I FORGOT A FEW ITEMS I WANTED TO TAKE. I DID NOT LIKE SITTING ON THE RUNWAY LOOKING FOR ITEMS SO I RADIOED ON THE CTAF FREQUENCY THAT I WAS ABORTING MY TAKEOFF AND RETURNING TO THE FBO. I TAXIED BACK TO THE FBO RAMP. I EXITED THE RUNWAY AND TAXIED TO THE NORTH RUNWAY ENTRANCE. I FOUND THE ITEMS I WAS LOOKING FOR. I RADIOED MY INTENTION TO BACK TAXI FOR RUNWAY 35. I GAVE IT THROTTLE TO GET THE AIRPLANE ROLLING. I BACK TAXIED TO THE BEGINNING OF RUNWAY 35. I MADE A U-TURN ON THE RUNWAY AND LINED UP ON THE CENTER LINE.

I PUSHED THE THROTTLE IN, APPLIED RIGHT RUDDER. THE AIRPLANE STARTED TO ROLL. I NOTICED THE ENGINE TACH RPM WAS INCREASING AND THE AIRSPEED INDICATOR WAS ALIVE. I CONTINUED DOWN THE CENTER LINE. EVERYTHING SEEMS NORMAL. I SAY NORMAL, SINCE I AM THE SOLE OWNER OF THIS AIRPLANE AND ONLY ONE WHO FLYS IT. I ROTATED THE AIRPLANE AT APPROXIMATELY 60 MILES AN HOUR. THE AIRPLANE LIFTED OFF THE RUNWAY

AND WAS CLIMBING. IT WAS AT THIS TIME I NOTICED THE ENGINE TACH SPEED SEEMED TO BE STALLED AT APPROXIMATELY 2200RPM. I BELIEVE I CHECKED ON THE THROTTLE TO MAKE SURE IT PUSHED ALL THE WAY IN. I CHECKED THE RUNWAY LENGTH AHEAD OF ME AND ESTIMATED I WAS JUST SHY OF MIDFIELD. I CONTINUED TO FLY AS THE AIRPLANE WAS IN A SLOW CLIMB. I MADE A GRADUAL RIGHT TURN TO THE NORTHEAST. I WAS HEADED TO HAYS KS (KHYS) AND ASSUME IT WAS HABIT TO HEAD THAT DIRECTION. LOOKING OUT THE WINDOW I NOTICED I WAS STILL IN A SHALLOW CLIMB AT THIS TIME. I LOOKED AT THE ENGINE TACH AND IT STILL SEEMED TO BE STALLED AT 2200RPM. I LOOKED AT THE ALTIMETER AND IT WAS AT APPROXIMATELY 3500 FT. MSL. THAT MADE ME APPROXIMATELY 500FT AGL. AT THIS TIME I ESTIMATE I WAS HALF A MILE NORTHEAST OF THE RUNWAY. I NOTICED THE TRIM ADJUSTMENT WAS WITHIN REASON. I WAS SLIGHTLY PULLING BACK ON THE YOKE. THE CLIMB RATE WAS NOT AS IT USUALLY IS. I AM USED TO THE AIRPLANE EASILY PERFORMING 500 FT OR A MINUTE OR BETTER. THE RATE OF CLIMB APPEARED TO BE APPROXIMATELY 200 FT A MINUTE AT THIS TIME. THE TAKEOFF WEIGHT OF THE AIRPLANE WAS CLOSE TO WHAT I USUALLY FLY. THE PERFORMANCE OF THE AIRPLANE WAS NOT RIGHT SO I MADE THE DECISION TO HEAD BACK AND LAND. I DID NOT MOVE THE THROTTLE AS I STILL HAD POWER AND WAS AT A LOWER ALTITUDE. I DECIDED TO ENTER INTO A STANDARD LEFT TRAFFIC PATTERN TO LAND. I MADE A WIDE SHALLOW LEFT U-TURN AND HEADED SOUTHWEST BOUND. I NOTICED AN AIRPLANE ON A BACK TAXI FOR RUNWAY 35. I DECIDED TO CUT ACROSS THE NORTHWEST CORNER OF THE AIRFIELD. I MADE ANOTHER SHALLOW LEFT TURN TO ENTER A LEFT DOWNWIND APPROACH. THIS PUT ME ON THE WEST SIDE OF THE ROAD HEADING SOUTHBOUND. AS I WAS LOOKING OUT THE WINDOW I FELT I WAS LOSING ALTITUDE, HOWEVER I DO NOT RECALL LOOKING AT THE ALTIMETER AT THIS TIME. I THEN RADIOED ON CTAF THAT I WAS IN AN EMERGENCY, NEEDED RUNWAY 35 AND THAT THERE WAS AN AIRPLANE ON IT. I HEARD A RESPONSE BUT IT DID NOT COME IN CLEAR. I THEN REMEMBER CHECKING MY AIRSPEED AND KNEW I NEEDED TO KEEP IT ABOVE 60 MPH. I WAS EXTREMELY COGNITIVE OF NOT GETTING INTO A STALL SITUATION. I LOOKED AGAIN AND SAW THE AIRPLANE WAS STILL ON THE RUNWAY. I AGAIN RADIOED THAT I NEEDED RUNWAY 35 AND THERE WAS AN AIRPLANE ON IT. I HEARD A RESPONSE THAT IT WAS WORKING ON CLEARING. I DECIDED TO TRY TO EXTEND MY DOWNWIND IN HOPES TO GIVE TIME FOR THE RUNWAY TO CLEAR. AT THIS TIME I BELIEVE I WAS JUST ABEAM OF THE SEWER POND. WHEN I WAS ABEAM OF THE END OF THE RUNWAY, I THOUGHT I WAS LOSING ALTITUDE AND POWER. I DECIDED I SHOULD NOT CONTINUE THE DOWNWIND. I MADE A SHALLOW LEFT TURN TO TRY TO GET INTO A LEFT BASE POSITION. I WAS BARELY INTO THE TURN WHEN I PULLED BACK ON THE YOKE TO MAINTAIN ALTITUDE WHEN I KNEW I WAS LOSING ALTITUDE FAST. IT WAS AT THIS INSTANT I KNEW I WAS GOING TO CRASH. I TURNED THE YOKE TO NEUTRAL AND PUSHED THE YOKE FORWARD. THE WINGS WENT LEVEL. I SAW THE GROUND WAS COMING UP FAST SO I PULLED BACK ON THE YOKE HOPING TO FLAIR. IT WAS NOT JUST MOMENTS LATER THE RIGHT WHEEL HIT THE ROAD. THAT

CONTACT PUT ME IN A LITTLE BIT OF A CRAB ANGLE. I BOUNCED INTO THE ROAD DITCH AND SLID INTO A CORN FIELD. THE PLANE MADE A BELLY LANDING WITHOUT FLIPPING ON ITS TOP. I SAT THERE A FEW MOMENTS COLLECTING MY THOUGHTS. I SMELLED FUEL SO I EXITED THE AIRPLANE THROUGH THE DOOR. IT HAD POPPED OPEN. I WALKED AWAY FROM THE AIRPLANE. AFTER A FEW MOMENTS OUTSIDE THE AIRPLANE, I WALKED BACK TO IT AND REACHED INTO THE AIRPLANE AND SHUT OFF THE MASTER SWITCH AND MAGNETOS. I THEN STARTED TO LOOK FOR MY PHONE. I THEN HEARD SIRENS. THE AMBULANCE, FIRE DEPARTMENT AND POLICE ARRIVED. OVER A PEIOD OF TIME THE FOLLOWING HAPPENED: THE FIRE CHIEF UNHOOKED THE START BATTERY AND I ADVISED HIM THE ELT BATTERY SHOULD BE UNHOOKED SO IT WAS NOT TRANSMITTING SINCE THEY WERE ALREADY HERE. HE MOVED THE FUEL SWITCH FROM THE LEFT TANK TO THE OFF POSITION. SCOTT CITY POLICE OFFICER B. DAVIDSON HANDED ME HER PHONE AND SAID IT WAS DENVER CENTER. I BELIEVE HER NAME WAS JESSICA. SHE WAS JUST CONFIRMG THE ACCIDENT. I ALSO RECEIVED A CALL FROM TIMOTHY CHANAY WITH THE FAA. A KANSAS HIGHWAY PATROL OFFICER ARRIVED. MR CHANAY CALLED ME A SECOND TIME AND ADVISED ME I COULD REMOVE THE AIRPLANE. HE ASKED I TRY NOT TO DISTURB THE ENGINE. I MADE PHONE CALLS TO A FRIEND. HE WAS BRINGING A SKID STEER AND A TRAILER. I ADVISED THE FIRE DEPARTMENT I WAS GOING TO CUT OFF THE WINGS SO I COULD MOVE IT. HE ASKED IF I WANTED TO FIRE DEPARTMENT TO DO IT. THE FIRE DEPARTMENT REMOVED THE WINGS. I PUT THE AIRPLANE IN MY HANGER AND SECURED IT.

THERE ARE POSSIBLE WITNESSES, THE AIRPLANE ON THE RUNWAY AND THE FBO OPERATOR. THERE IS HEARSAY THERE WAS BLACK SMOKE COMING FROM THE AIRPLANE EXHAUST. I GAVE THIS INFORMATION TO FAA INSPECTOR DAVE GOBBLE.
