- 1. The verbal contract for the Core of Engineers and Better by Design started around June 7, 2022 for the hauling of Shot Rock to a Levee project to repair levees from the flood on the Garden of Eve Levee, to my best knowledge we had hauled around 56 loads of shot rock to the designated area that was provided by Core of Engineers and Better by Design before the accident. I had only been over the crossing once in my life during the Pre-Job meeting and designated road that are trucks where designated to take for the hauling of shot rock.
- 2. Was a Verbal Contract with Better by Design, they would have the original contract between them and the Core for the project, but I have not been able to access the contract at this time.
- 3.I received Verbal Instructions on route and also was driven bye the Core and Better by Design the route to use for the Shot Rock Delivery, It was determined that we could not safely turn a loaded truck into access road from county road 122 and Porche Praire Ave. The Corner was too tight to make the turn down the Levee with farmers gates lock down county road 122. Porche Praire Ave was the road MS Contracting, LLC was Verbal Instructed to use and was also driven on the day of the Pre-Job Meeting. Porche Praire Ave is also the road that was designated to use for the Pre-Inspection by the Core of Engineers.

- 3. Indicate if the route was specified in the contract with an accompanying map or whether you received verbal instructions on the route to use.
