Hi Erin,

I'm not sure if you were able to watch our Board Meeting on the San Pedro Bay pipeline accident last week. Our Board voted on a recommendation to all PHMSA-regulated pipeline owners and operators to develop and implement a PSMS based on API RP 1173. This was a recommendation that was proposed by Chair Homendy during the meeting and I'm now doing some research to help develop the supporting text.

I know that AGA's Board voted for all AGA members to implement a PSMS program, and I'm not sure if APGA members have made a similar commitment. Whether APGA made such a commitment or not, I'm sure that many of your member companies have voluntarily implemented PSMS. I'm trying to determine if there's a list of APGA members that already have such a program (by PHMSA OPID and parent company if possible).

I will try to narrow down the list of safety recommendation recipients to only those companies that



A safety management system is a systematic approach to managing safety. Embedded in a SMS are the overarching structures, policies and procedures an organization uses to direct and control its activities. In many situations, pipeline operators already have these elements implemented and Pipeline Safety Management Systems (PSMS) offers a framework to continuously improve these programs.

One of the elements of a safety management system that is essential to safe operations is a commitment by management.

Whereas: Safety is the highest priority of APGA members; and

Whereas: public gas systems have an excellent safety record; and

Whereas: the basic elements of pipeline safety management systems are applicable to systems of all sizes and can assist operators in identifying areas where pipeline safety performance can be enhanced; and

NOW, THEREFORE, BE IT RESOLVED: that APGA members are committed to continuing to enhance pipeline safety through the following Safety Management System elements:

- 1. Promoting a positive safety culture within our system.
- 2. Communicating and educating our employees, contractors, and the public regarding pipeline safety.
- 3. Implementing processes and actions that reduce risk and maintain the integrity of our pipeline assets.
- 4. Developing and maintaining safe work practices.
- 5. Investigating incidents and near-misses on our pipeline system in an effort to identify and implement corrective actions moving forward.
- 6. Verifying that existing operations and safety practices are improving pipeline safety.
- 7. Reviewing our system's safety performance to determine if additional actions are necessary to improve pipeline safety.
- 8. Responding effectively to pipeline incidents.
- 9. Ensuring that our personnel and our contractors are competent in performing all tasks that impact the integrity of our system.
- 10. Maintaining documentation needed to ensure pipeline safety.

Hey Sara, so circling back after discussing with our Pipeline SMS lead Sam Minifie who I have cc'd on the email.

So, as far as API member companies and are tracking specific to SMS and RP 1173 being in place, we stopped tracking at the company-level around 2019. However, <u>API's Energy Excellence</u> program includes the 10 SMS Program Elements and requires all members to commit to these principles as an expectation of API membership. As you know INGAA and AGA have similar Board-level commitments. For more information specific to our API Energy Excellence program I am including Alexa Burr who oversees that program and can provide more details.

Also, for reference I am sharing a link to our Pipeline SMS 2022 Annual Report (here), and 2021 report (here) both which talk about the overall mileage covered in PSMS. We also recent conducted a safety culture survey with INGAA and LEPA and over 25 member companies and can provide more details on that survey as well.
