Brief Description: Starboard Generator slung a connecting rod that penetrated the bock, his ignited the crankcase mist and triggered a crankcase explosion. One crewmember was close by and suffered burns on approximately 40% of his body. The fire self–extinguished within approximately 15 min. The fire affected the adjacent generator by singing several way ways.

Both generators are out of commission until repaired. The Emergency generator came online and provided lighting and emergency services as needed. Passengers and non–essential crew were evacuated to the pier and later passengers were taken to hotel rooms. After Actions in progress.
