1	<u>INTERVIEW</u>	
2	MR. FOX: This is Michael Fox, investigator, National	
3	Transportation Safety Board out of Washington, D.C., office.	
4	Today is July the 24th. I am located at in	
5	West Springfield, Massachusetts, and I am interviewing the motor	
6	carrier, DAKS Express.	
7	In the room there is two gentlemen that are associated with	
8	the company and we'll go around the room. Sir, Mr. Botyan?	
9	MR. BOTYAN: Yeah. Botyan, Gennadiy.	
10	MR. FOX: Gennadiy. It's and can you spell your last	
11	name?	
12	MR. BOTYAN: Yeah, the first name B-O-T-Y-A-N; last name, G-	
13	E-N-N-D-I-Y.	
14	MR. SERGEYCHIK: Your first mistake. It's the last name	
15	Botyan.	
16	MR. BOTYAN: Well, there is no different, Botyan	
17	MR. SERGEYCHIK: Yeah.	
18	MR. FOX: So, your last name is B-O-T-Y-A-N?	
19	MR. BOTYAN: B-O-T-Y-A-N. Yeah.	
20	MR. SERGEYCHIK: And first name?	
21	MR. BOTYAN: First name G-E-N-N-A-D-I-Y.	
22	MR. FOX: And what is your association with DAKS Express?	
23	MR. BOTYAN: I'm the driver.	
24	MR. FOX: You're the driver?	
25	MR. BOTYAN: Yes.	

1 MR. FOX: Okay. And also, in the room, sir, your name? 2 Anatoliy Sergeychik. MR. SERGEYCHIK: 3 MR. FOX: And you, sir, are you associated with the company? 4 MR. SERGEYCHIK: Yes, sir, (indiscernible), Inc. 5 MR. FOX: Do you have any association --6 MR. SERGEYCHIK: Oh, just this -- like for today, just 7 friends. 8 Today just friends? MR. FOX: 9 MR. BOTYAN: Yes. 10 But you were interested in potentially merging the MR. FOX: 11 company? 12 MR. SERGEYCHIK: Yes. 13 MR. BOTYAN: Yeah. 14 MR. FOX: And, sir, give me your license again. So, in the room is first name, A-N-A-T-O-L-I-Y, last name, S-E-R-G-E-Y-C-H-I-15 16 And how do you spell that -- I mean pronounce that, sir? 17 MR. SERGEYCHIK: Anatoliy Sergeychik. 18 MR. FOX: Sergeychik? 19 MR. SERGEYCHIK: Sergeychik. 2.0 MR. FOX: Sergeychik is a potential business partner with 21 DAKS Express. 22 MR. SERGEYCHIK: Yes. 23 MR. FOX: And that's the reason why he's joining the 24 interview. Thank you for helping. 25 INTERVIEW OF GENNADIY BOTYAN

- 1 BY MR. FOX:
- 2 Q. So, sir, as I mentioned, I'm here investigating a fatal crash
- 3 that took place in Randolph, New Hampshire a couple of weeks ago.
- 4 | I've been trying to reach your wife who is --
- 5 A. Svetlana.
- 6 Q. Svetlana, who's the -- she's the president of the company?
- 7 A. She's president.
- 8 Q. Because this is the same address as the accident driver and
- 9 there is some questions that we have about the relationship
- 10 between the companies. When did the business begin, DAKS Express?
- 11 When did it start?
- 12 A. 2016, I believe. I have documentation here. I have
- 13 everything, relationship, in March, I believe in March 2016.
- 14 Q. 2016?
- 15 A. Not 2015. No.
- 16 Q. 2015?
- 17 A. Yeah. That started from 2015, March.
- 18 Q. March? So you're showing me a document of -- from the
- 19 Federal Motor Carrier Safety Administration dated March the 12th,
- 20 2015. And this is showing you have a MC number and a USDOT
- 21 number. Now this listed here is in
- 22 Springfield --
- 23 A. Correct.
- 24 | O. -- Massachusetts?
- 25 A. Yes. Correct.

- 1 Q. What address is that?
- 2 A. We start from that address. It's two owners. We started
- 3 with two owners, Dimitri Arekhau and Svetlana. It's like a, she
- 4 is director I believe or, yeah. Dimitri, he was owner. Svetlana,
- 5 | I believe director. It's, I have a new paper if you need it,
- 6 updated.
- 7 Q. Yes. Because I think that when the company first became
- 8 incorporated --
- 9 A. It's been --
- 10 Q. -- it was --
- 11 A. Dimitri Arekhau.
- 12 O. Dimitri Arekhau?
- 13 A. Yeah.
- 14 Q. Last name's spelled A-R-E-K-H-A-U. And who is this person,
- 15 sir?
- 16 A. It's owner.
- 17 Q. Owner?
- 18 A. Yeah.
- 19 Q. The original owner?
- 20 A. It's two owners original, Svetlana --
- 21 Q. Yeah, on here, right?
- 22 A. Yeah. So --
- 23 Q. She was listed as Svetlana, was listed as the director.
- 24 A. Yeah.
- 25 Q. And then Dimitri was --

- 1 A. He's the owner.
- 2 Q. Is he still the owner?
- 3 A. No. Not anymore.
- 4 Q. He's out of the business?
- 5 A. Yes.
- 6 Q. Okay. So now it's you and your wife?
- 7 A. Yeah. I mean, actually it's under my wife, but later on I
- 8 | will be like, I don't know, maybe as director, maybe accountant.
- 9 I don't know.
- 10 Q. Okay. Where is your wife now?
- 11 A. She's in Florida.
- 12 Q. She's in what -- where in Florida?
- 13 A. It's North Port.
- 14 Q. North Port? What's the address?
- 15 A. It's .
- 16 Q. Boulevard?
- 17 A. Yeah.
- 18 Q. And do you have another home there?
- 19 A. We're renting house.
- 20 Q. Renting a home?
- 21 A. Yeah.
- 22 Q. Yeah, because originally when I tried to reach her, she said
- 23 | she was on vacation, your wife. But -- and then she called when I
- 24 had set up this appointment for us to meet today, or actually we
- 25 | were trying to meet yesterday. She said she couldn't because she

- 1 was in Florida and then she had to go to a doctor's appointment.
- 2 A. Yeah, yeah, yeah.
- 3  $\mathbb{Q}$ . And then she said, well, I live here in Florida.
- 4 A. Well, maybe she thought -- she supposed to be come to
- 5 Massachusetts for a vacation. Maybe it's kind of
- 6 misunderstanding.
- 7 Q. Oh, okay.
- 8 A. Probably. I'm not sure.
- 9 Q. Right. So she was going to come here for vacation?
- 10 A. Yeah. We came here for vacation. We've been here. Just
- 11 left from here.
- MR. SERGEYCHIK: It's like, like people they're usually from
- 13 Massachusetts go to vacation to Florida. But she goes vacation to
- 14 here from Florida.
- 15 MR. FOX: Correct. So she lives in Florida all the time?
- 16 MR. SERGEYCHIK: Yes.
- MR. FOX: And you live here all the time?
- 18 MR. BOTYAN: No, no, no. I'm on the road and I'm here. I'm
- 19 | in Florida. I'm on the road. I'm a driver.
- MR. SERGEYCHIK: Yeah, it's like drivers, like.
- MR. BOTYAN: Yeah.
- 22 BY MR. FOX:
- 23 Q. Okay. So --
- 24 A. Address, and you interest about the address?
- 25 Q. Now you, this is you?

- 1 A. Yeah.
- 2 Q. And you're listed at --
- 3 A.
- 4 Q. --
- 5 A. Yes, correct.
- 6 Q. Is this your address?
- 7 A. Yes, correct.
- 8 Q. You live here?
- 9 A. I'm living sometimes, yeah, at that address, but usually I
- 10 live -- I mean, most time I live in North Port. I not change
- 11 license yet.
- 12 Q. North Port in Florida?
- 13 A. Florida. Yeah. Depends on our trips.
- 14 Q. Okay. So now I'm really confused because all of your
- 15 paperwork says New -- it says this address where I'm located
- 16 here --
- 17 A. Yes. Correct.
- 18 Q. -- at
- 19 A. Why I live in that address, ? Or --
- 20 Q. Well, why is the -- you know, all of your documents, the
- 21 documents that you filed with the DOT, the documents you filed
- 22 | with the state, shows DAKS Express here where I'm sitting.
- 23 A. Okay.
- 24 Q. In
- 25 A. Gregory Derkach, he was work with us. He lives here in same

- 1 address.
- 2 Q. Gregory?
- 3 A. Yes, Gregory.
- 4 Q. Now I do not know this person. Is he --
- 5 A. Okay. Before we move to Florida, he asked me to be like as a
- 6 companion. He wants to buy truck but he not ready. And he said,
- 7 let's do it, everything in his address at , and he can
- 8 start from there. That's the whole story.
- 9 Q. Well, all right, as far as the DOT is concerned, if you're --
- 10 if this is your office, then you have, you know, your papers,
- 11 everything is kept here.
- 12 A. Um-hum.
- 13 Q. Is that correct? Do you have all your files here?
- 14 A. Yeah.
- 15 Q. So you have your driver files, your drug testing --
- 16 A. Yeah.
- 17 Q. -- maintenance records are all kept here?
- 18 A. Yeah.
- 19 Q. Okay. Well --
- 20 A. I mean, we have one or two trucks. We don't have too many
- 21 trucks, only two for now.
- 22 Q. Okay. All right. So, I'll probably want to see them here in
- 23 a few minutes.
- 24 A. Sure. Yeah. We have everything in process to do -- I spoke
- 25 | with Dennis -- what's the last name?

- 1 Q. Davendoff?
- 2 A. Davendoff, yeah. He wants to do -- he did for us the change
- 3 address, everything. We ask how we should do. He said, yeah,
- 4 | that's fine, everything's fine. We did -- we just change address,
- 5 billing address on because some brokers wants to
- 6 match Form W-9 and the physical address. It's supposed to be
- 7 matching.
- 8 Q. Right. Well, and then the DOT thinks the same thing.
- 9 A. Yeah.
- 10 Q. If you list your company here at then this is where
- 11 all your paperwork should be kept.
- 12 A. Yeah.
- 13 Q. And that's why it's a little confusing that you live at
- 14 another address --
- 15 A. Yeah. I'm process to change the license, everything.
- 16 Everything is in process.
- 17 Q. But you do physically live over here on ?
- 18 A. Yeah. Yeah.
- 19 Q. All righty.
- 20 A. Well, I'm not the -- I'm always on the road.
- 21 O. Hmm?
- 22 A. I'm always on the road.
- 23 Q. Oh, always on the road?
- 24 A. Yes. Some day in Carolina, some day in Massachusetts, some
- 25 day in Florida.

- 1 Q. But as far as when you're home, you consider home to be here
- 2 | in Massachusetts or in Florida?
- 3 A. Most in Florida.
- 4 Q. Florida.
- 5 A. Yeah, Florida.
- 6 Q. Okay.
- 7 A. That is all the trips, you know, I like it more south because
- 8 it's very good roads there.
- 9 Q. Now how many vehicles do you own?
- 10 A. I own part of it because we have two owners on truck. And I
- 11 own the trailer.
- 12 Q. So you have two, you have two vehicles in mind?
- 13 A. So I have one vehicle and we purchase with a guy he used to
- 14 work with us, and we purchased one truck with him. That's all we
- 15 have. And another --
- 16 Q. Now according to your -- the paperwork that you just filed
- 17 | with the DOT -- that's what this document is. This is called the
- 18 MCS-150. It was just updated in June. It was done June the 11th,
- 19 2019. It says you have three trucks. Right there is three.
- 20 MR. SERGEYCHIK: It's like three trucks under your company.
- MR. FOX: Yes.
- MR. SERGEYCHIK: I mean not your physically, but --
- MR. FOX: It may be leased.
- MR. SERGEYCHIK: -- he wants to know -- no, no, no -- how
- 25 truck in the company?

- 1 MR. FOX: Yeah. How many trucks do you have in the company?
- 2 MR. SERGEYCHIK: In the company?
- 3 MR. BOTYAN: Maybe David, he did -- not the David -- Dennis.
- 4 BY MR. FOX:
- 5 Q. Dennis.
- 6 A. Yeah, maybe Dennis, he did mistake. It's only two trucks.
- 7 Q. So, you're saying you only have two trucks?
- 8 A. Only two trucks on the road. Seeing this --
- 9 Q. What -- do you have the paperwork on those trucks?
- 10 A. Yeah.
- 11 Q. So you have the vehicle registrations?
- 12 A. Yeah.
- 13 Q. Okay.
- 14 A. Okay, that's for the truck.
- 15 Q. Um-hum.
- 16 A. That's the registration. And another registration.
- 17 Q. That's for the two trucks?
- 18 A. Yeah, that's a truck and trailer. Registration for the
- 19 trailer and the trailer.
- 20 Q. If it's not, I'll just take a picture.
- 21 A. Just a moment here.
- 22 Q. And these are a Ford F350?
- 23 A. Yes. Correct. Ford F350, 2005.
- 24 O. Now this is the trailer?
- 25 A. Yes, correct.

- 1 Q. And then you have another one, another truck and trailer?
- 2 A. Yeah. We -- that's owner/operator. Owner/operator.
- 3 Q. Now just while you're looking for that, your other paperwork
- 4 | showed for your Letters of Incorporation to the state,
  - ,

- 5 Street in Chicopee.
- 6 A. We used to live on that address.
- 7 MR. SERGEYCHIK: That was like original, where he was live
- 8 before Florida.
- 9 MR. BOTYAN: Yeah, before Florida.
- 10 BY MR. FOX:
- 11 Q. Before Florida?
- 12 A. Yeah. Yeah.
- 13 Q. Okay.
- 14 A. Yeah, we live on that address about 10 years.
- 15 Q. Okay.
- 16 A. Okay. That's the registration of the trailer, and this one
- 17 | right here, registration for the truck.
- 18 O. This is the second truck?
- 19 A. Yes. Second truck.
- 20 Q. Second truck and trailer. So this is a 2013, what is that,
- 21 Appalachian?
- 22 A. It's a trailer, yeah, Appalachian, yeah.
- 23 Q. A trailer. And who is David?
- 24 A. That's the driver, owner/operator actually. Not the driver.
- 25 He owns truck and we have a lease agreement with him.

- 1 Q. Is this the same thing, then? This one and this one?
- 2 A. One is probably expired one. Yeah, this one probably
- 3 expired. Expiration -- yeah, that's the new one.
- 4 Q. Okay. So this is the new one. This is a Dodge. 2011?
- 5 A. Yeah.
- 6 Q. And this is a 2500 series?
- 7 A. It's 35, 3-5.
- 8 Q. 3500, 350?
- 9 A. Yeah, 350.
- 10 Q. All right. So this is your two trucks and trailers. And
- 11 | then do you have the information on your drivers?
- 12 A. Yeah. I'm the driver. So what kind of information do you
- 13 | want?
- 14 Q. Like do you have what's called a driver qualification file?
- 15 Like your application --
- 16 A. Yeah. Driver application, yeah, of course.
- 17 Q. Application --
- 18 A. It's road test, application, a copy of my license.
- 19 Q. Yeah. License, right.
- 20 A. A lease agreement. Yeah. Another lease agreement. It's,
- 21 what, it's medical card. Those have -- no, it's not expired. I'm
- 22 | like, what? And another medical card. I don't know what that --
- 23 yeah, it's medical card. Pull all the paper out and examine it.
- 24 Q. Um-hum. Yeah. There's lot of paperwork in the trucking
- 25 business.

- 1 A. Yeah. But it's no chance, no chance to, you know, do the job
- 2 without paper.
- 3 Q. Yeah. You have to have the paperwork.
- 4 A. Yeah. I don't know, do you need the inspection report? If
- 5 you need, you can up here.
- 6 Q. Sure, yeah.
- 7 A. We keep in file in case we need. It's another inspection for
- 8 the, that's for the truck. That's for the --
- 9 O. The trailer.
- 10 A. Yeah.
- 11 Q. This is the trailer?
- 12 A. No. That's the truck.
- 13 Q. It says trailer.
- 14 A. Okay. Yeah, trailer. I apologize. That's the truck.
- 15 Q. Yeah. Okay.
- 16 A. Do you need the second page or no?
- 17 Q. No.
- 18 A. That's the whole information.
- 19 Q. Yeah. This is your long form.
- 20 A. Yeah.
- 21 Q. That's fine. Now so do you hold -- is this a CDL?
- 22 A. No. It's under CDL.
- 23 Q. Under CDL.
- 24 A. I drive under CDL.
- 25 Q. Under CDL?

- 1 A. It's a two-car hauler.
- 2 Q. Two-car hauler?
- 3 A. Yeah.
- 4 Q. Now I told your wife, all the drivers you've used in the past
- 5 year --
- 6 A. Um-hum. One he trying to open his own company. It's Andre
- 7 | Fidorsh (ph.), but we have all information if you need. It's on
- 8 file anyway if you need. And Aleksandr Hachenko (ph.), he not
- 9 working since 2018.
- 10 Q. Do you have his paperwork?
- 11 A. Yeah. I look.
- 12 Q. Why don't we -- we'll talk about him in a second.
- 13 A. Him, no. Him no.
- 14 Q. Aleksandr?
- 15 A. Yeah.
- 16 Q. Yeah. All right. So we'll talk about him in a second. How
- 17 do you generate your revenue? How do you get your loads?
- 18 A. Through the Central Dispatch, through the --
- 19 Q. Central Dispatch?
- 20 A. Yeah.
- 21 Q. And they give you your loads? That's how you get your --
- 22 A. Yeah. Through the Central Dispatch. Correct.
- 23 Q. Is there any other broker that you use to get your loads?
- 24 A. Mostly cars arrive United Road. Some companies through the
- 25 email. So email and Central Dispatch. We found that we get loads

- 1 | from the Central Dispatch, but the companies send us not only
- 2 | through Central Dispatch, only through email. That's how it
- 3 works. So company list the cars on Central Dispatch. We looking,
- 4 and we call them after if we agree with the price. Send to our
- 5 email. We have a contract, so --
- 6 Q. Now is -- according to your, your DOT records, it's just
- 7 | automobiles that you pick up? Is that your only cargo or do you
- 8 pick up anything else?
- 9 A. No.
- 10 Q. Just automobiles?
- 11 A. Yeah, just automobiles.
- 12 Q. Cars?
- 13 A. Sometimes people move, like golf carts.
- 14 Q. Yes.
- 15 A. It's, you know, golf cart same as a car.
- 16 Q. Right.
- 17 A. Or land cut like -- you know, cutting land, grass.
- 18 O. Um-hum.
- 19 A. So that's it.
- 20 Q. All right. So, who were the drivers that you've used in the
- 21 past year?
- 22 A. In this year it's Andre Fidorsh, Andre Fidorsh.
- 23 Q. Andre Fidorsh.
- 24 A. Yeah. He's not working since March, I believe, after --
- 25 Q. Um-hum.

- 1 A. -- we -- ours old insurance expire and he told us, I don't
- 2 | want to renew insurance. I want to -- you can, yeah -- he said, I
- 3 want to try to open my own company. I'm like, that's up to you.
- 4 He ask how could we help him a little bit.
- 5 Q. All right. So help me -- walk me through this. The current
- 6 drivers you say is just two?
- 7 A. Drivers three.
- 8 Q. Three drivers?
- 9 A. Two cars. Two trucks.
- 10 Q. Right. So it's you --
- 11 A. Me, then David and Aleksandr. I see if I can give you his
- 12 file, too, maybe.
- 13 Q. Okay. Just I just want to get the spelling down. So it's --
- 14 A. Okay.
- 15 Q. It's you. And then --
- 16 A. David.
- 17 Q. David, K-A-R-A-P-U-N-A-R-L-Y.
- 18 A. Um-hum.
- 19 O. And then who's the third driver?
- 20 A. All right. Aleksandr Aseyev. I not remember the spelling.
- 21 O. Aleksandr Viktor.
- 22 A. That's his middle name.
- 23 Q. Oh, Aseyev?
- 24 A. Aseyev, yeah.
- 25 Q. Aseyev.

- 1 A. Yeah.
- 2 Q. It's A-L-E-K-S-A-N-D-R, A-S-E-Y-E-V. Aleksandr is his first
- 3 name?
- 4 A. Yes, correct.
- 5 Q. Okay. He has a Florida license also?
- 6 A. Yes.
- 7 Q. So these are your three drivers.
- 8 A. Yeah. Only three drivers.
- 9 Q. Okay. All right. That's good. And then the drivers that
- 10 you've used in the past year?
- 11 A. Only (indiscernible) and -- actually, hold on. I'm wrong.
- 12 Yes. Here, too, on all this. I thought -- it's not here. Okay.
- 13 So he quit in March, I believe, after renewal insurance. Yeah.
- 14 Q. Okay. I see there's --
- 15 A. David.
- 16 Q. Jager --
- 17 A. Yeah. He not --
- 18 Q. -- Popov (ph.).
- 19 A. Yeah. Popov. Yeah, he's not working anymore. He's not
- 20 working --
- 21 Q. And then you have a Pavlo?
- 22 A. Yeah, Pavlo. He's not working since 2000- --
- 23 Q. P-A-V-L-O, Dukach?
- 24 A. Dukach, yeah.
- 25 Q. Dukach, D-U-K-A-C-H.

- 1 A. Yes.
- 2 Q. Forgive me if I'm mispronouncing these names.
- 3 A. No, don't worry.
- 4 Q. So then we also have another one here, this Gregory --
- 5 A. He's not working since 2017, I believe.
- 6 Q. No. He got a roadside inspection in 2018.
- 7 A. '18, okay. I'm -- all right, '18. Last year, yeah. He's --
- 8 hey. That's (indiscernible) because he wants to check everything.
- 9 Q. Yes. See, he's asleep.
- 10 All right. And then you also had this Aleksandr Hachenko.
- 11 A. Hachenko. Yeah.
- 12 O. Hachenko.
- 13 A. Hachenko, yeah, that's his license, medical and job
- 14 application.
- 15 Q. Um-hum. Now this is -- this says a job application letter.
- 16 Do you have a regular application that you fill out, like previous
- 17 employer check and things of that nature?
- 18 A. He just, I believe came from Ukraine, and I believe he not
- 19 work on transportation company. I'm not sure.
- 20 Q. Did you hire -- you hired this driver?
- 21 A. Not really hire. He told me he going through divorce and he
- 22 looking job to pay child support or something. I don't know. He
- 23 said I need some money. So we drive a little bit together and
- 24 after a little while we have complaints from the customers, so --
- 25 Q. You had complaints from the customers?

- 1 A. Yeah.
- 2 Q. Such as what? What was the complaints?
- 3 A. He's kind of probably rude or so with the customers. Just in
- 4 probably his language, nobody not understand each other, the
- 5 customer and driver. And customer call to the broker, and broker
- 6 call us and tell if it will be Aleksandr driver, we not give you
- 7 our loads. So that's the whole story.
- 8 Q. So did you terminate him?
- 9 A. Yeah.
- 10 O. You fired him?
- 11 A. Not really fired. I just tell him we can't, you know, work
- 12 together because that's the issue.
- 13 Q. Okay.
- 14 A. I don't want to lose any customers.
- 15 Q. Now do you do any drug testing?
- 16 A. Under -- it's not required for the --
- 17 Q. Not required?
- 18 A. -- for the --
- 19 Q. Because you have no CDL equipment?
- 20 A. Yeah. But the, yeah, mostly -- and I did by myself, I did
- 21 | the drug test, but it's probably about 2015 or '16, '15 yeah,
- 22 since we start. I did the drug test.
- 23 Q. And who is your local insurance agent?
- 24 A. It's Mass Trans.
- 25 Q. Mass Trans?

- 1 A. Roman.
- 2 Q. Roman?
- 3 A. Yeah.
- 4 Q. Yeah. Know his last name?
- 5 A. Shtefan. I not remember a last name, I mean spelling.
- 6 Q. That's, that's fine. Shtefan. And so, you, your insurance
- 7 is through -- do you have a copy of your insurance policy?
- 8 A. No.
