2	(1:05 p.m.)
3	MR. EVANS: Good afternoon. Today is July 25th. It is now
4	1:05 p.m., and my name is Roger Evans and I am an investigator
5	with the National Transportation Safety Board in Washington, D.C.
6	We are at the Blue Rock Fire hall in Millersville, PA. This
7	interview is being conducted as part of the investigation into the
8	residential gas explosion on Springdale Lane here in Millersville
9	that occurred on July 2, 2017. The NTSB Case No. is DCA17FP006.
10	The purpose of the investigation is to increase safety, not
11	to assign fault, blame or liability. The NTSB cannot offer any
12	guarantee of confidentially or immunity from legal actions.
13	This interview is being recorded and may be transcribed at a
14	later date. A copy of the transcript will be provided to the
15	interviewee for review prior to being entered into the public
16	docket.
17	Joanne, and the last name again was?
18	MS. SCHMIDT: Schmidt.
19	MR. EVANS: Schmidt. Okay. Joanne Schmidt, you're permitted
20	to have one person present during the interview. This is a person
21	of your choice attorney, supervisor, friend, family member or
22	nobody at all. Please state for the record who you have selected?
23	MS. SCHMIDT: My daughter-in-law.
24	MR. EVANS: And daughter-in-law, can you spell your name?
25	MS. COOPER: Tania Cooper. T-A-N-I-A, Cooper.

1 MR. EVANS: And how do you spell Cooper? 2 MS. COOPER: C-O-O-P-E-R. 3 MR. EVANS: Okay. And Joanne, can you please spell your name 4 for us? 5 MS. SCHMIDT: All right. Joanne, J-O-A-N-N-E, Schmidt, 6 S-C-H-M-I-D-T. 7 MR. EVANS: Okay. And you are, are you employed? MS. SCHMIDT: No, I'm retired. 8 9 MR. EVANS: Okay. Good. Okay. EVANS: 25 Well, thank you again for appearing today. Just a few -- if Q.

4	А.	B-U-R-R, O-A-K.
5	Q.	And as far as where that is in relationship to the, where the
6	explo	osion occurred, how far is that away?
7	А.	Jeez, not even a quarter of a mile, I would say.
8		BY MR. DOWNS:
9	Q.	Can we refer to the map? Is this direction here, east of the
10	acci	dent site which was here?
11	Α.	Yes.
12	Q.	And it's the next intersection down?
13	Α.	Yes.
14	Q.	So for the record, it's one block to the east of the accident
15	site	
16	Α.	Okay.
17	Q.	And how far down that block are you?
18	Α.	Probably
19	Q.	A few houses?
20	Α.	About six houses.
21	Q.	Six houses in or so?
22	Α.	Five or six.
23	Q.	Five or six?.
24	Α.	So about a quarter, half a block.
25	Q.	Close enough, thank you.

1 A. Yeah.

2 MR. EVANS: And that was Rick Downs speaking.

3 MR. DOWNS: Thank you.

4 BY MR. EVANS:

5 Q. So, and I guess you commonly walk from the neighborhood; is 6 that correct?

7 A. Yes.

8 Q. Okay. So on the day of the incident, can you start from when 9 you woke up, go through what you did, and just tell us what you 10 saw, what time it was, who you saw?

11 A. Well, that was the last stretch of my walk, and I walked up 12 the sidewalk, and I got to one of the driveways and smelled like 13 the rotten egg smell.

14 Q. Right.

A. And I stopped and looked and I saw an SUV parked in the driveway, so I thought maybe it was running and the exhaust and everything. So I kept going and I got to -- can I use this?

18 Q. Yes, absolutely.

19 A. I got to -- so that driveway was probably down here, which is 20 not in this picture. So I walked up here and my usual leg is to 21 come off of this sidewalk and come around here and go around that 22 circle but I --

23 Q. I'm going to ask you to use this one instead?

24 A. Okay.

25 Q. That's the same thing.

1	A. Okay. And, so back here was where I had the first faint
2	smell and then right up in here when I was ready to go around that
3	circle, it was right back here where I had a really strong smell.
4	And I, it stopped me from my breath. It was that strong.
5	Q. And you feel as though the driveway was perhaps, which
6	address up there?
7	A. This one here?
8	MS. COOPER: So it would have been
9	MS. SCHMIDT: Well, this is the brick house, 202.
10	MS. COOPER: 202.
11	BY MR. EVANS:
12	Q. 202, That's here?
13	A. Yeah. And where I first smelled it was around 190. I
14	believe so.
15	Q. And when you said you smelled gas at that point, was there
16	any sort of a breeze or anything that day do you recall?
17	A. I, no, I don't think so. I don't recall.
18	Q. Was that the first time you'd ever smelled gas in this area?
19	A. Yes, to the yeah.
20	Q. How about your entire neighborhood?
21	A. That's the first time, yeah.
22	Q. Okay. And did you continue on walking around the cul-de-sac?
23	A. No, I did not.
24	Q. So once you smelled the gas at the, at that point there,
25	which is the

- A. Yeah. It made me turn around and look right at the brick
 house. And then I thought --
- 3 Q. So at that point you turned around and looked at number 202?4 A. 202. Yeah.
- 5 Q. Okay.
- A. And then I contemplated going back around, so, but then Idecided not to, so I turned around and went, started back.
- 8 Q. And you were walking your dog?
- 9 No. I did not, I don't have a dog. But I did meet up with a Α. 10 woman coming up this way with a dog when I headed back. And I 11 stopped her and I said, do you live up that way? She says, no, I 12 live down the other way. I said, well, I think I can smell gas. 13 I was like, I'll go home and call UGI. And she says, oh, okay. 14 She says, I -- she kept walking up towards that way. I didn't 15 know her personally. That's the first time I've ever seen her on 16 the walk and the dog.
- 17 Q. But you did mention to her that you were going to call UGI?18 A. Yep. Yeah.
- 19 Q. Okay. And did she have any reaction to that?

A. She just said, oh, okay. I'll see what I can find out. Then
she just kept walking up. Then I went straight home and dug out
the phone number and called UGI.

- Q. Yeah. We have, we had reports, or maybe rumors that someonehad called who was walking a dog.
- 25 A. She may have called, too. I don't know.

1	Q.	Okay. But you were not walk, you were not walking a dog?
2	Α.	No.
3	Q.	And you don't own dog?
4	A.	I do not own a dog.
5	Q.	Okay. And then where were you when the, what by the way,
6	what	time was it when you were at that point?
7	Α.	I had called UGI, according to my phone it was 10:25. So I
8	imag	ine it was between 10:10 and 10:20.
9	Q.	Okay. And what type of a response did you get from UGI when
10	you r	nade the odor complaint?
11	Α.	They asked me a few questions about the location and if I was
12	stil	l there. And she said that they would have a team out there
13	right	away.
14	Q.	Okay. Once the call was made and I trust you went back to
15	your	home?
16	A.	I was at home when I called UGI.
17	Q.	Oh, so you walked all the way down to your house
18	A.	Yeah.
19	Q.	and made the call to UGI?
20	A.	Yeah. I wasn't about to stand there.
21	Q.	Okay. Okay. Understood. So were you at your home when the
22	home	exploded?
23	A.	Yes, I was.
24	Q.	Okay. And what time do you think that was?
25	Α.	Close to oh, I'm not sure. I can't say for sure.

- 1 Q. Hour later, 2 hours later, 3 hours later? No idea?
- 2 A. I didn't make note of the time.
- 3 Q. Okay. So when you had --
- 4 A. I can guess but, you know, I don't think that --
- 5 Q. Yeah --
- 6 A. -- would be --
- 7 Q. Yeah, that's okay.
- 8 A. Yeah. No.

9 Q. No, that's all right. So at the time of the, when you heard 10 the explosion, did you kind of have in your mind, oh someone's 11 house blew up? Is that what you thought or just thought it was a 12 plane crash, or what was your first impression?

13 A. My first impression was that maybe one of the homes did 14 explode. That was my first impression because of calling UGI and 15 knowing where I smelled the smell was around the cul-de-sac.

16 Q. Okay. Had you, had you talked with anybody else when you

17 were walking down the street besides the one lady that had the

- 18 dog?
- 19 A. No.
- 20 Q. And did you see anybody else out that day besides --
- 21 A. No, I didn't. I just, I just remember here and her dog.
- 22 Q. Okay. And I guess you've smelled natural gas before because
- 23 you knew right off the bat what it was?
- 24 A. My home's supplied with gas, too, so --
- 25 Q. So you have a gas oven or something?

1	A. Yeah.
2	Q. Yeah. Okay.
3	A. No, I have a gas water tank, so.
4	Q. Right. Yeah. Okay.
5	MR. EVANS: Any questions?
6	MR. KENDALL: I have no questions.
7	MR. DOWNS: Ms. Schmidt, thanks so much for joining us today,
8	and take a
9	MS. SCHMIDT: Sure.
10	MR. DOWNS: few minutes. I'm going to just recap a little
11	bit and make sure I'm following your
12	MS. SCHMIDT: Okay.
13	MR. DOWNS: path.
14	BY MR. DOWNS:
15	Q. This is a regular walk you do daily, weekly, or how often do
16	you do this?
17	A. It's sporadic. It depends on the weather.
18	Q. Okay. And other factors?
19	A. And other factors, yeah.
20	Q. And you're retired so you got lots of time to walk?
21	A. Yeah. Exactly.
22	Q. Okay.
23	A. Different times of the day, so.
24	Q. Very good. And you live down the side street over in this
25	area here?

1 A. Mm-hmm.

2	Q. And your normal walk is this way towards Springdale, or do
3	you start and go that way, or which way do you do your walk?
4	A. Sometimes I change it up. But this time I went up Burr Oak
5	and went
6	Q. Up Burr Oak, Burr Oak
7	A. Then right.
8	Q north and then make
9	A. I made a right.
10	Q you made a right
11	A. And went up
12	Q on Springdale
13	A all around, yeah, the neighborhood.
14	Q. The neighborhood to the right?
15	A. On that side.
16	Q. Meaning to the east of the accident site?
17	A. Yeah.
18	Q. And then worked your way ultimately back to Springdale
19	Lane?
20	A. Correct.
21	Q. And then walked past your intersection, up Burr Oak?
22	A. Right.
23	Q. And then walked west on Burr Oak. And you were saying to the
24	effect that you thought you might have been in the neighborhood of
25	the 190

1	Α.	Yeah.
2	Q.	building here, because you thought there was an SUV in the
3	driv	eway there that sparked your recollection, right?
4	Α.	Yes.
5	Q.	And so when you first smelled the odor, distinct odor, and
6	you	knew it was natural gas?
7	Α.	Well at that time I didn't know because it was that eggy
8	smel	1.
9	Q.	A rotten egg smell?
10	Α.	Yeah.
11	Q.	And you're thinking maybe the exhaust from the car
12	A.	Because of the car.
13	Q.	might have been contributing to it?
14	Α.	Yeah
15	Q.	Okay, good. And you continued on kind of making a mental
16	note	, would that be a fair characterization?
17	A.	I can't say yes or no because I just chalked it off that it
18	was	the car, the SUV
19	Q.	The car, okay.
20	A.	and the car in the driveway.
21	Q.	And as you were walking to the west, this being north at the
22	top i	here, was the odor continuing, got worse or less, or
23	A.	No. I didn't notice it until I got to the cul-de-sac.
24	Q.	Until you actually got to the edge of the cul-de-sac
25	A.	Correct.

1	Q.	here where there's a mailbox right here.
2		
	Α.	Yeah.
3	Q.	And that's towards the edge of the cul-de-sac. And right in
4	the	area by that mailbox, kind of at the end of the sidewalk here,
5	the	paved sidewalk, is that when you smelled it again?
6	Α.	I was off the sidewalk onto the street.
7	Q.	Pavement, itself?
8	A.	Yes, Mm-hmm.
9	Q.	Okay. And that's when it distinctively hit you?
10	Α.	Yes. It got yup.
11	Q.	Very good. And what was your thinking again? That it
12	Α.	Well, I
13	Q.	was definitely a natural
14	Α.	I was
15	Q.	gas leak or
16	Α.	I wasn't sure if I was going to be able to continue to
17	brea	th, it was that strong, but
18	Q.	That strong and it stopped you in your tracks

8	Q.	It sounds like you're a fairly sociable person in your

13	Α.	I would, I would say between the 190 and 198, yeah.

19	Q.	So you got the 10:25?
20	Α.	10:25 a.m.
21	Q.	Right. 10:25 call. And you described the call and the folks
22	at U	GI were very helpful and amenable? No trouble there, right?
23	Α.	Oh, oh no, none at all.
24	Q.	Okay. Did they tell you to take any action?
25	Α.	No. She, they just took, asked for my name and phone number

1	and said that they would have a team out there right away.
2	Q. Okay.
3	A. And that was it.
4	Q. That was it?
5	A. That was the end of the phone call.
6	Q. Okay. Great. Let me ask you this, Ms. Schmidt. How did you
7	know to call the gas company? UGI?
8	A. Well, if you smell gas and you're not sure where it's coming

11	receive anything that provided you instructions on what to do if
12	you smell gas?
13	A. No.
14	Q. Do you receive anything in your gas bill, for example?
15	A. Just the little blurb in there that says, if you smell gas,
16	call.
17	Q. That's what, that's what
18	A. Yeah.
19	Q I'm getting at. You received
20	A. Okay.
21	Q something. I don't, I don't want to prompt the answer
22	here.
23	A. Okay. That's all right. That's all right
24	Q. I'm just trying elicit the
25	A. Yeah.

- 3 Q. So you did get something that you recall in your gas bill?4 A. Yes.

- 8 on, maybe on the back. I can't remember now because I'm paperless
- 9 now.
- 10 Q. Okay.
- 11 A. So I kept one of the paper ones.
- 12 Q. Okay.
- 13 A. So it might be in the back where there's a statement that
- 14 says it.
- 15 Q. On the back of the envelope?
- 16 A. No, the --
- 17 Q. Or back of the bill?
- 18 A. -- bill, yeah.
- 19 Q. Okay.
- 20 A. I think so.
- 21 Q. Okay.
- 22 A. Of --
- 23 Q. And you kept this bill from a ways back and it just happened
- 24 to be filed away in the drawer?
- 25 A. Yes, that was when I first moved in --

- 18 A. Yeah.

Q. Okay. And you were, you were at your house after you made the phone call to UGI, doing whatever you needed to do and then at some point later on you describe hearing a noise, an explosion, or

- 12 A. Yes.
- 13 Q. You're on the --

- 15 Q. -- east side of the street?
- 16 A. Yes, I am.
- 17 Q. Okay. Okay. I'm thinking you were on the west side, but --
- 18 A. No.
- 19 Q. -- you're on the east side of the street?
- 20 A. Correct.
- 21 Q. Okay, good. So you wouldn't of seen it anyways?
- 22 A. No.
- Q. Okay, very good. Okay, and what did you do when you heard
 the boom? Did you dial 911 or anything, or --
- 25 A. No, I did not. I did, like -- I went through the house and

1	ran t	to the front door and, like, everybody else was doing and
2	Q.	Was it your thinking that it's not my house thank God or
3	A.	Oh, hell oh, sorry.
4	Q.	That's quite all right.
5	Α.	No. I would say, I was just hoping that my phone call to UGI
6	was e	enough.
7	Q.	Helpful?
8	Α.	Yes.
9	Q.	Very good. And you were saying your neighbors were all
10	look	ing outside about the same time when you went out to look?
11	A.	Yes.
12	Q.	Okay. And everybody was wondering the same thing?
13	A.	Yes.
14	Q.	Okay. And then what happened after that? Everybody's
15	talk	ing amongst themselves, amongst the neighbors or so, or did
16	you h	happen to hear fire trucks or anything arrive?
17	Α.	When I was sitting out on the back deck, I heard one of the
18	fire	trucks coming in.
19	Q.	You heard the siren coming up
20	Α.	Yes.
21	Q.	coming up Springdale?
22	Α.	Yes.
23	Q.	And that was after the explosion?
24	Α.	Yes. No, no, no. That was before.
25	Q.	Before the explosion?

1 A. Mm-hmm.

2 Q. Okay that -- my second trick question.

3 A. No, that was before.

Q. Very good. So you heard it with the siren coming up before.
About how much before? Best guess? I realize you're not watching
the clock necessarily.

- 7 A. Well, I remember sitting there thinking, oh, thank goodness,
 8 you know, they got people there checking it out, and then the, I
 9 would say, it wasn't very long, maybe 10 or 15 minutes.
- 10 Q. Ten or 15?
- 11 A. Yeah.

Q. Okay, very good. Okay. Is there anything else that you can think of you'd want to add to the discussion, that we're not asking you the right question, maybe? Let's put it this way. You do -- anything here that you'd do maybe differently now that you know what you know?

17 A. Now that I know what I know, I wish I had called 911, as18 well.

19 Q. Back when you were near the gas odor you mean? Or?

20 A. I wouldn't have done it near the gas odor. I maybe, I

21 probably should have used my cellphone on the way home.

22 Q. Did you have phone with you at the time?

23 A. I did, yes.

Q. Okay. But in retrospect you're thinking now maybe 911. But the instructions on the gas bill, does it say call UGI or does it
