A timeline of events was constructed from the Honolulu Control Facility watch desk (HCF) phone audio, air traffic control (ATC) phone audio, ATC audio transcripts, the U.S. Coast Guard (USCG) Honolulu Joint Rescue Coordination Center (JRCC) situation report, and the State of Hawaii Department of Transportation Airports Division Fire Incident Report (ARFF). Entries in the timeline reflect pertinent information contained in these recordings and are summaries of longer conversations.
