Elena,

As discussed during our meeting, our Distribution Integrity Management Program considers both GIS data and complementary information from local subject matter experts (SMEs). Where service line installation records are not available, our GIS system identifies the pipe material attribute as “unknown.” This category represents 72.5% of the service line footage in our GIS system for the Mississippi division. However, SME knowledge of these assets helps drive our actions which includes but is not limited to: reviewing outputs from our risk model tool, completing distribution annual reports such as the DOT 7100 report, determining priorities for infrastructure replacement, and performing accelerated leak surveys. As we review GIS records and continue infrastructure replacement, we are able to update system attributes in our GIS system while continuing to consider complementary SME knowledge and SME input alongside results from our risk model tool to support the identification of threats and measures to address risk under our Distribution Integrity Management Program.
