


2 A. Ethan has been a commercial fisherman since 2017, 2018,3 roughly. End of 2017, beginning of 2018.

4 Q. Okay. And how many different boats has he been on, do you 5 know?

6 A. Quite a few. He went on the *Titan* out of Gloucester, he was 7 doing lobstering this past summer out of Portland, he was -- he 8 had been on so many boats. Based out of Gloucester, Boston --9 there's just so many.

10 Q. Okay. And has he been on ground fishing vessels before? Has
11 he done this type of fishery before?

12 A. Yeah. He was doing eel fishing on -- like slime eel fishing 13 on the *Titan*. He was usually a dragger. Lobstering had actually 14 been a newer thing for him. He hadn't really done much lobstering 15 like closer to shore. He was usually offshore.

16 Q. Okay. Sorry, I'm just taking some notes.

17 A. No, you're good. Sorry if I talk too fast, or if you need me
18 to repeat something --

Q. Okay. About how many trips a month would he normally do?
A. He would do back-to-back trips usually. They might take like
a day or two break, but usually, they would do turnarounds. He -recently, he had taken a week off because we had been going
through some things, so he just wanted to spend some time and -but he usually was fishing more than at home.

25 Q. Okay. So what would his normal like work hours, work

2	back for a day
3	(Simultaneous speaking.)
4	A. Sometimes, it would be so like, when he was doing the
5	offshore, he was gone for 5 days at least. It all depended on
6	their catch and food, and everything like that was really the
7	biggest factors for them.
8	Q. Okay. And then would they go out 5 days, would they come
9	back, offload the fish, get groceries, and then go back out?
10	A. Sometimes, yes. Depending on like how rough the trip was or
11	weather, but usually they would do a turnaround, yeah.
12	Q. And then, how long have you guys been together?
13	A. Ethan and I first started dating in the 6th grade.
14	Q. Oh, wow.
15	A. Yeah. We had been recently heavily (verbatim) since the end
16	of like 2017, beginning of 2018.
17	Q. Okay. So you've been with him for the majority of his
18	fishing career?
19	A. Yeah. I have the mileage on the cars to prove it. E-ZPass
20	tolls.
21	Q. Those add up.
22	A. Yes, they do. My car actually got my registration got
23	suspended from unpaid tolls from it.
24	Q. Oh.
25	A. Yeah.

1	Q. So, when he would go underway, was it typical, like on any of
2	the boats that he served on, for him to be able to call you and
3	just check in with you?
4	A. So he, yes, had the ability hold on, I have to plug in my
5	phone, sorry. Yes, he like most of the phones, he did have the
б	satellite yes, he did have a satellite phone on every boat that
7	he had been on. It was just hit or miss if we has able to call
8	me. It was all depending on like how busy they were, but usually,
9	like when he was driving, he would take time, or he would skip
10	sleeping for a little bit to be able to call me. Because it was
11	important, because he was always gone for so long, and I have
12	really bad anxiety, so
13	Q. Okay. How did he decide do you know like why and how he
14	decided to get into the fishing industry?
15	A. So he actually had moved to Harpswell, and one of his friends
16	had gotten him on a boat out there, and ever since then, he he
17	loved the money.
18	Q. Did he ever have any type of training like did he go do
19	you know if he went through any type of like survival suit
20	training or
21	(Simultaneous speaking.)
22	A. I know they went
23	Q or anything like that?
24	A over that on the boats with him. Like they would kind of
25	do a rundown of the like the I don't know how they explained

2 Q. Like the safety equipment --

3 Because like every boat had -- yeah, because every boat had Α. 4 like a different protocol, I guess, so they would just kind of go 5 -- like he obviously knew how to put on his survival suit and 6 everything like that. He -- that was his biggest thing. He 7 wanted to know how to do that, obviously, for safety reasons. But 8 yeah, every boat he went on, that was the first thing they went 9 over with him.

And that was the first thing he went over with me, too, when I -- because when I went on the boat with him, like God forbid anything would happen when we were docked or whatever, he just wanted me to know where all the exits and stuff, and stuff like that. So he would show me like the map layouts, because they had it right there up in the wheel well, so --

16 Q. Okay. And did he have his own survival suit, or did he use 17 what was on the boat?

18 A. It was what was on the boat, provided on the boat.

19 Q. All right.

A. I was going to say, he only provided his gear and his own --21 he only had to get his own gear and stuff like that.

 specifics on Ethan's experience on the *Emmy Rose*.

5 Q. So first one is, do you know what positions he held on the 6 vessel?

7 He wasn't -- I don't -- he wasn't -- so it went captain, Α. 8 first hand -- he was like second. It all depended, also, on who went on the trip with them, because they sometimes would change 9 10 the crew, like because some person had family issues going on or 11 something like that, so it depended on who went. There was one 12 guy who, when they went, he was above Ethan, but when it went with a different crew, Ethan was like the captain's first hand, I 13 14 quess. It just really mattered on who went out. And the captain 15 was trying to get Ethan into a higher position, because he saw 16 potential in Ethan and wanted him to become his own captain at 17 some point. And you mentioned kind of the first hand and second hand. 18 0. Do

19 you know, what duties or what work would he traditionally do in 20 those positions?

A. I honestly don't know. We didn't really like get into thatmuch depth/detail about it.

23 Q. Okay.

24 A. It wasn't just conversation we -- like I --

25 Q. I mean, just some of the conversations you had with him, do

7	me frequently was when he was driving, because it was really the
8	only free time he would have. He would call me for like 5, 10
9	minutes, if that, depending
10	Q. Are there would there be a specific time? Like, hey, I've
11	got I'm standing this watch and I'm driving the boat, or just
12	be like, hey, I'm in the wheelhouse and I'm calling you
13	A. It was the most randomest (verbatim) times.
14	Q. Okay.
15	A. I would get phone calls at 1:00 a.m., 7 o'clock at night
16	it was never the same. And he'd be like, oh, I'll call you
17	tomorrow, and then, half the time, he wouldn't call me because
18	they got so busy and
19	Q. Um-hum.
20	A he just didn't have time.
21	Q. Okay. Next question is, do you know how many trips he's made
22	on the Emmy Rose?
23	A. He started on the Emmy Rose when so we had gotten into a
24	fight in August and broke up for a week or so, and that is when he
25	started on the Emmy Rose.

3	Q. Okay. And then I know you mentioned when was asking you					
4	some questions, so how many trips would you say I guess like					
5	every 2 weeks or every other week, he would go					
б	A. He had gone on every trip they had been on since he'd gone on					
7	the boat except for one.					
8	Q. Okay.					
9	A. He missed

11	Q. And do you know when that one was?					
12	A. It was not the I think it was the two trips before					
13	last.

15	A. Because he had gotten redfish poisoning in his hand

17	A and he had been taking antibiotics for a really long time,					
18	and he just we had just gotten back together and everything,					
19	and he just wanted to take time and yeah, so he took a week					
20	off.					
21	Q. Okay. All right, next question. I know you when we					
22	talked on the phone before, you had mentioned that you had been on					
23	the vessel a couple times, and just can you kind of explain					
24	what your experience with the vessel, what you did, how you got					
25	onboard, that type of thing?

1	A. I would meet them down in Gloucester when they were unloading
2	and would help them wash I would put on the suit and help wash
3	boards and unload the boat. I would be there when they got
4	groceries and put all the groceries away in the fridge and play
5	Tetris, because it drove me crazy how they would just throw
6	everything in there, like how do you guys find anything? So I
7	would like play Tetris and put all the groceries away. I would
8	make the beds and help clean the boat. The only thing I didn't do
9	was go down in the engine room, because it was too loud; I refused
10	to put the earmuffs on.
11	Q. Okay. Have you been down in the fish hold and everything,
12	too, and
13	A. Yeah.
14	Q lazarette, those types of areas?
15	A. Yeah.
16	Q. Okay. Can you maybe just describe for me, just kind of walk
17	us through your recollection of the vessel, like how it was laid
18	out and how it was set up?
19	A. So I usually would get on on the front of the boat, because
20	that was how I felt safest getting on, and would go through the
21	yeah, the cabin, I guess the wheelhouse actually. Yeah, the
22	wheelhouse. And then there was a staircase down, and the bathroom
23	would be right there off on the right, and then you'd go down a
24	little bit, and then off to the left there was one bunkroom with
25	four bunks; there was two up against the wall and then two up

1 against this wall, and then cabinets off to the side for their
2 clothes.

And then you'd go down a little bit further and then, on the right, there was a last door with another bunkroom with one bunk, which I believe was Bobby's bunk, the captain's. And then next to that was like the kitchen and the dining room table area, and then -- and the stove was right there and the sink and the fridge, and then you'd walk through this little cubby area kind of space, and then down below was the engine room right there.

10 And then you'd walk out on deck, and then off to the right, 11 there was a -- like a hallway, I guess, where they just had ropes 12 and stuff like that, and there was a big wheel with -- I want to 13 call it like a hose deck, I think, was on it, right there off to 14 the right. And then there was the controls for the draggers, the 15 arms and stuff like that, and then you'd walk down a little bit 16 further, and there was another hull (ph.) room where they had all 17 of the oil and stuff like that for random tools and -- it was like their tool room, like the toolshed or whatever. 18

And then, out on the deck, like -- so they had the controls for the arms and shit -- or stuff, sorry, and they had kind of like a lobster tank right in front of that. And then in front of that was the hole down into the ice -- the fish hold. And then it like opened out into the deck, and then the wheels.

Q. And then, so did you ever go down -- you said you didn't goin the engine room because it was too noisy, but any other spaces

1 below? Have you ever been down in any of those spaces? 2 I kind of went down the stairs into the fish hold. I didn't Α. like touch foot down into it because it was really cold down 3 4 there, and I was just trying to hand him his cigarettes, but he 5 couldn't really come up because he had to blow ice, and there was 6 like the ice pens or whatever. 7 Sorry, and then one other thing you mentioned, just Ο. Um-hum. checking my notes here, is you said they would carry a lobster 8 9 tank on the -- was that back on the back deck you said? 10 So like, when you walked out onto -- yeah, so when you walked Α. 11 out onto the first deck, where the controls were for the arms and 12 stuff like that for the draggers, like right in front of that. I 13 don't know if it was for lobster; I don't really know like -- it 14 was just a lobster-sized tank, like one of those big, square fish 15 -- maybe it was for their bait maybe. I don't know. 16 If you had to guess, how big was it, would you say? Q. 17 Like hot tub sized. Α. Oh, okay. And was it made out of plastic or --18 0. 19 Yeah, it was like the thick plastic bait barrels that they Α. used. Not like the thin round ones, like the really super thick 20 21 plastic. 22 0. Um-hum. Okay. 23 I never opened the lid to see what was in it because I didn't Α. 24 need to. It was always covered with stuff, so --

2	the deck-deck, I guess.
3	Q. Up to the wheelhouse, or up to the upper deck?
4	A. Yeah, up to the upper deck.
5	Q. Okay.
6	A. Because there was like a deck, and then you would go
7	downstairs, and then it would go into the wheelhouse.
8	Q. Okay. All right, next question. So what was I guess what
9	was your opinion of the Emmy Rose, and then, if Ethan ever
10	disclosed to you what his opinion of the vessel was
11	A. My first impression of the boat was it was the cleanest boat
12	he had ever been on.
13	Q. Okay.
14	A. It was in very impeccable, clean shape. I had like the
15	floors were spotless, all the furniture was put together, there
16	weren't any rips in it; it was actually very clean and maintained.
17	And, I mean, the only thing that I kind of thought was odd was
18	like how high the sides of it was, because every other boat he had
19	been on, they I mean, they were like kind of high, but not like
20	over-your-height high, I guess.
21	And I guess Ethan's biggest thing he always bitched about
22	it he's like, it's not set up to be a dragger boat. Just the
23	way that it was set up, I guess, just wasn't mechanically in
24	his opinion, I guess, compared to other boats he had been on, he
25	just didn't feel like it was right because it was the size and

11	A. Yeah. He just said the way that it was just set up, he said,							
12	compared to other boats, he just said the flow of it just wasn't							
13	what he I don't know, that was just his personal thing, I							
14	guess. I don't know.							
15	Q. Okay. Sorry, just taking some notes. All right, next							
16	question is you kind of already answered this, but I'll ask it							
17	again. The typical schedule, so they would leave Portland, go out							
18	and fish, and then come back. Like how did that work? What was							
19	the typical schedule routine?							
20	A. It really depended on like how much they caught, because they							
21	were all about the money. They just wanted that big paycheck, so							
22	they would try to push it as long as they could to fill up,							
23	because they didn't want to come back unless they were full.							
24	Because they're like, well, what's the point; that's kind of a							
25	waste of food, money, gas you know what I mean?

2	A. So it really depended. They usually were gone for at least
3	5 or 6 days though. And I would meet them down in Gloucester and
4	help them unload, and sometimes Ethan would come home with me for
5	2 days, if that, depending on if they needed to fix a net or what
6	had happened.
7	Q. So they would would they leave from Portland, go out and
8	fish, and then come back into Gloucester? Is that how it would
9	work? And then sail back to Portland?
10	A. Yeah, they would unload in Gloucester and then sail back to
11	Portland and then leave from Portland and go back again and then
12	unload in Gloucester. And if depending on if they had were
13	doing a turnaround or not
14	Q. Okay.
15	A because if they did a turnaround, they just left right
16	from Gloucester.
17	Q. Oh, okay. Did they do did he do frequent turnarounds, or
18	was it kind of hit or miss?
19	A. He had done yeah, it was hit or miss. It really depended
20	on how the trip went and the weather and everything was based
21	off of so much other factors; it was so annoying.
22	Q. Okay. Next question is, can you discuss I know you've
23	been on there, but just how do you understand how the vessel
24	fished and how the things how the nets and doors and rigging
25	and pens and all that, any did he ever mention anything about

3	A. I mean, kind of. I had watched them work on the doors, like	
4	the anchor doors for the nets. I know they were doing welding and	
5	fixing those. I had seen that done down in Gloucester, and they	
б	had done it in Portland, too, because they just didn't like the	
7	way that Bobby didn't like the way they were set up or	
8	something like that, and he thought, by the way they changed them	
9	or whatever, it would work better for them. But	
10	Q. And who was doing the work on those?	
11	A. The guys.	
12	Q. Do you remember yeah, do you know who was somebody	
13	you said somebody was welding. Do you know who was welding?	
14	A. Bobby and the crew, all of the guys	
15	Q. Okay, so everybody would weld. Would Ethan weld as well?	
16	A. I don't think Ethan knew he would like hold the torch to	
17	melt the bolt, but he's not a welder. He can't weld. I will	
18	openly admit that. He would not do that because he does not know	
19	what he's doing. He's like, nah, I'm good; thanks, though.	
20	Q. Understood. And then any I know we briefly talked to it,	
21	but anything else about the booms? I know you said that he would	
22	sail as either the first or second mate and kind of be in the fish	
23	hold sometimes. Did he ever say anything about working in the	
24	fish hold or anything along those lines?	
25	A. I know they were fixing the net a lot, but other than that, I

3	Q. Did he ever say anything about the why were they fixing
4	the doors? Because like you mentioned
5	A. He just because the way that Bobby thought that, if
6	they had changed the way they were set up, it was maybe the net
7	wouldn't get caught as much or something. He was just trying to
8	see if it would help them. They literally only took they
9	didn't like change the complete door; they changed like the bottom
10	it looks like a you know how like Santa's sleigh has those
11	shoe things?
12	Q. Um-hum.
13	A. So, at the bottom of the door, like it looks like an anchor,
14	and then on the bottom of it, it has like one of those shoe
15	things, and they literally only took the shoes off. That's all
16	they were doing.
17	(Simultaneous speaking.)
18	Q. (Indiscernible)
19	A. And they I think they would take like a chain link maybe
20	and change the length of it, the door, but that was really all
21	they were doing.
22	Q. Okay. Do you next question is, do you know how the catch
23	was stored? So they would go out and fish, and then how would
24	they where would they put the fish once they caught it?
25	A. Down in the fish hold, on ice.

1	Q. Do you know how they would would they separate it out or
2	how would they with the fish pens and
3	A. So they had like the pens downstairs. I don't know exactly
4	how they put them in there, but I know they did have to separate
5	like each because they had they would catch different types
б	of fish, so they did have to separate like the different types.
7	Because when they were unloading, they unloaded by the type of
8	fish, and they would go pen by pen and get each type of fish
9	before they would move on to the next type, because every type is
10	like a different price per weight and stuff like that, so
11	Q. Okay, so segregate it. And anything about how they would
12	they do like ice, fish, ice, or would it just be kind of, hey,
13	we're putting all these over here and over there?
14	A. Like
15	Q. If you don't know, that's fine. I mean
16	A. Honestly, I don't really know, because when they were
17	unloading, they didn't really they weren't down in the hold

18 unloading the fish; they hired people to go down there and like 19 load the buckets with the fish. Ethan just stood at the door and 20 held the bucket when it came up to make sure that it didn't hit 21 anything.

Q. Okay. And then I -- again, another question. So kind of the -- do you know what his typical work-rest -- what his work hours were onboard, kind of what the schedule was?

25 A. (No audible response.)

3 Q. Okay. He never said like, hey -- sorry, go ahead.

4 A. I was going to say, there was no schedule whatsoever.

8 Where they were in offshore or in what they were doing? Ο. 9 Like depending on the quota-wise, like how they were doing Α. 10 catching fish. Like, if they were on fish, they would just keep 11 kind of circling the fish to catch all that they could in that 12 area. So they would literally just like pick the net up, take all 13 the fish out, reset the net, then just keep doing that over and 14 over again if they were on fish until they pretty much --15 Okay. So it was safe to say that it was some -- you know, it Ο. 16 wasn't like, hey, you're on watch for 6 hours, and then you have 17 6 hours off and --

18 A. There was no --

19 Q. Okay.

20 A. I don't think there's ever been a boat he's worked on like21 that.

22 Q. Um-hum.

A. The only boat that he actually had like a schedule was when
he was lobstering, and that's because I dropped him off at 5:30 in
the morning and I picked him up at 6 o'clock at night. That was

1	literally the only job like fishing job he's had with a
2	schedule like that.
3	Q. And then you mentioned, I guess it was Bobby would pretty
4	much determine the schedule, so the captain would say, hey, this
5	is what we're doing and
б	A. Yep.
7	Q. Okay. Next question is, did you ever discuss about any
8	unresolved maintenance issues or things that needed to get fixed
9	and weren't fixed, or like problems with certain systems or
10	A. Never.
11	Q devices on the vessel?
12	A. Never said anything to me about it.

14	A. But, I mean, Ethan also wasn't really like in like that
15	was more of like a boat owner and Bobby situation. It wasn't
16	really like

19	they could fix.
20	Q. Got you. I was just saying like, hey, if he's, you know,
21	down in the fish hold all the time and like, hey, the ice maker
22	doesn't work or this system keeps

5	It was something somebody didn't flip a switch or something
6	like that. I don't remember exactly what it was.
7	Q. Would Ethan do work in the engine room? Would he work the
8	machinery at all?

24	Q. Lazarette yeah, yeah, no worries. It's like the most aft
25	compartment on the vessel. So you know where the big fish reels

6 Q. But their shares would be based on the costs of operating the 7 vessel?

8 And Bobby, depending on -- so there's a couple times Α. Yeah. 9 Ethan, I would pick him up in Gloucester because he didn't want to 10 ride back to Portland, so Bobby would dock him like 100, 200 bucks 11 for not helping clean the boat on the way back. Stupid shit like 12 that, just because he knew that it would kind of irk him a little 13 bit just because he was like, I don't want to have to sit on a 14 boat for another 8 hours, like I want to go home.

Yeah. Did he ever talk about his -- what was his opinion of 15 Ο. 16 Bobby as a captain? Did he ever disclose his opinion of him? 17 He had a lot of respect for Bobby, because Bobby saw Ethan's Α. 18 potential and wanted to help Ethan advance. He wanted Ethan to be 19 in the captain's chair. He wanted -- because he knew Ethan could do it; he had the determination, and that kid loved being out on 20 21 the ocean.

Q. Okay. And then last question I have for you is, did he ever tell you about any alarms, like hearing alarms going off or like having to silence alarms or anything?

A. So, out of all crews, that was the best working crew they had had. Which, I mean, you want it bad enough, you'll suck it up.

A. And he was the kid on the boat, youngest one, and Bobby knewthat calling him kid really got under his skin, so he called himkid all the time. And he would talk to me, he would be like, you

Because Rink really liked Ethan, and he 22 was a hard worker, and he just wanted to make sure he was taken 23 care of. And Ethan's like, nah, I'm going to stick it out; I'll 24 stick it out. And then him and Bobby had this big heart-to-heart 25 conversation, and everything was peachy keen.

1	I mean, I drove Bobby and Ethan around for like 4 or 5 hours
2	the day before they left, just talking, shooting the shit, and
3	Bobby was just trying to tell Ethan, he's like, dude, I just want
4	you to be me, like you have the potential; I can see it. And he's
5	like, I wouldn't be pushing you as hard as I am and working as
6	hard as I am if I didn't see the potential that I did.
