NOTES:

- Before loading, Ramp personnel must verify the dry ice capacity of any feeder aircraft with the Pilot-in-Command.
- Any deviation from the requirements for feeder aircraft must be approved by the operator. Feeder aircraft are loaded with dry ice as directed by the flight crew.

I. Animal (Lives) Loading

NOTE:

Insects, non-venomous reptiles (i.e., snakes, alligators, lizards), pet store tropical fish and consumable shellfish (i.e., lobsters, scallops, etc.) are not considered live animals for air carriage purposes, in compliance with *Aircraft Ramp Operations Manual* R3-5-75 and R5-5-25.

- (1) Never load a USPS shipment of live animals in closed ULD containers.
- (2) Dry ice or Cryogenic Liquids and animals (Lives) must be loaded on aircraft as follows:
 - (a) Lives must be loaded forward of dry ice or cryogenic liquid shipments.
 - (b) Lives must be separated from dry ice shipments or cryogenic liquid shipments by at least 1 position and live animals in packages must be placed 12 inches off the floor.
 - (c) Except for dry ice packed with other dangerous goods that are required to be accessible, all dry ice shall be loaded aft.
 - (d) Never load lives and dry ice or cryogenic liquids together on the same pallet.
 - (e) Never load lives and dry ice or cryogenic liquids together in bulk compartments.
- (3) Special Rules For 777F:
 - (a) Live animals cannot be loaded in the AFT BELLY or ABK of tail numbers 850-857.
